## International Conference "Housing: An Engine for Inclusive Growth", April 10-13, 2013 at New Delhi, India

At the outset, we convey our best wishes for the New Year 2013 to you and your family members.

- 2. We are glad to inform you that the Asia Pacific Union for Housing Finance (APUHF) in association with the National Housing Bank (NHB), India is organizing the next International Conference on the theme 'Housing: An Engine for Inclusive Growth' during April 10-13, 2013 at New Delhi, India. A meeting of the Advisory Board is also scheduled on April 12, 2013 in the forenoon.
- 3. As you will kindly appreciate, the theme of the Conference is very relevant to the current context in view of challenging environment being faced by different economies across the world.
