






# **MESSAGE**


# **MESSAGE**

I am confident that under the committed leadership of its current Chairman, Mr. Mohsin Sheikhani and his team, ABAD will make land able progress to meet its obligations.



## **ABAD'S PROFILE**

ASSOCIATION OF BUILDERS AND DEVELOPERS OF PAKISTAN (ABAD) is a national level representative organization of Builders and Developers, registered under the Companies Ordinance, 1984 with Registration No. KARACHI No. 4967 of 1977-78 and licensed under Trade Organizations Ordinance, 2007-2013 and it's affiliated with the Federation of Pakistan Chamber of commerce and Industry (FPCCI). It was formed in the year 1972 with the aims and objectives of unifying and streamlining the construction activities of private sector.

The principal aims and objectives of ABAD include.

- Unifying builders and developers for their collective good.
- Promoting housing industry in the country.
- Providing assistance to the Government in formulating its housing policies and plans.
- Coordinating between ABAD members, the Government and other agencies.
- Dealing with problems faced by its members in the execution of their projects.
- Organized research.
- Awareness and training program to promote the science and art of building.
- Working actively for eradication of unethical business practices from the housing and developing field.
- Exploring the prospects of large-scale projects in the public sector and then acting as a consortium of ABAD members to secure and execute the projects.

Today, ABAD has in its fold more than 1000 leading construction companies of the country. Most of its members' offices are equipped with up-to-date systems of designing, cost control, project management and latest civil engineering techniques to minimize the cost of construction. The association operates on democratic lines with election of One Chairman, Senior Vice Chairman, Vice Chairman and Managing Committees and One Chairman from each of its two regions i.e., Southern Region and Northern Region for a full term of year. The Chairman-ABAD is elected among Full / Ordinary members and the Vice Chairman from Associate Members and One Chairman each from its two respective regions. The elected office bearers for the term 2013 -2014 are Mr. Mohsin Sheikhani, Chairman-ABAD, M. Saleem Kassim Patel, Senior Vice Chairman-ABAD, Mr. Hanif Gohar, Vice Chairman-ABAD, Mr. Haris Ali Mithani, Chairman Southern Region-ABAD and Engr. M. Akbar Shaikh, Chairman Northern Region-ABAD.

As a representative organization of the country's builders and developers, ABAD has made a valuable contribution in the formulation of National Housing Policy and Sindh Building Control Ordinance. It has also played a leading role in securing an increase in the House building Finance Corporation component of housing loans as well as the allocation to HBFC in the Federal Budget.

In Karachi ABAD has played a pivotal role in procurement of land for its members and also for the issuance of no objection to them by Karachi Development Authority. Other major achievements of ABAD include increasing the covered area of flats, fixation of the selling price of housing units, inclusion of a provision of escalation.

Simplification of the procedure for the permission to mortgage and registration of leases, increase



in the period of completion and streamlining of documentation procedures regularly. Although there is a pressing requirement for houses in Karachi yet on account of non-availability of infrastructure and other amenities, some schemes cannot be developed due to scarcity, efforts to remove these bottlenecks are continuing on all possible levels.

As a socially responsible organization in addition to the above core functions ABAD also extends donations and other kinds of support to deserving institutions and welfare organizations. A safe shelter to live in is recognized the world over as a fundamental human right and that is the vision behind ABAD's efforts and ventures.

- Create awareness and organize training programs for promoting science and art of building
- Working actively for eradication of unethical business practices from construction industry.
- Exploring prospects for undertaking large scale projects in the public sector and form a consortium of ABAD members to secure and execute the projects



#### **CHAIRMAN'S REVIEW**

It has been very nice of members of ABAD to elect me and my team for this term which is coming to its end. The trust imposed on me I had considered it my sacred duty to fulfill the expectations to resolve the issues which were a hurdle in carrying out their construction activities. I very humbly like to inform you that some very important issues were resolved with the efforts of Mr. Saleem Kassim Patel, Mr. Hanif Gohar, Mr. Haris Mithani and the entire Central and Regional Executive Committees and Conveners and Co-Conveners of the Sub-Committees. Each of them had played their roles with the requisite expertise. And most important of all members of ABAD were behind me to give their unconditional support to make possible the achievements what we have made.

Here I take the opportunity of mentioning the achievements we achieved during this term 2013-2014. It is all due to the cooperation and support provided to me

SBCA – With regard to SBCA our members were facing some acute problems which were hindering their construction activities. After hectic negotiations with SBCA were able to accomplish the following:

Staircase and passage, Condominium Act 2014, Decrease in Scrutiny Fee, Service Area, Partial Completion Plan, Decrease in Vetting Charges, Mandatory membership of ABAD, Decrease in Composition Fee. Public issues with builders were also resolved with coordination of SBCA

K-Electric – The electric connections have always been a hindrance in the successful completion of our members' projects. It is a very difficult task to negotiate with K-Electric since its privatization. In spite of this we have been able to acquire some positive decisions in our favour. It gives me pleasure to mention some achievements in this regard which are Special Counter for ABAD members, Nomination of Focal Person, Load Assessment Criteria, and Energization despite minor violations.

SSGC – The main issue with SSGC which has been carried over from the preceding years was the moratorium on Gas Connections on buildings consisting of Ground plus six stories. With ongoing positive negotiations we were able to get approval for ground + four stories which will be helpful to a large number of our members we are making our full efforts so that the ban is completely lifted

KW&SB - Our liaison with KW&SB is going in right direction. We have been in contact with the higher ups of KW&SB to resolve a number of issues confronted by our members. We have also been successful in providing connections only through ABAD NOC. The long pending issue of Bulk Billing has also been taken care of. The Representation of ABAD in the board has been discussed and KW&SB is in contact with the Sindh Government to move a summary in Sindh Assembly. In addition, formation of Joint Committee consisting of representation from both ABAD & KW&SB for resolution of issues confronted by our members has been made.

HBFC- The coordination with HBFC is at its best. A number of issues were resolved and for other we have been in contact with HBFC on Rate of Construction as the current rate of construction in use in HBFC at present is Rs. 1200 per sq.ft. Since the cost of construction has increased due to high price of building materials, we have suggested that the construction rate be enhanced to Rs. 2000/=. On Project Completion it has been observed that in cases where the projects have been completed but the gas and electric connections are not available for obvious reasons, it

is a monetary loss to the builder as the final check is held up. ABAD had suggested that final check may be released against an undertaking by the builder.

At present this fee is charged from both, the builder and the client, which is unjustified. ABAD suggests that the fee be charged from either and not from both. We have told block wise financing was in practice in HBFCL prior to 2009 whereas at present, the financing is done after the project is complete. We have suggested that block wise financing be restarted. The issue paying of installments HBFC starts the pay back of the loan/rent after the issuance of first check. We have suggested that the pay back should start after 18 months to facilitate both builder and allottee. ABAD has made suggestion that bulk loaning facility should only be given to the builders registered with ABAD.

PTCL – The ever important communication issue was addressed by having an MOU signed between ABAD and PTCL. This will provide facilities to members who require corporate services f for their clients. Moreover PTCL will resolve issues of members on priority basis.

LAW & ORDER AND ANTI-ENCROACHMENT - The precarious law and order situation, land grabbing and illegal encroachments were among a number of hardships and difficulties which were faced our members but due to determined hard work and sincerity of my colleagues we made tangible progress on anti-encroachment. Liaison with law enforcement agencies was remarkably improved. Similarly coordination with civic authorities was increased to address law & order and encroachment issues.

CANTONMENTS - Coordination to improve liaison with cantonment and military authorities including all departments was taken up to resolve issues which were hindering the construction activities of members of ABAD working in cantonment area

CEMENT - An arrangement has been made with Cement Manufacturers according to which members of ABAD will get a special discount on cement bags. The discount will be big help for our members to protect themselves from ever-increasing prices of cement.

ABAD INTERNATIONAL EXPO 2014 - The fundamental theme was to emphasize the importance builders and developers in providing affordable housing to the common citizen of Pakistan. The absence of affordable housing is increasing the housing shortage which has reached almost 8 million units. This was an international event as number of foreign companies participated in this expo along with Pakistani companies. The event proved to be a success as it helped in image building of the construction industry.

FPCCI - Besides being the member of the FPCCI Managing Committee and General Body, ABAD was successful in Nomination of Chairmen of Standing Committees – 2014 for Mr. Saleem Kassim Patel – Real Estate, Mr. Arif Siddik – Land Utilization and Infrastructure, Mr. Irfan Patel – Housing & Construction Industry.

#### ISSUES

Where we have achieved the above mentioned special considerations, there are still some issues which are being pursued vigorously which include the all important issue of Sale Tax on Services. Our members through ABAD have filed three writ petitions which have been taken up the Sindh High Court. These petitions have been filed through none other than Barrister Farogh Nadeem whose track record boasts a series of successes in identical cases.



Civil Aviation – earmarking Funnel Areas and Height Restrictions in Karachi we have met CAA officials to clearly define all aspects of areas and height restrictions as due to unavailability of this information NOC's for a number of our members are pending.

Environment - to amend rules and regulations to provide environmentally safe areas keeping in view the problems faced by ABAD members

In order to strengthen the organized construction sector, we are pursuing that all builders and developers in the country should be brought under the umbrella of ABAD through Government legislation.

## SENIOR VICE-CHAIRMAN'S REVIEW

Land grabbing, illegal encroachment, law and order situation, activities of land mafia and issues of Sales tax were some important issues which confronted us immediately after taking over the charge.

In order to plan our activities, we took stock of the situation to decide our course of action. Activities of land Mafia in the form of land grabbing and illegal encroachment required immediate action to control law and order situation. The situation demanded developing close coordination with police and other law enforcing agencies to tighten the loose ends. In this context, meetings were arranged with high ups in law enforcing agencies such as IG, AIG and DIGs in all districts of Karachi to explain to them that security of life and property of builders is of prime importance for continuation of building and construction activities. These personalities from law enforcing agencies were also invited to ABAD House for exchanging views with members of ABAD on different issues. During these meetings, the members explained the importance of construction industry to them and emphasized its role in providing job opportunities to masses.

Another hot burning issue confronting members of ABAD was and is the moratorium on gas connections for high rise buildings which has been the cause for delaying the possession of housing units to allottees. We have taken up the issue at different levels but have not been able to get it resolved as yet though we have been promised that the issue is being looked into.

I cannot and will not say much on the issue of Sales Tax on Services except that we did take up the matter up to the highest Level but unsuccessful. The Matter is now in the court of law who have issued a stay order and we are waiting for a decision in the matter.

ABAD organized an international exhibition ABAD International EXPO 2014 from 12 to 14 August 2014 in Karachi EXPO Centre which has been reported most successful and is expected to attract foreign investment up to \$500 million and also help in transfer of technical knowhow. The exhibition was inaugurated by the Chief Minister of Sindh. Companies from overseas - along with local firms participated in the exhibition. Delegates from Singapore, Turkey, Germany, Sri Lanka and UAE also visited the exhibition to explore opportunities for collaboration with construction industry in Pakistan. The exhibition was also visited by dignitaries like the Governor of Sindh, Speaker and Deputy Speaker of Sindh Assembly, provincial ministers of Sindh and other high ranking officials.

ABAD also signed an MOU with Pakistan Telecommunication Co. Ltd. (PTCL) to provide corporate services to members of ABAD and their clients. Another MOU was signed with K-Electric for introducing the concept of energy conservation and launching energy conservation campaign in Karachi.

I would also like to congratulate the South Regional Chairman for his whole hearted and untiring efforts in organizing the ABAD International EXPO 2014. He deserves all praise for his work day in and day out to make this event successful. All members of the ABAD EXPO Committee also deserve full appreciation for their support to the Regional Chairman in successfully launching and organizing the exhibition.



My thanks are also due to law and order sub-committee and anti-encroachment cell of ABAD for their hard work in developing close coordination with law enforcing agencies and controlling the disturbances in Karachi to create conducive atmosphere for business community to continue their commercial activities. Their efforts have been helpful in re-activating the building and construction industry which has generated some job opportunities for the skilled and unskilled labour in construction and allied industries.

I also thank all members of CEC, REC, Conveners and Co-Conveners of Sub-Committees and their members for their all out support in the performance of my duties as Senior Vice Chairman-ABAD.

I must also appreciate the staff of ABAD Secretariat who extended me full support in carrying out my responsibilities very efficiently.

#### **VICE CHAIRMAN'S REVIEW**

I take his opportunity to offer my thanks to the Chairman ABAD, Mohsin Sheikhani, and the Senior Vice Chairman ABAD. Saleem Kassim Patel and the Chairman (SR) ABAD Haris Ali Mithani as their cooperation and support was great help for me in performing my duties as Vice chairman ABAD.

The issue of Sales Tax on Services was the most disturbing factor which kept haunting us throughout our tenure. ABAD took up the matter at different levels but did not succeed in our efforts. Finally, the issue is now in a court of law at present where stay has been granted and we are waiting for the orders of the court in this respect.

We were successful in taking up the issue with the Cantonment Boards. In this context, coordination with Cantonment Boards and the Directorate of Military Lands & Cantonments was increased to resolve the issues which were hindering the building and construction activities of members of ABAD.

Another issue which was hampering the progress of construction industry was the menace of land grabbing, Qabza and illegal encroachments which were creating law and order situation. This situation was handled effectively through concerted efforts by increasing coordination with police and law enforcing agencies. These activities resulted in controlling the situation and near peace prevailed. In most cases, the encroachments were removed and the grabbed lands were got released and handed over to their owners.

Members of ABAD were facing a number of issues with the Sindh Building Control Authority. These issues pertained to increase in vetting charges and scrutiny fee, Exclusion of staircase and passage and service area from Compulsory open space, mandatory membership of ABAD for all applicants for builders licence. These issues were taken up with SBCA through representations and meetings and most of these issues were resolved. However, there are still some issues which will be taken up in the course of time.

K Electric and SSGC are never ending issues. With K Electric, some positive development is visible but there are still a lot of things which need to be done. Our members have to wait endlessly for new connection. The result of this situation is delay in giving possession of allotted units to their owners. The investment of builders gets blocked which is creating a difficult situation for builders and the allottees equally.

SSGC is another issue where there has not been much success though some light can be seen at the end of the tunnel. We have been making representations and discussing the issue at all levels through personal meetings but no tangible results have, been achieved. ABAD is however continuing its efforts to get the matter resolved.

As all of us are aware housing finance is a basic requirement for promotion of housing and construction industry. House Building Finance Co. Ltd. is the only organization in the Government sector which is providing finance for house building. ABAD has developed very close relations with HBFCL and has set up a ABAD/HBFCL Committee which holds regular meetings and day to day issues are resolved in these meetings. ABAD has suggested a number of amendments to the



operational procedure of HBFCL which have improved their loaning system. Some amendments suggested include Block wise financing, bulk loaning facility and revision in the rate of construction. These are under consideration by HBFCL.

ABAD International EXPO 2014, the exhibition organized by ABAD is a land mark in the history of ABAD. Business to business meetings were organized and it is expected that the exhibition will play the role of catalyst which is expected to bring in foreign investment of \$ 500 Million and help in transfer of technology.

The building and construction industry started to move its wheels which provided jobs to both skilled and unskilled workers. I feel proud to inform the members that the REC organized an investment oriented event ABAD International EXPO 2014 from 12 to 14 August 2014 at the Karachi Expo Centre. This was a unique opportunity for ABAD as the event was the sole responsibility of ABAD. The event was managed by an event organizer, Badar Expo Solutions. This was an international show as more than 100 local and international exhibitors from leading builders, real estate and building related companies participated. Also delegates from Singapore, Sri Lanka, UAE, Turkey and Germany visited the exhibition.

The exhibition has been declared a great success by all standards. The exhibition was inaugurated by the Chief Minister of Sindh and visited by dignitaries like Governor of Sindh, Speaker and Deputy Speaker of Sindh Assembly, Provincial Ministers, Secretaries of Federal and Provincial ministries and bureaucrats. The exhibition is expected to attract foreign investment of \$ 50d Million and also initiate transfer of technical knowhow.

The exhibition was also accompanied by seminars on "Smart City Advocacy in South Asia, Urbanism in Context of Smart Cities" on 12th August 2014 and "Role of construction industry in National Economy and Low Cost Housing and Rehabilitation of Katchi Abadi"on is" August 2014. These seminars were addressed by expert professionals and speakers from different organisations.

The Moratorium on new gas connections to High Rise Projects has been one of the stumbling blocks in transfer of residential units to allottees. We have represented this issue at every level and on every opportunity but without any relief. ABAD would however continue its efforts in this direction and we hope to get the issue resolved soon.

REC is aware of the issues with K-Electric. We are in regular negotiations with them through meetings and correspondence regarding delays in electric connection, bank guarantee, Connection under Self Finance. We hope that some positive result will be achieved.



#### ABAD POLICE LIAISON COMMITTEE (APLC)

This is another feather in the cap of ABAD. The term of reference of APLC is to effectively deal with all crimes such as frauds, advese law and order situation, threats of life to builders, demand of bhatta, car snatching and encroachment on lands of builders

#### **ACHIEVEMENT**

An order on the directive of I G Police has been issued. The APLC will be functional round the clock, A 24 hours functional control room will be created and a mobile will be procured to facilitate the operation.

#### **ALLIED INDUSTRIES SUB-COMMITTEE**

Terms of Reference of this Sub-Committee is to identify the role of industries allied to construction and to liaise with vendors to obtain maximum benefits and support of builders. As per the terms of reference, the Committee started working on developing close relations with allied industries and in this context planned to establish contact with manufacturers of cement and steel.

The cement industry was decided to be the first priority for Allied Industries Sub-Committee. The Committee therefore planned to start meetings with manufacturers and dealers of cement to understand the reasons behind unprecedented increase in price. Meetings were held with manufacturers, dealers, importers and suppliers of cement. At the same time, some basic research was conducted to understand the statistical calculation of the cement issue.

Representations were submitted to Federal and provincial Governments in this connection. Simultaneously, the Sub-Committee arranged a meeting with Pakistan Steel Re-Rolling Mills Association to discuss the issue of price of steel bars. The delegation of Pakistan Steel Re-Rolling Mills Association explained their pricing policy and said that their price of steel bars depends on the cost of raw material being imported from different sources. The local taxes, rate of exchange and the price of metal in the international market are some factors on which the price of steel products would depend. The meeting did not bring any relief to builders in this respect.

Rising price of cement was the other issue which needed immediate attention. The Allied Industries Sub-Committee had been working on this issue since last year but no tangible result had been achieved. ABAD therefore decided to take up the issue from a different angle. The Chairman and some active members of ABAD decided to take up the issue of rising cement prices at the Association level a meeting was therefore arranged with the All Pakistan Cement Manufacturers Association (APCMA) and negotiations were held with the office bearers of the APCMA. After prolonged negotiations with the office bearers of the Association, a working arrangement was negotiated which provided some discount to members of ABAD on the prices of cement. For this purpose a proper system was worked out to ensure that only members of ABAD avail this facility. Until today, many members have taken advantage of this facility.

Members of Allied Industries Sub-Committee were very actively involved in organizing the ABAD International EXPO 2014 which was held in Karachi EXPO Centre from 12 to 14 August 2014. This was an international exhibition which was participated by almost 100 companies from overseas



and Pakistan as well The event was declared a great success. It attracted a number of visitors from within and outside Pakistan. It provided a unique opportunity to builders and manufacturers of products in allied industries to display their products to end uses and the construction industry and thus get full advantage of the opportunity. It is estimated that the exhibition will attract investment from overseas in excess of \$500 Million and also help in transfer of technology to Pakistan. Organising an event like the ABAD International EXPO 2014 will be remembered by members of ABAD for long times to come.

#### ANTI-ENCROACHMENT CELL

Due to increase in the incidents of land grabbing, encroachment and Qabza, the anti-encroachment Cell had to become active from day one. Members of the Cell had an in house meeting in which it was agreed that the Cell should increase coordination with the Police and other law enforcing agencies to control and eliminate the nefarious activities of criminals.

As a follow up to the decision of the meeting of Anti-Encroachment Cell, it was agreed that meetings with high officials of police and other law enforcing agencies be organized by inviting them to ABAD House or visiting them in their offices for meeting with members of ABAD and for exchanging views on different proposals for controlling the situation.

The first meeting in this series was organized on 5th December 2013 in ABAD House with Col. Javed Hussain Baloch, the Sector Commander of Bhittai Rangers. Members were invited to discuss the issue and give their suggestions for controlling the situation.

Free discussion was held in the meeting. Members of ABAD exchanged views and suggestions for maintenance of law and order in Karachi. All complaints of law and order were placed in the meeting. The Sector Commander listened to complaints and assured the members that their grievances will be looked into and that his staff will ensure complete peace and normalcy.

A meeting was arranged with DIG East, Mr. Munir Ahmed Shaikh in his office on 11th December 2013. This meeting was arranged as majority of law and order issues were taking place in this area. Members of anti-encroachment and law and order sub committees attended this meeting and explained the woes of members of ABAD. The DIG listened patiently to grievances and assured the members that their interest will be taken care off. ABAD Delegation explained the importance of construction industry to the DIG and briefed him about its role in providing employment to skilled and unskilled personnel. He appreciated the role of construction industry in revitalizing the economy.

The Commissioner Karachi Mr. Shoaib Ahmed Siddiqui was invited to ABAD House for a meeting with members of ABAD. He was apprised of different issues faced by members including the law and order situation, land grabbing, encroachment on lands of members etc. He gave patient hearing to all issues and responded to each point raised by members.

A follow up meeting was arranged with Mr. Munir Ahmed Shaikh, DIG East on 10th January 2014 in his office to continue discussion on the law and order situation in District East. Members of antiencroachment Cell attended the meeting and free and useful discussion with the DIG East and his staff.

A meeting was arranged with DIG West on 24th February 2014 in his office to discuss complaints of members working in that area. Members of anti-encroachment Cell placed the complaints before the DIG who listened to all complaints and assured the members that these complaints will be taken up promptly. He and his staff will cooperate with ABAD to control the situation.

As a follow up to the meeting with DIG West, a meeting was held with SSP West, Mr Irfan Ali Baloch on 21st March 2014 in his office to further the complaints of members in that area and to stress the importance of construction industry for providing jobs and for revival of the economy in the depressed economic conditions.

Mr. Kamal Hakeem, Assistant Commissioner Gulshan-e-labal was invited for a meeting with members of ABAD on 22nd March 2014 to discuss the law and order issues of the area. The complaints of members were brought to his attention requesting his cooperation to eliminate the criminals. He assured the members that he and his staff would extend all help to bring peace to the area. He suggested that any incident of law and order be properly and immediately reported for action. He assured of immediate response on any matter.

Dr Fahad, the newly arrived ASP Gulshan-e-Igbal visited ABAD on 15th April 2014 to introduce himself and exchange views regarding law and order situation in the area. We exchanged notes on the General situation pertaining to the subject.

Follow up meetings were held with the Commissioner Karachi, Mr. Shoaib Ahmad Siddiqui and the Assistant Commissioner-Gulshan-e-Igbal Mr. Kamal Hakeem on 14th April 2014 and on 15th April 2014 respectively which were a continuation of the previous meetings. Subjects discussed in the meeting concerned law and order situation, incidents of land grabbing and encroachment in the area.

The newly arrived Assistant Commissioner Gulshan-e-Igbal visited ABAD on 20th May 2014 to introduce himself and to get a feel of the situation pertaining to the area. Members of Law & Order Sub-Committee and Anti-encroachment Cell of ABAD attended the meeting and briefed the visitor about the law and order situation in the area. He was also advised of the security situation in the area, the incidents of land grabbing and encroachment and activities of anti social elements in the area. He assured the members that he will be vigilant about such incidents and would ensure that these are eliminated.

A meeting was arranged with Lt. Col. Muitaba, Wing Commander, Sachal Rangers to coordinate them in our efforts to control the law and order situation. We apprised him of the issues and the complaints of members pertaining to land grabbing, encroachment, harassment and other criminal activities and requested him to cooperate in our task of bringing peace and prosperity in the area. He appreciated our concern when he was advised that construction industry is the second largest employer after agriculture and therefore requires special consideration. He suggested that any complaints pertaining to law and order may be referred in the first opportunity. It was agreed that all complaints may be referred to them as well along with other law enforcing agencies.

DIG East Mr. Munir Ahmed Shaikh was invited to ABAD House on 24th June 2014 for a usual round up meeting to continue follow up on complaints of law and order, land grabbing and encroachment. The meeting was attended by members of anti-encroachment cell in which the complaints received since the last meetings were placed and progress on other complaints was reviewed. It was agreed that regular contact between the two organizations will be maintained for a proper follow up on various issues.



Mr. Iabal Mehmood, the Inspector General of police was invited for a luncheon meeting in ABAD House on 26th June 2014. The meeting was well attended by members who apprised the IG about their issues of law and order, encroachment and land grabbing. All complaints received from members were placed before the IG who assured action on these. In his speech, he advised the members to lodge FIRs of every incident for proper investigation and action.

# CITY BUILDERS & DOWNTOWN AFFAIRS SUB-COMMITTEE

The term of reference of this sub-committee is to resolve all issues of city builders and downtown affairs. During the period under review the City Builders Downtown Affairs Sub-Committee held 8 in-house meetings. These meetings were held to discuss different issues faced by members of ABAD in the downtown area.

In the different meetings of sub-committee the members were specially asked to be punctual and regular so that the sub-committee can work efficiently as working for the sub-committee should be the first priority of the members.

The most prominent achievement during this term was the exclusion of passage from the saleable area. The support and efforts of Chairman ABAD Mr. Mohsin Sheikhani were remarkable in order to achieve this breakthrough. Services of Mr. Anwar Dawood OK are worth mentioning who along with Chairman ABAD Mr. Mohsin Sheikhani put in his best efforts. This achievement will provide benefit of billions of rupees to our members.

In the meetings it was also discussed that bye-laws regarding to NOC for sale and advertisement of the project should be amended, as they sometime create problems to the builders' community. It was also mutually agreed that gas connections, electricity meters and water and sewerage are the major issues faced by the builders at present and mostly for those builders who are working in downtown areas.

The convener Mr. Asif Sumsum also informed the meeting that the House is already in contact with all the concerned departments and also tries to contact with the high-ups like provincial governor and chief minister. He also assured the members that all the matters will soon be resolved as we also try to contact with General Managers and Managing Directors of the concerned utility departments.

In the meetings, issues related to the cooperative societies' were also discussed and some members also shared their experiences in that regards. The convener also asked the members to inform ABAD about their problems and issues related to the downtown, so that they can be resolved on priority basis.

#### COOPERATIVE SOCIETIES

It took very painstaking efforts to convince the Ministry of Housing that fees charged by Unions and Societies should be cut off. Their only role should be that of title verification. The matter of commercialization is not the business of societies and unions. Mr. Younus Dhaga played a very important and marvelous role. It is expected that notification to this effect will soon be issued. This new rule which has cut down the role to verification of titles only is going to save crores of rupees for our members.

A very good liaison has been established with almost all local tax departments. If any member is confronted with any sort of problems with regards to local taxation, we can resolve these problems in a timely manner.

In the meetings the issue of environmental protection was also discussed, since the builders have been receiving different notices in that regards. But it was mutually resolved that the problems



related to environmental protection will not be taken up from the platform of ABAD and the House just provide guidance to the affected members in resolving their issues.

## **DEFUNCT KDA SUB-COMMITTEE**

This Sub-Committee held meetings with Deputy Commissioner, East and Municipal Commissioner, Karachi Metropolitan Corporation to discuss different issues. Meetings were also held with the Administrator, Karachi to discuss issues faced by members of ABAD. These issues pertained to sale of plots by now defunct KDA through public auction or allotment. These plots were purchased by members of ABAD who had paid full price of these plots but possession of the same had not been given. At the same time, charging ground rent on these plots had also been started. It was pointed out in these meetings that ground rent should not be charged on these plots as their physical possession had not been given. Also, the NUF should not be charged till such time that water is made available in the area. This Committee also took up the issue of possession of plots purchased by members of ABAD in auction, possession of which had not been given and these had been encroached. As the title of these lands is not clear, possession of these cannot be given till such time that the ownership of land is verified.

## **ENVIRONMENTAL PROTECTION SUB-COMMITTEE**

This Sub-Committee did not make any significant contribution during the year as no meetings were held. However, the Environmental Protection Agency (EPA) Government of Sindh remained busy in issuing notices under the Pakistan Environmental Act 1997.

Builders of KIRAN RESIDENCY in Karachi received a notice from EPA for personal hearing in a case of construction of a building in Karachi. They were advised that construction activities are going on without obtaining approval from EPA. A copy of the letter was received by ABAD. A letter was received from Environmental Management Consultants advising about their assignment of a study for Environmental Impact Assessment for Grade Separated Traffic Improvement Plan for their client, Karachi Metropolitan Corporation.

ABAD also wrote to legal adviser of ABAD seeking his legal opinion about applicability of the EPA to builders. A reply is still awaited. A soft reminder has been sent.

#### HBFCL, HOUSING FINANCE FROM DFIS & COMMERCIAL BANKS SUB-COMMITTEE

This Sub-Committee has been assigned the task of dealing with the resolution of issues concerning housing finance from House Building Finance Co. Ltd.(HBFCL), This Sub-Committee keeps in regular contact with the Senior Executives of HBFCL to thrash out any issues that may come up in the processing of housing finance of any member. In this context, the Sub-Committee had a number of meetings with Senior Executives of HBFCL to discuss the specific issues.

The Sub-Committee and the HBFCL had meetings on the following dates to resolve issues of members of ABAD:

- 28-10-2013 Meeting in HBFCL Office
- 16-12-2013 Meeting in ABAD House
- 22-01-2014 Meeting in ABAD House
- 21-03-2014 Meeting in HBFCL Office
- 27-06-2014 Meeting in HBFCL Office

## The main tasks in front of this Sub-Committee were:

#### Rate of Construction

The current rate of construction in use in HBFC at present is Rs. 1200 per sq.ft. Since the cost of construction has increased due to high price of building materials, ABAD suggests that the construction rate be enhanced to Rs. 2000/=.

## Overseas Employees

The application from overseas employees is only entertained on hard copy. If for any reason there are objections it takes very long time to remove those objections. It is suggested that the correspondence between overseas employees and HBFC may also be entertained through email also.

#### Project Completion

It has been observed that in cases where the projects have been completed but the gas and electric connections are not available for obvious reasons, it is a monetary loss to the builder as the final check is held up. ABAD suggests that final check may be released against an undertaking by the builder.

#### Project Processing Fee

At present this fee is charged from both, the builder and the client, which is unjustified. ABAD suggests that the fee be charged from either and not from both.

## Policy File

Once the time has been cleared by legal then the power of approval of policy file should be



devalued by Zonal Chief in order to avoid lengthy procedure and abnormal delays.

#### Block wise financing

Block wise financing was in practice in HBFCL prior to 2009 whereas at present, the financing is done after the project is complete. ABAD suggests that block wise financing be restarted.

#### Moratorium period

HBFC starts the pay back of the loan/rent after the issuance of first check. This should start after 18 months as some members have been allowed this facility.

#### **Bulk Loaning**

Bulk loaning facility should only be given to the builders registered with ABAD. To discuss these and other allied matters, a Standing Committee with members from ABAD and HBFCL was formed which held regular meetings.

The HBFC Sub-Committee of ABAD had been successful in getting the application and approval process simplified for House building loans from HBFCL.

This success has been achieved through regular contact at senior level. Fair understanding at senior level in HBFCL has been developed which has proved helpful in the resolution of issues of members of ABAD.

The pending issue which is being deliberated upon is the Bulk Financing. A number of suggestions were made. Some have considered.

## **HYDERABAD AFFAIRS SUB-COMMITTEE**

It was said in a meeting that Sindh Building Control Authority, Hyderabad Region has forwarded a copy of proposed Interim policy for approval of building plan for Hyderabad Region. The Interim Policy amended the KB&TPR 2002 for the jurisdiction of Hyderabad Division till such time that building byelaws are formulated for the whole of Hyderabad Region. The Interim Policy lays down rules for Residential Category, Commercial Category and Flat Size Category.

Letters were addressed to Hyderabad Cantonment Board for representation of ABAD in their Building Committee.

Issues of members of ABAD from Hyderabad Region were taken up with Hyderabad Electric Supply Co and other concerned Departments.

It has been decided in principle that a Sub-Regional Office will be set up in Hyderabad. Chairman ABAD had a meeting with members of ABAD from Hyderabad for exchange of views with them. The opportunity was also utilized to project ABAD International Expo 2014 to members from Hyderabad.

Chairman ABAD also called on the officials of Hyderabad Electric Supply Co. and discussed matters of mutual interest.

## K- ELECTRIC & SSGC

#### K-ELECTRIC

ABAD kept in regular contact with K-Electric and SSGC for resolution of issues of members of ABAD. The Committee held a regular internal meeting on 5th December 2013 to discuss and decide the course of action to be followed with these two organizations so the issues of members may be resolved.

Soon after this, JANG organized a forum on "Gas Policy of Government" in ABAD House which highlighted the issues faced by builders in view of the policy of Government in this matter.

A delegation of ABAD had a meeting with Mr. Kashif Igbal Ghazi, Manager New Connections on 27thNovember 2013 to discuss different issues of members of ABAD regarding delays and other complaints regarding new connections for members of ABAD.

After continuous efforts to arrange a meeting with K-Electric, an appointment was given for a meeting with Syed Muhammad Taha, Chief Distribution Officer on 28th January 2014 to discuss the issues of delay in new connections and other allied problems.

In order to express our worries on not getting gas connections, a meeting was arranged to see Mr. Shakir Aleem, Acting General Manager-Sales SSGC on 28th January 2014 to explain the negative impact on construction industry of denial of this facility. He did appreciate the thinking of ABAD but said that in view of moratoriumby the Federal Government, he was unable to do much but did undertake to pursue the matter with the Ministry.

ABAD delegation called on Mir Masood Rashid G M and Focal Person for issues of members of ABAD to discuss complaints about delays in new connections, issue of Bank guarantee, the issue of requirement of NOC, Tariff Rates for TL Connection etc.

ABAD has all along been inviting different officers of K-Electric to visit ABAD House for a meeting but they avoided this invitation. However, ABAD continued pursung all matters at suitable levels for their resolution.

Another meeting was held with Mir Masood Rashid, GM Bulk Business Development of K-Electric on 28th March 2014 to follow up the earlier meeting and to press for early resolution of the issues of members of ABAD.

Latest meeting was held with Syed Muhammad Taha, Chief Distribution Officer, on 19th September 2014 to continue discussions on the issues already discussed but still unresolved.

A delegation of ABAD lead by Chairman ABAD called on Mr Amir Zafar and Mr. Kashif Iqbal Ghazi to discuss different issues of members of ABAD.

#### SSGC

As mentioned earlier in the report, not much progress was made in the matter of gas connections for new projects due to moratorium. ABAD has taken up this matter at the highest level through correspondence, meetings with all concerned with this issue but no tangible progress has been made. However, ABAD is continuing its efforts to get this restriction lifted with the hope that positive result will be achieved soon.

#### **KARACHI WATER & SEWERAGE BOARD**

Karachi Water & Sewerage Board Sub-Committee was assigned the task of developing close relations with those at the helm of affairs in KW&SB who matter and who could be helpful in expediting the resolution of issues of members of ABAD. The Sub-Committee held meetings as per the following schedule:

Additionally, a delegation of ABAD held a meeting with the Karachi Water & Sewerage Board in their office on 9th December 2013 to discuss complaints of members of ABAD most of which were related to excess billing and bulk billing charges. These issues were also followed up through correspondence.

The Managing Director of Karachi Water & Sewerage Board Mr. Qutubuddin Shaikh was invited to ABAD House on 2nd April 2014 for a luncheon meeting with members of ABAD. The MD Of KW&SB was welcomed to ABAD House by the Senior Vice Chairman ABAD, Mr. Saleem Kassim Patel who placed grievances of members of ABAD before the MD in his address. The MD gave patient hearing to the address and responded favourably to the demands of members who sought relief from him.

The Senior Vice Chairman also requested the MD to give representation to ABAD on the Board of KW&SB which he accepted in principle but said that this will need approval by the Government of Sindh for which he promised to take up the matter. This matter is being pursued with the KW&SB and we are hopeful of a positive response.

The Senior Vice Chairman ABAD also referred to delays in getting new connections and also pointed out that the old system of NOC from ABAD for new connections which was being followed as per the requirement of MOU signed in 2005 between ABAD, KW&SB with the efforts of NAZIM of Karachi that all applications for new water connections were to be forwarded through ABAD, was no longer being followed. He said that this is no longer being followed which has resulted in uncontrolled new connections resulting in water shortage in Karachi.



A meeting of the ABAD with KWSB was held on 14th April 2014 in KW&SB Office to discuss the agenda point by point which was put up to the Managing Director when he visited ABAD on 2nd April 2014. This meeting was a follow up meeting attended by the Convener of KW&SB Subcommittee of ABAD, Mr. Rais Ahmed and Mr. Muhammad Hassan Bakshi, Co-Convener of KW&SB Sub-Committee of ABAD. Mr. Muhammad Aslam, Deputy Managing Director (RRG), Mr. Fahim Ahmed Siddiqui, Director Bulk and Mr. M Azam Khan Diector Bulk and some others attended the meeting.

Another meeting was held on 21st August 2014 in ABAD House to discuss implementation of decisions of last meeting. This meeting was attended by the Convener of KW&SB Sub-Committee of ABAD MR. Rais Ahmed, Mr. Muhammad Hassan Bakshi- the Co-Convener of KW&SB Sub-Committee of ABAD and members of the Sub-Committee from ABAD side and Mr. M Aslam Khan, Deputy Managing Director (RRG), Mr. Raza H Naqvi Director-Bulk and Mr. Fahim A Sddiqui, Deputy Director Bulk from KW&SB. The meeting was held in a cordial atmosphere and all concerned issues were discussed. A copyof the minutes of this meeting is attached wit tis report for information of members of ABAD.

Members were receiving notices from Sindh Revenue Board regarding registration in SRB; however ABAD advised them not to get register and provided them draft reply which they should send to SRB.

ABAD arrange a meeting Advocate Noman Jamali to seek his legal opinion in the matter he suggested a petition in the court of law and the legal committee seconded hi suggestion. ABAD filed a petition through Advocate Farogh Naseem and Advocate Noman Jamali in Sindh High Court against Sindh Revenue Board. The Sindh High Court issued a stay order in response to this petition and directed the Sind Revenue Board not to issue a final order in any case of sales tax on the services until the gives a final decision in the matter.

Legal Affairs Sub-Committee convince the members to become intervener in our petition which they agreed and two more petition were filed in the high court which gave more weight to petition filed by ABAD.

ABAD had meeting with Honorable Chief Minister Sindh, Syed Qaim Ali Shah on the issue he assured us that necessary amendment to exclude Property Developers & Promoters as service providers will be made.

We are still on the stay order and the next hearing has been fixed for 12th October 2014.

#### **NEW MEMBERSHIP & RENEWAL SUB-COMMITTEE**

The New Membership & Renewal Sub-Committee of ABAD held several meetings from October 2013 to September 2014.

A meeting with Mr. Sohail Mumtaz, Director Design Section, SBCA was held on 8, January, 2014, it was decided in this meeting that no builders license will be renewed without valid membership certificate of ABAD. Furthermore SBCA will verify from ABAD the proposed name of builders before issuance of new builder's license in order to avoid duplication of name.

A total of 121 Membership cases were received during the current tenure and 110 have been approved by this Central Executive Committee in which 107 were ordinary members and 3 associate members. Balance 11 membership cases are in process and will be placed in the next meeting of Central Executive Committee for approval.

Breakup of the new membership is 92 belong to Karachi, 17 belong to Hyderabad and 1 belong to Rawalpindi.

New Membership & Renewal Sub-Committee of ABAD will start new membership and renewal of old companies who have not renewed their membership of ABAD due to some reason. It is suggested that the new membership sub-committee continue drive for membership of ABAD through personal contact and telephone calls to persuade them to re-join ABAD as it will be ultimately in their own interest since they will get all services available from ABAD to its members.

The present New Membership & Renewal Sub-Committee of ABAD has persuaded the renewal of old membership cases vigorously which has resulted in renewal of 20 cases. The New Membership & Renewal Sub-Committee of ABAD had numbers of meeting to resolve the issue of Builders of Hyderabad who had name similar to other members of ABAD. Different suggestion were given to resolve the issue and finally the committee agreed to give membership these builders of Hyderabad with similar name with the following conditions The Joint meeting of Central Executive Committee and Regional Executive Committee of ABAD held on September 13, 2014 already approved this suggestion:

- Builders will have to submit an affidavit that they will not launch / start a new project from this company.
- ABAD Membership Certificate will be valid for the specific running project and this will be mentioned in the certificate.
- 3. This membership will be valid till completion of the project.
- After completion of the project, member will have to change the name of the company in ABAD record without payment of any further fees/charges.
- ABAD will inform SBCA, that this membership is valid for the specific running project only and no NOC will be issued for any other project on to this company.
- 6. This membership is issued due to this reason that after KBCA was converted into SBCA and all laws of SBCA are now applicable for whole of Sindh including Hyderabad, since some of Hyderabad Builders had already announced their project moral less the similar name with Karachi Builders, so we have no option to give membership. ABAD has therefore approved similar name for those specific running projects to safeguard the financial interest of public who have booked in this project on the basis of NOC issued by SBCA.

To summarize the performance of the New Membership & Renewal Sub-Committee of ABAD, we would like to submit the following figures for the information of Central Executive Committee:

- Membership fee received from new members Rs. 90 Lacs (from 121 members)
- Membership Renewal fee received from members for 2014 Rs. 70 Lacs (from renewal 500 members)
- Membership renewal fee from old out of date members Rs. 16 Lacs (from 20 members)

It will be observed from the above details that the New Membership & Renewal Sub-Committee of ABAD has earned Rupees 176 Lacs for ABAD which must be appreciated by all members present in the meeting.

Cases of Completion/Regularization where proposed/revised plan was approved prior to 13-2-2014 excluding cases submitted during Amnesty Scheme - 2004 the rate of composition fee applicable vide Notification No. City Nazim/Secy/2431/2007 Dated 15-12-2007.

Cases Submitted during Amnesty Scheme 2004 the rate of composition fee applicable vide Notification No. Nazim/City/Secy/6249/2004 Dated 14-09-2004.



### **ABAD INTERNATIONAL EXPO 2014**

**ABAD International Expo 2014** was held from 12th to 14th August, 2014 at Karachi Expo Centre. The event promises to be most dynamic exhibiting a rendezvous of builders and developers, remodelers, building materials, sales and marketing professionals, architects and other building industry professionals. The ABAD Expo is an initiative of the Association of Builders and Developers of Pakistan (ABAD) and jointly managed in conjunction with Pakistan's leading event management company, Badar Expo Solutions (BXSS).

The three days long International Expo was unexpected for both the organizers and the participants under the prevailing circumstances and scenario of the whole country. A large number of citizens turned out and visited the exhibition which surprised everyone. The stall holders, particularly the builders and developers; were expecting that like previous experience the public turnout shall be poor and there will not be any booking whatsoever as per its legacy but there negative expectations proved wrong and it became equally fruitful for almost all the stall holders. More or less everyone booked flats, plots, bungalows, shops and units and as well booking and purchase of construction material received heavy responses etc. that gave them confidence and they could achieve maximum results out of it.

The event hosted two-day seminar to educate the delegates, guests and visitors regarding the need and importance of housing and construction in the country. Themes of the seminar were Role of Construction Industry in National Economy, Smart Cities Advocacy in South Asia, Low Cost Housing and Rehabilitation of Katchi Abadies.
