


ABAD also deserves appreciation for inducing its members to adopt latest technology in their construction activities.





ABAD'S PROFILE

ASSOCIATION OF BUILDERS AND DEVELOPERS OF PAKISTAN (ABAD) is a national level representative organization of Builders and Developers, registered under the Companies Ordinance, 1984 with Registration No. KARACHI No. 4967 of 1977-78 and licensed under Trade Organizations Ordinance, 2007 and is affiliated with the Federation of Pakistan Chamber of commerce and Industry (FPCCI). It was formed in the year 1972 with the aims and objectives of unifying and streamlining the construction activities of private sector.

The principal aims and objectives of ABAD include.

- Unifying builders and developers for their collective good.
- Promoting housing industry in the country.
- Providing assistance to the Government in formulating its housing policies and plans.
- Coordinating between ABAD members, the Government and other agencies.
- Dealing with problems faced by its members in the execution of their projects.
- Organized research.
- Awareness and training program to promote the science and art of building.
- Working actively for eradication of unethical business practices from the housing and developing field.
- Exploring the prospects of large-scale projects in the public sector and then acting as a consortium of ABAD members to secure and execute the projects.

Today, ABAD has in its fold around 1000 leading construction companies of the country. Most of its members' offices are equipped with up-to-date systems of designing, cost control, project management and latest civil engineering techniques to minimize the cost of construction. The association operates on democratic lines with election of One Chairman, Senior Vice-Chairman, Vice-Chairman and Managing Committees and One Chairman from each of its two regions i.e., Southern Region and Northern Region for a full term of year. Beside this for the first time a sub-region was also operative in Hyderabad with its Vice-Chairman.

The Chairman-ABAD is elected among Full/Ordinary members and the Vice Chairman from Associate Members and One Chairman each from its two respective. The elected office bearers for the term 2015-16 are Mr. M. Hanif Gohar, Chairman-ABAD, Mr. M. Arif Yousuf Jeewa, Senior Vice-Chairman - ABAD, Mr. M. Rizwan Adhia, Vice-Chairman, Mr. Asif Sumsum, Chairman Southern Region-ABAD, Mr. Sheeraz J. Monno, Chairman Northern Region-ABAD and Mr. Ghulam Hussain Memon as Vice-Chairman Sub-Region Hyderabad.

As a representative organization of the country's builders and developers, ABAD has made a valuable contribution in the formulation of National Housing Policy and Sindh Building Control Ordinance. It has also played a leading role in securing and increase in the House Building Finance Corporation component of housing loans as well as the allocation to HBFC in the Federal Budget.

In Karachi ABAD has played a pivotal role in procurement of land for its members and also for the issuance of no

objection to them by the concerned government departments. Other major achievements of ABAD include increasing the covered area of flats, fixation of the selling price of housing units, inclusion of a provision of escalation, simplification of the procedure for the permission to mortgage and registration of leases, increase in the period of completion and streamlining of documentation procedures regularly. Although there is a pressing requirement for houses in Karachi yet on account of non-availability of infrastructure and other amenities, some schemes cannot be developed due to scarcity, efforts to remove these bottlenecks are continuing on all possible levels.

As a socially responsible organization in addition to the above core functions ABAD also extends donations and other kinds of support to deserving institutions and welfare organizations. A safe shelter to live in is recognized the world over as a fundamental human right and that is the vision behind ABAD's efforts and ventures.

CHAIRMAN'S REVIEW

The start of the tenure 2015-2016 witnessed challenging state of construction industry which needed a dedicated drive for starting the revival process. Issues like moratorium on new gas connections and water connections accompanied with events of land grabbing and encroachment were on the rise and the law and order situation had touched alarming position. Builders were worried about safety and security of life and property of their own and their staff. ABAD recognized the seriousness of the situation and planning started to remove the bottlenecks and restore the confidence of builders so they could devote their energy to the process of recovery. The support of my team members, Mr. Arif Yousuf Jeeva, as Senior Vice Chairman, Mr. Rizwan Adhia as Vice Chairman, M. Asif Sumsum as Chairman (Southern Region), Mr. Ghulam Hussain Memon Vice Chairman Sub-Region – Hyderabad and Sheraz J. Monnoo as Chairman (Northern Region) along with members of CEC and REC gave me the moral support and courage to fight against all anti social activities.

In this tenure repair/renovation of ABAD house was made which was not instigated for the last 24 years - a beautiful mosque is constructed in the premises of ABAD House for prayer, refurbishing of ABAD house including interior decorations and extension of administration block with some other construction works. During this ABAD is also certified with ISO-9001:2008 which is also considered a great achievement.

We also conducted several meetings with Minister of Petroleum & Natural Resources in his chambers for lifting of ban on new Gas Connections especially for the completed projects of the Members of ABAD that could not be handed over to the clients due to ban on Gas connection since 2011. And now by the Grace of Almighty Allah we are successful in our efforts and new connections have been given to the members projects.

An MOU was also signed between ABAD and STEVTA for training of unskilled youth of the province of Sindh, since it is also a corporate social responsibility to do something for the betterment of common people.

After several meetings between the Managing Director of KW&SB and the delegation of ABAD, the MD KW&SB lifted the ban on new water connections also. This is also a major accomplishment made in this tenure.

We started liaising with law enforcing agencies including police and rangers to make our way through them to control the law and order situation. In this context, we arranged meetings with the highest authorities in these departments by inviting them for meetings to discuss the issues and suggest measures to control the situation. Delegation of ABAD also called on some officials of law enforcing agencies in their offices and discussed the land grabbing, encroachment and other related issues with them.



Imposition of Sales Tax on services by Government of Sindh was another hot burning issue which was a spill-over from previous years and needed immediate attention so the matter may be taken up with relevant authorities for its abolition. We started off by addressing letters to Sindh Board of Revenue, Sindh Minister for Finance supported by various documents to prove that the tax was illegal and unjustified. We also wrote letters to President of Pakistan, Prime Minister of Pakistan, Governor and Chief Minister of Sindh, Board of Investment of Sindh etc.

We developed cordial relations with the House Building Finance Co. Ltd. A Committee comprising of representatives of ABAD and HBFCL has also been set up to deal with day to day issues of members of ABAD and to suggest improvements in HBFCL policies.

Though a KESC/ABAD Committee was formed to thrash out day to day issues of members, it was just not possible to get an appointment with the CEO of KESC. Therefore, contact with KESC was only at a lower level.

ABAD organized a seminar on 'Transparency in Construction Industry' on which was addressed by some eminent speakers having the chief guest Director General National Accountability Bureau (NAB) Lft. Col. Siraj ul Naeem. The Seminar was well attended by members. The Chief Guest explained the subject in a fruitful manner. Then the addresses were followed by question-answer session.

ABAD also organized a three-day international event ABAD INTERNATIONAL EXPO-2016 which again proved to be a historic event in the history of construction industry. For which I specially thanked to the Convener Mr. Haris Ali Mithani and his team of EXPO who worked day and night for making the event another success story.

Before I conclude I would like to add that I highly appreciate the cooperation and coordination of my team mates, Mr. Arif Yousuf Jeeva, as Senior Vice Chairman, Mr. Rizwan Adhia as Vice Chairman, M. Asif Sumsum as Chairman (Southern Region), Mr. Ghulam Hussain Memon Vice Chairman Sub-Region – Hyderabad and Sheraz J. Monnoo as Chairman (Northern Region), members Of CEC and REC and all Conveners and Co-Conveners of Sub-Committees of ABAD and I am thankful to them. In the end, I would like to express my deep appreciation for the efficiency of ABAD Secretariat who provided me full support to perform my responsibilities for the betterment of ABAD House.

SENIOR VICE CHAIRMAN'S REVIEW

The term 2015-2016 started in a very complicated and depressed situation for the construction industry. The confidence of the industry was shaken due to various measures taken by the Government which were not favorable to the construction industry. The Issues with the Federal Board of Revenue and other Taxation problems by the Government were on top of the list. However, we did not lose heart and with the cooperation and coordination of the Chairman ABAD, Vice Chairman and Chairman (SR) we planned to fight our way through.

I am thankful to all members of ABAD in general and to my colleagues in CEC, REC and different Sub-Committees of ABAD in particular for their encouragement and unhindered support which gave me a moral support to deal with different issues. We kept all issues facing our members right in front of us so we do not lose their sight and get these resolved soonest. I do admit that we were not

successful in getting relief for our members from the issues with FBR though we kept pressure on the government through correspondence to the highest authority in government hierarchy, the President of Pakistan and the Prime Minister of Pakistan and by arranging meetings with all relevant officials in concerned departments.

We had fruitful meetings with Sindh Building Control Authority regarding issues faced by members of ABAD and the clauses unfavourable to builders were suitably amended to curtail the adverse effect on the industry. Similarly, meetings were held with Military Lands & Cantonments Department to discuss various issues confronting the construction industry. A lot of efforts were put in sort out matters concerning KW&SB and progress was also made in matters concerning new connections for projects of builders and the issuance of excessive bills.

We made concerted efforts to discuss the issues of construction industry with officials of HBFCL and as a result of these efforts the process of obtaining loans was simplified. The process of verifying income was also simplified. Progress was made in the matter of bulk loan for projects. A joint ABAD/HBFCL Committee was formed to take care of routine issues and resolve them.

The law and order situation was much better during the period under review and we had to arrange meetings with officials in law enforcement agencies to fully control the situation and curb the incidence of anti social activities.

I must again thank the Chairman, Vice-Chairman, Regional Chairmen, Conveners and Co-Conveners of all the Sub-Committees for their cooperation and full support to provide best services to members of ABAD.

VICE CHAIRMAN'S REVIEW

I take his opportunity to offer my thanks to the Chairman ABAD, Muhammad Hanif Gohar, Senior Vice Chairman ABAD M. Arif Yousuf Jeewa and the Chairman (SR) ABAD Mr. Asif Sumsum as their cooperation and support was great help for me in performing my duties as Vice chairman ABAD.

In order to plan our activities, we took stock of the situation to decide our course of action. Activities of land Mafia in the form of land grabbing and illegal encroachment required immediate action to control law and order situation. The situation demanded developing close coordination with police and other law enforcing agencies to tighten the loose ends. In this context, meetings were arranged with high ups in law enforcing agencies such as IG, AIG and DIGs in all districts of Karachi to explain to them that security of life and property of builders is of prime importance for continuation of building and construction activities. These personalities from law enforcing

agencies were also invited to ABAD House for exchanging views with members of ABAD on different issues. During these meetings, the members explained the importance of construction industry to them and emphasized its role in providing job opportunities to masses.

During our tenure we were successful in taking up the issue with the Cantonment Boards. In this context, coordination with Cantonment Boards and the Directorate of Military Lands & Cantonments was increased to resolve the issues which were hindering the building and construction activities of members of ABAD.

We all know that the issues with K-Electric are never ending. Though, some positive development is visible but there are still a lot of things which need to be done. Our members have to wait endlessly for new connection. The result of this situation is delay in giving possession of allotted units to their owners. The investment of builders gets blocked which is creating a difficult situation for builders and the allottees equally.

ABAD International EXPO 2016, the exhibition organized by ABAD was another land mark in the history of ABAD. Like the previous successful event, more than 200 companies were participated from local industries as well as from overseas. All of this provided unique opportunities to builders and developers and manufacturers of supplies to building industry such as cement, steel, sanitary ware, paints, glass, wood etc. The exhibition has been described as very successful.

Delegates from Turkey, Germany, UAE, Thailand and Singapore also visited the exhibition. B2B meetings were organized and it is expected that the exhibition will play the role of catalyst which is expected to bring in foreign investment of around millions of dollars and also help in transfer of technology from one country to another.

SOUTH REGION CHAIRMAN'S REVIEW

First of all I am very thankful to my members for reposing confidence in me and elected as Chairman South Region. Immediately after taking over as South Regional Chairman, I took a stock of the situation with my colleagues in REC and we agreed that we need to bring harmony and peace in Karachi as top most priority so the economic activity in the city and the province could start. So, we decided to start meetings with all the law enforcing agencies.

In this connection meetings were organized with the Additional Inspector General Sindh Police, DIGs, SSP, Commissioner Karachi, Rangers etc. Some meetings were arranged at the office of these officers and some meetings were arranged at the ABAD House. These meetings proved useful as the law and order situation calmed down and by and large somewhat normalcy prevailed. This situation provided a boost to economic activity. The building and construction industry started to move its wheels which provided jobs to both

skilled and unskilled workers. Simultaneously, the allied industries also started working with increase in the demand for their products. The cumulative effect of all this resulted in bringing out improvement in the economy.

I feel proud to inform the members that ABAD organized an investment oriented event second time with the same theme but with even bigger magnitude, ABAD International EXPO 2016 from 12 to 14 August 2016 at the Karachi Expo Centre. This was an international show as a number of local and international exhibitors from leading builders, real estate and building related companies participated. Also delegates from Singapore, Sri Lanka, UAE, Turkey and Germany and many other countries visited the exhibition.

The exhibition has been declared a great success by all standards. The exhibition was inaugurated by the Governor of Sindh and visited by dignitaries like, Speaker and Deputy Speaker of Sindh Assembly, Provincial Ministers, Secretaries of Federal and Provincial ministries and bureaucrats. The exhibition is expected to attract foreign investment of billions of dollars and also initiate transfer of technical knowhow.

The exhibition was also accompanied by two seminars and a workshop on different topics related to building and construction industry. These sideline events were addressed by expert professionals and speakers from different organizations and were also attended by large number of people.

REC is also aware of the issues like with K-Electric. We are in regular negotiations with them through meetings and correspondence regarding delays in electric connection, bank guarantee, Connection under Self Finance. We hope that some positive result will be achieved soon.

ABAD played a very pro-active role in the matters of policies which were initiated by the Governments, both at provincial and federal level.




