ABAD POLICY FOR ISSUING GUARANTEE FOR SECURITY DEPOSIT EQUIVALENT TO 1% OF TOTAL COST OF THE PROJECT ON BEHALF OF THE MEMBER

TERMS OF REFERENCE

- 1. Guarantee: ABAD Guarantee will be issued without discrimination to all members subject to fulfillment of the following requirements;
 - a) It will be issued on behalf of those Builders & Developers who have taken NOC for sale for at least Two Projects and have successfully completed/delivered to the Allottees.
 - b) ABAD will charge 10% of the security/Guarantee, amount from the members as processing fees.
 - c) Members desiring to obtain ABAD Guarantee must pay in Advance ABAD membership charges at least to the extent of the project completion life as declared for Sale NOC.
 - d) ABAD Guarantee will not be issued to those members against whom there are numbers of complaints pending at ABAD from the Allottees or their ongoing projects is/are delayed more than 5 years of completion time without taking any extension/revision from the regularity authority.
 - e) To encourage new members, ABAD will issue guarantee subject to pay of processing fees and additional pledge of property equivalent to the amount of guarantee.
- 02. A Committee consisting four Senior Members, will be formed to issue the above Guarantee.
- 03. The above Committee will work independently without any interference from the Office Bearers.

- 04. The Committee will have an option to Co-opt any member for disposal of case of a particular area on temporary basis.
- 05. The Committee shall decide the case unanimously.
- 06. The Tenure of the Committee will be for 3 years, tenure can further be extended for 3 more years.
- 07. In case of vacancy in the committee due to any reason before completion of three years term, it may be fulfilled by the 2/3 votes of combined CEC and REC of that region.
- 08. The Committee may either accept or reject any request for issuance of Guarantee within 7 working days, without giving any reason.
- 09. An appeal against the decision of the Committee will be filed with immediate CEC, Final decision will be taken unanimously be the CEC, and this will be accepted as final decision.
- 10. A undated cheque of full amount of Guarantee will be given to ABAD along with other documentation which will/can be used if the Guarantee is called by SBCA or otherwise will be returned and uncashed on 50% occupation of the Project.
- 11. Following Members of ABAD are to be made members of the Committee.
