# Brief bout



ASSOCIATION OF BUILDERS AND DEVELOPERS OF PAKISTAN (ABAD) is a National Level representative organization of Builders and Developers, registered under the Companies Ordinance, 1984 with Registration No. KARACHI No. 4967 of 1977-78 and licensed under Trade Organizations Ordinance, 2007 and it's affiliated with the Federation of Pakistan Chamber of commerce and Industry (FPCCI). It was formed in the year 1972 with the aims and objectives of unifying and streamlining the construction activities of private sector.

#### The principal aims and objectives of ABAD include.

- Unifying builders and developers for collective good and streamlining their activities
- Promoting Housing industry in the country
- Providing assistance to relevant Government Departments in formulating housing policies and plans
- Coordinating between ABAD members, Government Departments and other concerned agencies for resolving issues of members of ABAD.
- Organize research activities for promotion of building techniques and introducing new developments in the construction industry.
- Create awareness and organize training programs for promoting science and art of building
- Working actively for eradication of unethical business practices from construction industry.
- Exploring prospects for undertaking large scale projects in the public sector and form a consortium of ABAD members to secure and execute the projects

Today, ABAD has in its fold more than 1000 leading construction companies of the country. Most of its members' offices are equipped with up-to-date systems of designing, cost control, project management and latest civil engineering techniques to minimize the cost of construction. The association operates on democratic lines with election of One Chairman, Senior Vice Chairman, Vice Chairman and Managing Committees and One Chairman from each of its two regions i.e., Southern Region and Northern Region for a full term of year. The Chairman-ABAD is elected among Full / Ordinary members and the Senior Vice and Vice Chairman from Associate Members and One Chairman each from its two respective. These office bearers are elected through the core committees of ABAD namely Central Executive Committee and Regional Executive Committees of (SR) and (NR).

As a representative organization of the country's builders and developers, ABAD has made a valuable contribution in the formulation of National Housing Policy and Sindh Building Control Ordinance. It has

also played a leading role in securing and increase in the House building Finance Corporation component of housing loans as well as the allocation to HBFCL in the Federal Budget.

In Karachi ABAD has played a pivotal role in procurement of land for its members and also for the issuance of no objection to

them by Karachi Development Authority. Other major achievements of ABAD include increasing the covered area of flats, fixation of the selling price of housing units, inclusion of a provision of escalation, simplification of the procedure for the permission to mortgage and registration of leases, increase in the period of completion and streamlining of documentation procedures regularly. Although there is a pressing requirement for houses in Karachi vet on account of non-availability of infrastructure and other amenities, some schemes cannot be developed due to scarcity, efforts to remove these bottlenecks are continuing on all possible levels.

As a socially responsible organization in addition to the above core functions ABAD also extends donations and other kinds of support to deserving institutions and welfare organizations. A safe shelter to live in is recognized the world over as a fundamental human right and that is the vision behind ABAD's efforts and ventures.

ABAD has four well managed operational offices all over Pakistan; A Head Secretariat in Karachi, North Regional Office in Lahore, Sub-Regional Office in Hyderabad and Capital Office in the Capital



City Islamabad. The Secretariat Office of ABAD in Karachi is having all the state of the art facilities required to run an Association's Secretariat. Having the staff members from Secretary General to Administration Officers and from Media and Research Cell to Archive and Publication Department ABAD has the entire capacity to deal with the day to day affairs of builders and developers. Within the Secretariat it has a Conference/Seminar Hall and Committee Room for the

committee meetings and different events. Separate rooms are also designated to all the elected office bearers where people meet them and get their issues resolved. Keeping the religious values at a high place ABAD also has a Prayer Area where around 150 persons can offer prayer at a time. ABAD has more than

forty different sub-committees headed by their Convener and Co-Conveners, who are always eager to serve for the betterment of housing industry and for the prosperity of ABAD as a whole. Having

the focal persons in almost all the concerned government departments ABAD has been very active to resolve the issues of it members with the best possible coordination from the government agencies.

ABAD has also been very phenomenal in organizing different events and exhibitions. Like in the recent past the ABAD Int'l EXPO 2014

Government must ensure the participation of local builders, contractors, skilled and unskilled labor in all CPEC projects. Also it must open venues for use of locally developed materials in these constructions. Government should have a strict eye on the project as not to become only one sided affairs.

# CONSTRUCTION MACHINERY AROUND THE WORLD

#### Concrete Batching Plants and Its Types

A concrete batch plant is a mixing plant where sand, gravel, cement, water, and other materials are turned into concrete. The concrete produced in concrete batch plants is used for the foundations of buildings, paving material for roads and parking lots, pipes used for drainage and plumbing and pre-cast concrete components. Although the two words 'concrete' and 'cement' are often used interchangeably, cement is actually one of the ingredients in concrete. It's the fine gray powder that, in combination with water, binds sand and gravel or crushed stone into concrete, therefore, even though cement constitutes only 10-15% by weight of concrete's total mass, cement is the essential binding agent in concrete.



As we know that a notification issued from Sindh Building Control Authority (SBCA), in which it is made mandatory to use the concrete made from batching plant for the high rise buildings. As there are several advantages of a concrete batching plant at a construction site. They eliminate the problems of inefficiency and to minimize the risk of waste and therefore of loss of profits. Its use also enhances the life of the building as well as the strength, and is specially very beneficial for the high rise buildings.

Concrete batch plants are used by the construction industry and are required to produce high volumes of concrete and to be portable or stationary as required for a particular construction site.

There are various models of concrete batch plants available on the market designed to suit the particular needs of the construction industry. Self-loading batching plants are ideal for use at pre-cast yards and building sites. They are particularly useful for sites where continual concrete production is required 24 hours per day. The self-loading batch plant is fitted with a radial scraper that loads all the mineral materials, used in making concrete, into a weigh hopper. This is achieved via a programmable computer. The batch plant then discharges the mixture from the weigh hopper into either a pan mixer; drum mixer or dry belt conveyor.

#### Concrete Brick Makina Machine

A concrete brick is made of concrete that's been molded into the correct shape, and then allowed to harden and cure. Concrete brick and block making machines consist of a steel framework that holds the other components in place. There's a chute or hopper for pouring the wet cement, a frame that holds the metal concrete-block molds, a tamper for compacting the concrete in the molds and a mechanism for transferring the molded blocks out of the machine for drying and curina.



The machine is set up with the molds appropriate to the blocks or bricks to be made. Manual machines typically mold two or four bricks at a time, while electric, pneumatic or hydraulic block machines make eight to 16 bricks at a time, depending on brick or block type.

# Urbanization in Pakistan An Opportunity or Challenge


tial areas; excessive pressures on the available services; and resultant problems of sanitation, air, pollution, inadequate access to safe drinking water, over-crowding and social problems.

There is no denying with the fact that urbanization is strongly linked to economic growth. But, at the same time, rapid urbanization poses severe challenges to developing countries, as cities in these countries are ill equipped to deal with this increase. Without adequate planning and control, rapid urbanization may lead to: the development of informal and unauthorized settlements; shortages of housing; poorly serviced and designed residen-

#### Benefits of Urbanization

Cities, and policies that affect them, play a major role in building a market economy and in achieving stable and equitable growth. Lahore, Rawalpindi and Faisalabad from Punjab; Karachi and Hyderabad from Sindh: Peshawar from NWFP; and Quetta from Baluchistan are relatively developed districts of Pakistan. These are the districts that include the highly urbanized cities of Pakistan. Even, the relatively developed provinces, Punjab and Sindh, have larae underdeveloped pockets. This indicates that development in these provinces is primarily because of the development of their cities - Lahore,



Rawalpindi, Faisalabad, Karachi and Hyderabad. This supports the close association between urbanization and regional development.

Pakistan's ten major cities play a prominent role in the acceleration of its economic development. Of the total value added in large-scale manufacturing in Pakistan, about 48 percent is generated from these cities. Of this 48 percent, Karachi alone produces 29 percent while Lahore, Faisalabad and Hyderabad produce 6.3 percent, 5 percent and 3 percent, respectively.

The existing agglomeration economies in these cities not only attract capital but also generate internal and external economies as well and thus also provide incentives for investor. Moreover these cities have a vast informal sector, particularly in

Karachi and Lahore, which accommodates large number of illiterate unemployed. The dominance of employment in commerce and services, in these cities, too implies enough shares of urbanized cities in economic growth.

Large Markets, Industry and Trade The prominent center of economic activities is Karachi which accounts for about 32 percent of the total industrial establishment of Pakistan. It has not only large manufacturing industries but also the largest small-scale industry zone (having more than 3,000 industrial units) of Sindh and about 90 percent of these units are export oriented. Lahore is the next biggest industrial city of Pakistan. Industries in and around it has been continuously expanding. In Faisalabad, Hyderabad, Gujranwala and Multan industrialization has made great progress.

Textiles and garments produced/manufactured in these urban centers are supplied not only to other parts of the country but also are exported abroad (more than 65 percent of export earnings come from this sector).

#### **Urbanization Creates Employment**

Karachi, Lahore and Faisalabad are prominent for their high rate of employment and among them the major employment generator city is Karachi. If we take the statistics from large scale industry zone of Karachi, it provides employment to more than 0.5 million local residents as well as to migrants from all over the country, while the small-scale industry zone provides employment opportunities to more than 0.3 million



skilled, semi-skilled and non-skilled workers. Moreover, a large number of educated people look for better jobs, particularly in Karachi and Lahore as they absorb them because of their huge setup of multi-national firms and large markets of financial sector.

#### **MAJOR PROBLEMS**

**Urban Housing** 

In most of the urban areas there is a growing problem of housing provision. The housing facility in public sector is very minimal while in the private sector the prices are very high (both for purchase or rent). Persons per housing units or rooms per housing units determine the level of congestion of housing units. There are, on average, two rooms in every house in major cities of Pakistan. Each housing unit, on average, accommodates more than six persons in cities. This indicates that each room is shared by three or more persons.

Rapid urbanization can be devastating. It can lead to the proliferation of slums and squatter areas as well as an unhealthy environment. In Pakistan, the expansive houses in the formal sector consequently have given rise to informal settlements. These informal settlements i.e. unplanned urban expansion (katchi abadis) and slums, over time, have grown in number and size. About one-third of urban population resides in 2,460 katchi abadis and

2,184 slums. These houses are often overcrowded with unhygienic conditions such as, no proper sanitary facility, limited access to water supply, electricity and social services. This in turn results in the spread of diseases like tuberculosis and cholera.

#### Water supply

The availability of clean drinking water is another problem which the people have to face, despite the fact that they live in urban areas. A large proportion of the urban population does not have access to clean drinking water. The quality of water

the problem of lack of convenient toilet facilities. According to one source only 59 percent of urban population has sanitation and sewerage facilities. This indicates that the level of accessibility to adequate sanitation is disappointedly low. Another study has found that only 45 percent of the houses in the urban areas of Pakistan are found to have flush toilets served by water-borne sewage systems. Another 33 percent of city dwellers use flush toilet connected with septic tanks, and 7 percent use covered dry toilets. Some 15 percent of households use toilet facilities that



supplied through existing networks of water supply schemes does not meet the World Health organization (WHO) standards. Only half of the urban population of Pakistan has the facility of tap water inside the house, whereas 5 percent has it outside house, 38 percent use hand pump and motor pump, and the rest use methods like digging wells, public standpipes, water sellers, etc. to fulfill their water requirements.

#### Sanitation facilities

Urbanites are also confronted with

#### Health services

Although urban areas have greater health facilities in comparison with the rural areas, but the growing pressure of population in these areas also affects the provision of health services. The statistics indicate that these are inadequate to fulfill the requirement of the entire population of urban households.

#### Urban environment

industrial development a priority target. While, this no doubt creates wealth and prosperity it also results in the waste of great amounts of natural resources.

The level of environmental pollution in these cities is increasing gradually because of smoke-emitting vehicles, emission of chemicals and release of raw waste by factories. Industrial clusters around the industrial cities generate huge quantities of untreated effluents that are ultimately discharged into fresh water lines. Karachi is one of the most polluted (air and water) cities of the world where total suspended particulates (TSP) is three to four times higher than the level determined as safe by "WHO. Also sulphur dioxide and nitrogen dioxide that are hazardous for human health are notably above the safe levels. Similar conditions prevail in other

major cities like Lahore, Faisalabad, Multan, Hyderabad, Rawalpindi, and Peshawar.

#### Shortcomings of Urban Development Program

Urban development appears inevitable, even if efforts at rural development and decentralization were more successful, not least because many people have established themselves as more or less permanent urban residents. In Pakistan, one finds that a part of the attraction of better employment, the provision of other facilities (for instance, education, health, transport and communication, infrastructure facilities), are far better in urban areas. Developing countries like Pakistan face certain constraints as far as urban development planning is concerned. The most binding constraints are the shortage of financial resources, dependence on

foreign capital, high and disproportionate public expenditures service. The others are mismanagement in the usage of whatever resources are available, and lack of effective urban governance. Urban planning and management are of limited extent even in the primate city Karachi.

Although Pakistan has achieved high economic growth in the past, population has also grown at a high rate, so that per capita income has grown at around 3 percent per annum. There is also a feeling that the benefits of growth have not been shared equally among different regions and different sections of the society.

#### **Proposals**

The three main ingredients for improving urban conditions in Pakistan are improvement in urban



governance, in management, and in finance. The role of successful urban governance is extremely important, which is guided by four basic principles. These include accountability of public sector staff; community participation; predictability of laws and regulations (especially in terms of contract law, dispute resolution procedures and dear allocation of responsibilities), and transparency in private dealings. With the shift in development fashions to minimal government intervention and near-exclusive reliance on the private sector, governments are likely to neglect these priorities.

The management and development of cities need greater consideration. The first thing is for governments to recognize the seriousness of urban problems. The next step then is to get the context right, that is, to create an appropriate strategy of development. This means economic growth, which requires a favorable climate for investment (both public and private). After that, it is imperative to structure the reform program; this first of all requires examining

thoroughly the causes of poverty in urban areas. It is likely that many urban reforms and development program will be impeded if priority attention is not given to urban poverty reduction/alleviation as it decreases the productivity of urban labor force and thus urban economic growth, leads to social and political clashes, and creates health and environmental problems. In addition, it is also essential to adopt a program to control population growth.

As far as management of urban development is concerned four elements need to be kept in view. First, it is essential to have effective local authorities (i.e. appropriate institutions for delivery of services) and organizational structures to work (i.e. adequate availability of both human and financial resources). Second, it is necessary to ensure that there is coordination and integration of development proposals, ranging from land use to service provision, with the urban plans, as cities get larger. Third, it is crucial to formulate and implement urban plans and policies. Fourth, it

is essential to involve local people in planning in order to get sustainable urban development. It is now realized that participation and empowerment are central to all facts of development. This requires improved education, workshops and involvement of private sector.


In addition, urban policies must address three systemic issues. These are: i) allocation of resources efficiently - set in with the move from central planning to market pricing of production factor; ii) managing social safety nets - rooted in the transfer of responsibility for delivery of social services from state enterprises to local authorities; and iii) building strong local institutions embedded in the changing role of local authorities from that of being responsible for executing central planning to that of being accountable to local citizens for management of municipal assets.







#### Ulm Cathedral, Germany

Ulm Minster, sometimes referred to as the Ulm Cathedral, is a Lutheran Church in Ulm, Germany. This magnificent Gothic masterpiece is located on the banks of the River Danube in Germany's Baden-Wurttemberg region. Work on the Ulm Minster started in 1377, but it was finally completed in 1890. It is considered the tallest church in the world at 161.5 meters (530 feet) and was once the tallest building in the world. From the top level of the structure, visitors are able to view a panorama of Ulm and a glimpse of the Alps.







#### **Tianning Temple, China**

Located in Changzou City in China's southern Jiangsu province is the Tianning Temple, which is the largest wooden structure in the world, standing at 153.79 meters. The thirteen storey building was completed in 2007 and it serves as a Buddhist pagoda. With the Chinese Communist Party relaxing its control over religion, the pagoda was allowed to stand for the historically peaceful religion of Chinese Chan Buddhism.



#### Notre Dame de Paris, France

The Notre-Dame Cathedral was completed in 1345 (after 182 years under construction) and is one of the most renowned religious structures in the world. The French Gothic Roman Catholic cathedral sits in the heart of Paris in the city's fourth arrondissement. The cathedral's spire reaches a height of 90 meters (295 ft). It is also the home of some of the most important Catholic relics: the True Cross, one of the Holy Nails and the Crown of Thorns.

#### **Meeting of Conveners and Co-Conveners**

The convener of FPCCI Committee M. hanif Gohar briefed the meeting regarding nominations in FPCCI standing Committees as Chairman and Vice Chairman. He said that committees are still open and if any member wanted to lead the committee he may contact with him.

Then the Senior Vice Chairman and Chairman South assured their full support to all the committee heads in every possible manner and also hoped that the working of subcommittees become even more better in near future.

Since there was no point to discuss the meeting ended with vote of thanks by Muhammad Hassan Bakshi.

#### **Meeting of Shelter & Publication Sub-Committee**

The meeting was held on 30th December at ABAD and started with Recitation of Holy Quran. Then the Convener, Engr. Zaheer Qadri briefed the meeting that it was called to discuss the composed dummy of Shelter Magazine. He said to Mr. Hussain that we gave you this magazine to improve its auality and make it like international standards because you are special-

ized in this field, but sorry to say you people just cut and paste the given material. We didn't find any designing and picture setting in your composed dummy. It also clearly seems that we did good work previously as compare to your designed dummy. He also showed some of the old published magazines to Mr. Hussain and his Team -Mr. Shahid and Mr. Zahid.

Mr. Hussain agreed with the observations of Engr. Qadri and said that he and his team will try their level best to improve the quality of magazine and will again compose the magazine according to the provided guidelines.

Mr. Hussain further informed that advertisement for the magazine is not from his side and his job is to

just compose or designed the magazine and then print it after approval from ABAD. He added that securing the advertisement was from the Chairman side / ABAD side. He clarify that in previous meeting Chairman ABAD said that ABAD will arrange advertisement for whole year period from different builders and construction material suppliers.

Mr. Hussain also said that we just provide international standard articles and for that we already started research. So, from the next issue we will be able to include our articles also.

In the meeting, Mr. Shahid Khairi said that it would not be possible to follow the given timelines; otherwise the magazine or the system we follow will become more problematic.

Mr. Shahid Niaz, said that he is neither a technical person nor a professional writer to generate articles from its own. It takes him time to research the related article and get them ready for shelter magazine.

Engr. Zaher Qadri suggested that the articles must be related to the construction industry and construction related activities of Pakistan, But Mr. Hussain was of the view that we should add articles related to international construction activities in order to make the magazine more informative. Regarding title of the Magazine Engr. Qadri said that 3 to 4 title options should be designed so that the best one can be selected.

Then Mr. Hussain explained the responsibilities of ABAD and his team. Responsibilities towards Hayder Ali & Co.

- Composing / designing
- Necessary edit or correct the given material
- Articles of international standard (3 articles in each issue. maximum 2 pages each)

Responsibilities towards ABAD

- Arranging the advertisement
- Provide basic material/contents, regarding ABAD activities

- Provide the key points / topics for interview from government officials. (but interview conducted by Hayder ali & Co.)
- Take interview of CEOs of construction material suppliers.

In the meeting it was also decided that 15 days will be required to Hayder Ali & Co. to get the magazine print, after providing the raw format material. So the basic material will be given on 15th of every month for designing and printing on time.

In the meeting Mr. Hussain suggested that ABAD employees' achievements should be published in magazine and ABAD members having new projects should also be highlighted in it so that advertisement can be taken from them.

Since there was no point to discuss, the meeting ended with vote of thanks by the Convener.

#### **Meeting of Valuation Table, Registration** & Taxation Sub-Committee

Deputy Commissioner Malir should take ABAD in confidence before finalizing the price fixation of related areas.

The meeting was held on 2nd December at ABAD. Started with Recitation of Holy Quran by Mr. Arif Shaikhani, Mr. Farigh Nadeem, Convener of the committee greeted the members and briefed the agenda of the meeting. He informed that himself along with Mr. Omer Bin Islam represented ABAD and attended the meeting called by DC Malir regarding District Price Fixation of Government Land in respect of Deh Mehran & Deh Saforan in District Malir, Karachi. They informed that DC Malir have revised

the rates after 20 years, earlier the same rates were revised in year 2007 and 2015 and the current revision of rates were proposed on 30th November 2016 in the last meeting with DC Malir. Mr. Farigh Nadeem also explained the categories and suggested that the plots in A1 category should be on 100 feet.

It was also suggested that DC Malir should also take ABAD in confidence before finalizing the price fixation of related areas. Mr. Nadeem informed that these recommendations have been put in the meeting with DC Malir and it was informed by DC Malir that all recommendations will be approved by the board in which Chairman ABAD will also be a member.

Mr. Ghulam Hussain Memon, Former Chairman Sub-Region of Hyderabad informed that he had a meeting with Mr. Hassan Bakshi, Collector Income Tax Hyderabad in which he discussed the matter of valuation table and taxations and also discussed the matter of categories. He also informed that Transfer Fee, Taxes on Gift Deed, Stamp Duty, Surrender Deed, etc. FBR rates are higher in Hyderabad. Mr. Fariah Nadeem requested Mr. Ghulam Hussain Memon to send details of the meeting to ABAD along with proposed plan and recommendations as discussed in the meeting with Mr. Hassan Bakhi, Collector Income Tax so that we can follow-up with concerned department.

Mr. Omer Bin Islam, Co-Convener informed that some members are facing problem in getting sub-lease in some areas of Karachi, so the matter should also be taken with concerned departments. It was also suggested that proper and justified valuation table should be prepared

by the concerned departments which also be finalized with the consent and approval of stake holders including ABAD.

Mr. Faisal Yousuf informed that he has experience of dealing the matter related to FBR Rates in previous vears and informed that rates was same in 2007 to 2005, the rates was revised in 2016. Mr. Nadeem requested Mr. Faisal Yousuf to share the papers of his meetings with DC Malir & FBR so that it could be discussed in the next meeting. Mr. Faisal Yousuf also suggested that ABAD should also brief the matter of amnesty related to tax to members of ABAD.

The matter of Tax Regime was also

discussed by members in the meetina. It was informed that 21 members have paid 5% against advance of each project in November 2016 and remaining 95% to be paid on quarterly basis. It was also mutually agreed that ABAD should work to revise / lower the rates with concerned departments. It was decided that the proposed fee structure should be: A1 Category = Rs.3500 and A Category = Rs.3000.

It was also decided that Sindh Government should consider lowering the rates so that it can be iustified and should not be a burden on builders and developers. As there were no points to discuss the meeting ended with vote of thanks to and from the chair.

#### Joint Meeting of Revenue Land Matters, **LDA and MDA Sub-Committee**

ABAD should create good liaison with LDA & MDA so that the issues can be resolved on priority basis.

The meeting was held on 3rd December at ABAD. Started with recitation from Holy Quran by Mr. Sadia Baloch, Mr. Fayyaz Ilyas welcomed all members in the meeting and briefed about agenda of the meeting.

Mr. Fayyaz Ilyas informed that the meeting of Revenue Land Matters, De-Freezing of Land by BOR Sub-Committee was held previously in which it was decided to call joint meeting with MDA & LDA so that issues may be highlighted and should be addressed properly. He requested members in the meeting to give suggestions in this regard.

Syed Khursheed Alam, Convener MDA Sub-Committee informed that infrastructure facilities in the areas of MDA were very poor and need to be improved by MDA. He also informed that members working in MDA have been facing problems in locating and identifying their plots and its jurisdictions. He also suggested that ABAD should send a letter to MDA to provide copies of MAPS of MDA along with details of linked DEH's in MDA.

It was also mutually agreed that ABAD should create good liaison with LDA & MDA so that our issues can be resolved on priority basis.

Sved Altaf Hussain informed that huge land was available in the jurisdictions of MDA which can be utilized in Low Cost Housing Projects. He suggested that ABAD should consider those areas in projection of low cost / affordable housing projects. He informed that in collaboration with MDA/LDA and public private partnership schemes. He also informed that some members were facing problems due to encroachment and land grabbing on their plots in MDA & LDA due to which construction activities were disturbed.

Mr. Muhammad Ayoob, Chairman SR informed that Anti-Encroachment and Law & Order Sub-Committee of ABAD was helping to resolve such issues in coordination with Law Enforcement Agencies and concerned authorities. He suggested that all the matters related to the encroachment or land grabbing should be sent to ABAD for taking proper action. He also informed that some members have applied for new electricity connection on self finance scheme basis. He added that the matter of double taxation will be

taken by ABAD and similarly the rates of Outer Development Charges have also been lowered by SBCA by the efforts of ABAD.

Mr. Sadia Baloch, Convener of LDA Sub-Committee informed that infrastructure facilities and roads in the areas of LDA were very poor due to which members were unable to start construction activities in those areas and this problem also causing delay in completion of their projects. Beside those the issue of sub-lease was also there that caused more problems to the builders.

Mr. Zeeshan Zaki, Co-Convener of Revenue Land Matters informed that no electricity in Sector 12, Surjani Town, Karachi due to which many projects were facing delay in completion process. He also pointed the matter of taxation by DC and KMC. He further informed that Federal &

Provincial Governments are felicitating Chinese companies involved in the development of infrastructure and housing schemes across Pakistan. They have been offered electricity on their door steps / on-going projects under CPEC. In this regard, K.E should also manage to provide new connections to members of ABAD who have applied and waiting since years to get new connection. He suggested that ABAD should highlight the matter in the next meeting with K-Electric Officials, Mr. Zeeshan informed that WAPDA is providing new electricity connections in Port Qasim, whereas K-Electric is unable to provide connections in the Karachi residential areas.

Mr. Fayyaz Ilyas, Convener asked Mr. Zeeshan Zaki to send details of pending issue so that ABAD can take proper action to resolve the issue in coordination with concerned department.

Members also discussed the problems related to K-Electric. It was suggested by Chairman SR that complaints related to K-Electric should be referred to ABAD Secretariat; the same will be sent to Convener & Co-Conveners of K-Electric Sub-Committee for the resolution.

In the meeting it was also suggested that K.E. should provide connections without the condition of self-finance scheme so that builders and developers can complete their projects on time and to give possession to their allottees.

Then Chairman SR concluded the meeting and also suggested to gather the details of pending issues regarding Revenue Land Matter, LDA & MDA and also K-Electric so that those issues can be discussed in the next meeting.

#### **Meeting of CPEC Planning & Development Committee**

The concerned Sub-Committee shall work to get better prospects of business contracts with CPEC

The meeting was held on 9th December at ABAD and started with recitation from Holy Quran by Mr. Farigh Nadeem. It was called to discuss and finalize the upcoming seminar on the topic of CPEC. Mr. Noman Tabani, Convener of Committee greeted all members in the meeting and briefed agenda of the meeting.

In the meeting Mr. Arif Jeewa informed that Mr. Ishaa Dar, Federal Minister of Finance & Professor Ahsan Jabal, Federal Minister for Planning Division will also attend the seminar at ABAD House. He informed that due to shortage of time on Friday, the seminar has to be started on time to make the seminar success within the

specific time. He suggested that ABAD Secretariat and the Sub-Committee will ensure the presence of members in that seminar.

Mr. Noman Tabani suggested the name of seminar should be "CPEC OPPORTUNITIES UNLIMITED." He also informed that development works under CPEC were under construction in Gawader, Kati Bandar, D.I. Khan, Kohat etc.

Mr. Arif Jeewa informed that at present ABAD and its members were not in any contract with CPEC allied companies in development works. We should work to get some contracts in the development of housing schemes under CPEC. He also informed that Chinese companies in collaboration with Pakistan Government were awarding contracts to foreign companies with vast experience and with high reputation in construction industry, He suggested that members of ABAD should also registered some companies with SECP and foreign partnerships to get construction works under CPEC development programs. Added that he had attended several meetings of federal government related to the CPEC and observed that lots of potential projects related to the construction and housing industry were available under CPEC planning.

Members also discussed the options to develop low cost housing schemes in that regards that can be

offered to federal and provincial government involved with CPEC Planning & Development process.

Mr. Noman Tabani shared his experience of working with Chinese companies and suggested that members should be very careful signing contracts with Chinese companies and to become part of any Joint Venture with foreign companies in terms of financial proceedings. He also suggested

that ABAD should finalize the presentation for the seminar to be presented to finance minister and other government officials in the upcoming seminar on CPEC so that image of ABAD shall be enhanced to the concerned authorities. He added that KPT & Port Qasim terminals have also been upgraded due to CPEC.

In the meeting it was mutually agreed that sub-committee should work to get better prospects of business contracts with CPEC so that construction industry can flourish. It was also suggested that a proper proposals and presentation will be shared in the seminar with Minister of Finance and Minister for Planning in order to get involved in the new projects under CPEC. Since there was no point to discuss the meeting ended with vote of thanks to and from the chair.

#### Meeting of Revenue Land Matter, De-Freezing of Land by Board of Revenue (BoR)

Members of ABAD should pay the ODC so that concerned authorities will utilize the funds for the improvement of Infrastructure facilities in Scheme 33.

The meeting started with the recitation from Holy Quran then Mr. Fayyaz Ilyas, Convener of the Committee welcomed the members in the meeting and briefed about the agenda of meeting. The convener requested members to give their suggestions and recommendations related to revenue land matters or other charges.

Mr. Muhammad Ayoob, Chairman Southern Region ABAD suggested that these matters should be dealt in coordination with concerned departments and ABAD will be in a better position if members of ABAD should report their issues with Board of Revenue and concerned Authorities / Departments.

During meeting it was also suggested that the Committee should also discuss the matter of Outer Development Charges in Scheme 33, Karachi. The recent letter received from Deputy Commissioner East / Project Director of Scheme 33, Karachi regardina

recovery of ODC from members of ABAD working in Scheme 33, Karachi was also referred. It was also discussed that it is necessary that members of ABAD should pay the ODC so that concerned authorities will utilize the funds for the improvement of Infrastructure facilities in Scheme 33.

The Convener appreciated the suggestions and said that members of ABAD should also be notified from ABAD to pay ODC. He suggested that ABAD Secretariat should send sms and e-mail to all members with request to provide details of any pending issues with Board of Revenue or any other departments so that proper action will be taken to resolve the issues of members of ABAD.

It was also discussed that in order to work in coordination with concerned Government Authorities and Departments, we should also call a Joint Meeting with MDA & LDA Sub-Committees, that would help us to

know issues of members of ABAD and to plan further line of action in coordination with members. I was also suggested to send letters to MDA, LDA and office of the Project Director of Scheme 33, Karachi with request to provide MAPS of MDA. LDA & MAPS of 43 linked DEH's in the area. This will help us identify the development in specific areas and can be shared with other members.

Mr. Fayyaz Ilyas inquired the members about development work in Northern By-Pass. Mr. Alam informed that most of the builders and developers are not able to carry out construction activities on their projects due to non-availability of infrastructure facilities in that area. He suggested that the matter should also be taken in the sub-committee to deal the matter with concerned Authority. He also informed that some builders and developers did not even started basic construction works due to which concerned authorities and utilities companies

are not improving infrastructure facilities in some Dehs.

Mr. Favvaz IIvas informed that it is the responsibility of Government Authorities and concerned departments to provide infrastructure

facilities to those under developed areas in Karachi so that builders and developers may start their development works, otherwise builders would be unable to get returns of their investment. He also assured that with team efforts we will

be able to resolve such issues with concerned authorities. At the end some members were also added in the sub-committee and then meeting ended with vote of thanks to and from the chair.

#### **Meeting of ABAD INTERNATIONAL EXPO-2017 Committee**

After Islamabad ABAD shall arrange International Expo 2017 in Lahore also.

A meeting for preparation of 3rd ABAD International ABAD Expo-2017 was held at ABAD. The meeting started with the recitation of Holy Quran. Mr. Muhammad Arif Yousuf Jeewa, Former Senior Vice Chairman ABAD informed the House that ABAD is now planning of its 3rd Mega Event on 24th to 26th March, 2017 at Pak China Friendship Centre, Islamabad and informed that booking etc. already been made and further said that due to the big auditorium there we have planned to hold Seminar on the sidelines also.

He added that we haven't approached the Allied Industry yet, so we have to decide whether we can make arrangements or to hold ABAD Expo-2017 or it should be given to other professionals to carry out the subject work with good planning.

Mr. Mohsin Sheikhani, Chairman ABAD said that we actually needed around 25 companies / sponsors for ABAD Expo-2017 at Islamabad and it was also proposed that the task would be given to Mr. Akber Sheikh and ABAD can manage the program and all sale and marketing will be done by ABAD Team.

Arif Yousuf Jeewa informed the

House that we should work with KPK and further we should call to KPK Chief Minister. Mr. Mohsin Sheikhani, Chairman ABAD said that we should take the Federal Government on board in this regards.

Mr. Muhammad Hassan Bakshi, Senior Vice Chairman ABAD informed the House said that before execution of any exhibition we should check its feasibility for e.g. some companies intended to meet with us but due to some delays they could not reached at time. So we should also consider their proposals. Mr. Muhammad Hassan Bakshi said that proper coordination would be required and a separate accounts be opened for expo. It was also proposed in the meeting that ABAD Team shall be lead by Mr. Muhammad Hassan Bakshi. Mr. Muhammad Hassan Bakshi also proposed to launch the 3rd Mega Event at Islamabad on January 16, 2016 at Islamabad.

Mr. Mohsin Sheikhani, Chairman ABAD said that we should make comprehensive layout plan and to study the offer by Zameen.Com, as we have already discussed the sizes etc. with them.

The Chairman further pointed out that a Musical Night to be arranged

and to invite the Foreign Diplomatic Missions in Islamabad and further the Northern Region be given chance to highlight the program and further we need a meeting at Lahore in this regard.

In the meeting it was also mutually agreed that after Islamabad ABAD should arrange International Expo 2017 at Lahore.

Chairman ABAD advised to nominate the Patron In Chief of 3rd ABAD International Expo-2017 to the Minister of Housing & Town Planning, Mr. Ishaq Daar, the Finance Minister and Mrs. Marium Nawaz Sharif and advised the Secretary General ABAD to write letter Mr. Ishaq Daar, Finance Minister of Pakistan and Mrs. Marium Nawaz to be the Chief Patron ABAD International Expo-2017, the Secretary General informed that it shall be complied with accordingly.

Chairman ABAD informed the House that Press Briefing shall be held in the end of December, 2016 and further we will arrange to visit at Lahore. As there was nothing more to discuss, the meeting concluded with a vote of thanks to and from the Chair.

#### **Meeting of KW&SB Sub-Committee**

The meeting was held on 3rd December at ABAD. Started with recitation from Holy Quran Syed Altaf Hussain, Convener of the committee welcomed the members in the meeting and briefed the agenda to the members.

In the meeting Syed Altaf Hussain requested committee members to give suggestions to improve the working of the Sub-Committee and create good working relationship & liaison with KW&SB. He suggested the formation of zone-wise committees so that head of each committee can get in contact with the members working in each zone and to highlight the problems and issues of members.

Mr. Altaf Tai, Co-Convener informed that he had some pending issues of billing with KW&SB and he also had a meeting with Mr. Aslam, Manager Revenue Resource Generation / RRG, KW&SB and the issue still needed to be resolved by KW&SB. He informed that members of ABAD working in the areas of P.E.C.H.S., Bahadurabad and

Shaheel-e-Millat Road were facing problems due to lifting of Water Pumps by KW&SB from project sites of builders and asking illegal amount to provide connections and to return the water pumps.

The co-convener also suggested that members of ABAD would provide list of allottees to KW&SB after completion of their projects, this will help members in getting legal connections easily and KW&SB would easily generate revenue regarding billing from the completed projects of members.

In the meeting it was also discussed that KW&SB have been charging illegal amount during the meter changing process from the builders which should be stopped. The members also suggested that KW&SB should provide tariff rates with clear details of charges so that members can assess the estimation for new connection and that would also help in the payment of billing matters of KW&SB.

Syed Altaf Hussain suggested that

we should implement the system to apply the application for water connection through ABAD so that members of ABAD should be treated on priority basis, he refers that this system was in practice few years back but was stopped or delayed from KW&SB. He suggested that KW&SB Sub-Committee will request Office Bearers of ABAD to consider continuing the system to forward the application for new water connection from ABAD to KW&SB

At the end, Mr. Muhammad Ayoob, Chairman South reviewed the proposals discussed in the meetings and suggested that ABAD should collect the details of pending issues with KW&SB and to finalize the agenda of the meeting with MD-KW&SB in consultation and approval of Office Bearers. He also assured to head the delegation of ABAD in the meeting with MD-KW&SB.

Since there was no point to discuss the meeting ended with vote of thanks to and from the chair.

#### Meeting at ABAD to Discuss Betterment Charges of SBCA

Sindh Building Control Authority is not authorize to collect "Betterment Charges"

The meeting started with recitation from Holy Quran and then Muhammad Hassan Bakshi, Senior Vice Chairman ABAD welcomed members in the meeting and briefed them about agenda of the meeting. He also requested the present members to give their suggestions and recommendations regarding the matter of Betterment Charges.

Mr. Mohsin Sheikhani, Chairman ABAD suggested that we should first discuss the impacts of taking the

matter in the court of law from ABAD and also to discuss the possibilities to negotiate the matter with SBCA before filing a petition.

Mr. Ibrahim Habib, Convener of legal Affair Sub-Committee informed that the matter of Betterment Charges by SBCA with reference to Stay Order obtained by few members of ABAD from the Honorable High Court of Sindh have been discussed in the meeting of Legal Affairs Sub-Committee held at ABAD in which it was unanimously decided that ABAD should file a petition in the court against Betterment Charges imposed by SBCA so that all members of ABAD should be benefited and should not pay the Betterment Charges to SBCA in the view of decision by the Honorable Court.

During meeting different suggestions were raised regarding filing a petition and having negotiation with the concerned authority.

Members in the meeting discussed the previous and present betterment charges, SBCA was charging Rs.50 / Sq. Ft. and as per revised rates it will become Rs.200 / Sq.Ft.

Mr. Arif Yousuf Jeewa, Former Senior Vice Chairman ABAD suggested it will be better if ABAD can negotiate the matter of Betterment Charges with SBCA before taking the matter to the honorable Court. He informed that it has been observed by almost all the members of ABAD that SBCA or other Authorities have to collect charges from members of ABAD related to the construction of their respective projects and schemes. Betterment Charges is the most revenue generating charges imposed by SBCA.

It was also discussed in the meeting to negotiate the charges to Rs. 100 / Sq. Ft. so that it can be easily paid by members of ABAD. Members also discussed that the court decision on the betterment charges also clears that SBCA is not authorize to collect "Betterment Charges"

Mr. Muhammad Hassan Bakshi, Sr. Vice Chairman ABAD informed that majority of members of ABAD are working in the main City Areas of Karachi where the construction cost is higher as compared to other areas of Karachi due to which betterment charges put burden on members of ABAD.

Since there was no point to discuss the meeting ended with vote of thanks to and from the chair.

#### **Meeting of HBFCL Sub-Committee**

A staff member from HBFCL will be deputed at ABAD House to facilitate members of ABAD in their related issues.

Mr. Muhammad Ayoob, Chairman Southern Region ABAD chaired the meeting and welcomed members in the meeting. Mr. Kaleem-Uz-Zaman Khan, Co-Convener of the Committee briefed about the agenda of the meeting. He informed that members are facing problems due to delay in approvals from HBFCL and public dealing.

Mr. Muhammad Ayoob briefed about the minutes of the meeting of ABAD delegation with MD-HBFCL in which several matters was discussed with MD-HBFCL. He informed that HBFCL will provide staff which will be deputed at ABAD House to facilitate members of ABAD in their related issues. The matter of providing office space to the representative of HBFCL will be finalized by Mr. Mohsin Sheikhani, Chairman ABAD.

In the meeting a member also informed that HBFCL is facing problem in dealing the matters related to downsizing in Human Resources and closing some offices in Karachi and Lahore. He suggested that ABAD should include these points in the agenda of the next meeting with HBFCL. It was also suggested that ABAD should prepare Point of Reference (P.O.R.) to the matters related to HBFCL and a meeting should me scheduled with Mr. Asad Jafri, Director HBFCL and Focal Person for ABAD. The name of Mr. Shahid Mahmood Usmani was also suggested as focal person between ABAD and HBFCL.

Chairman (SR) informed that the matter of finalizing the name of Convener of the Sub-Committee will be finalized by Chairman ABAD and Senior Vice Chairman ABAD for which he will give his recommendation.

Some members of ABAD from Interior Sindh also attended the meeting and shared their ideas. Chairman South appreciated those members - Mr Taria Aziz and Mr. Kishan Lal for attending the meeting and assured full cooperation

from ABAD.

He also asked Mr. Taria Aziz to bring new membership cases from Mirpurkhas. Mr. Taria Aziz informed that he will soon invite Chairman ABAD and senior members of ABAD to visit Mirpurkhas to meet interested Builders & Developers.

Mr. Muhammad Ayoob informed that the matter of Block Wise Financina also discussed in the meeting with HBFCL and the same shall be discussed in the next meeting. He suggested that the sub-committee should gather details of pending cases related to block wise financing from members of ABAD so that cases will be discussed with HBFCL in the next meeting.

Since there was no pint to discuss the meeting ended with vote of thanks by Chairman South Region.

#### **Meeting of KMC Sub-Committee**

Karachi Municipal Corporation should lower down the very high Material Dumping Charges.

The meeting was held on 9th January at ABAD. Started with recitation from Holy Quran by Co-Convener of the committee Muhammad Islam Siddiqui, that Convener Ahmed Owais Thanvi welcomed the members in the meeting and briefed agenda of the meeting.

Discussing the core issue faced by the members regarding KMC, the convener informed that the matter of building material dumping charges have been decided in several meetings of ABAD delegations with Commissioner Karachi, Mayor Karachi and Administrator KMC.

It was decided that only KMC is authorized to collect material dumping charges, as per internal policy of KMC and then they will share some percent of that charges with DMC to accommodate their expenses. He also informed that recently some of our members received challans from KMC & DMC due to the change of Director KMC and at present Additional Director KMC is looking after matters related to material dumping. He suggested that the issue should be discussed with concerned officials in next meeting of ABAD Delegation with KMC.

In the meeting it was also discussed that KMC and DMC staff were also asking for illegal amount even after the payment of official challans for the material dumping on builders'

projects and recently few cases were also reported in the areas of P.E.C.H.S. and Bahadurabad that caused a lot of problems.

Mr. Ahmed Owais suggested that members should not pay such illegal amount to KMC / DMC staff and the matter should be reported to ABAD Secretariat for taking proper action with concerned department. He also referred the meeting of ABAD Delegation with Mr. Laig Ahmed, then Administrator KMC, the meeting was held in April 2016 in which the matter was also discussed and it was then decided that KMC will collect Material Dumping Charges. He asked ABAD Secretariat to get the copy of minutes of that meeting from KMC Office for the record.

In the meeting it was mutually agreed that material dumping charges are also very high and ABAD should discuss the matter with KMC to lower the charges. It was also suggested that members should aet the latest list of charges from KMC to review them and to further suggest revised rates of dumping material.

Ahmed Owais Thanvi suggested that ABAD Secretarial should arrange a meeting of ABAD delegation with Director Encroachment Material – KMC in order to discuss these issues.

The convener also informed that

ABAD has discussed the matter of Adoption of Parks with Administrator KMC and Director Parks in 2016 as per few proposals of adoption of parks were received from members. He suggested that this matter will also be discussed with the Director Parks and KMC Officials so that members can beautify the surroundings of their projects in different areas of the city. He also added that the matter land grabbers and encroachers that encroached the land in front of builders' projects in various parts of the city will also be discussed with KMC Officials in the next meeting.

In the meeting, Muhammad Islam Siddiqui informed that his subject plot was allotted against auction in garden west Karachi and at present the subject plot is in the territory of local government authorities. Therefore, an alternate plot against allotted plot should be offered for compensation.

The convener also pointed out that ABAD needed a "Focal Person" to create and maintain good liaison between ABAD & KMC and then Mr. Arif Shaikhani was mutually suggested as "Focal Person" of ABAD in KMC. He also suggested that we should discuss the nomination of "Focal Person" from KMC to ABAD for the same purpose. Since there was no point to discuss the meeting ended with vote of thanks from the convener

#### **Meeting of K-Electric & SSGC Sub-Committee**

Members should not pay any illegal amount of K-Electric Staff or lower staff for Kunda Billing.

The meeting was held on 5th January at ABAD. Started with Recitation from Holy Quran Mr. Rizwan Adhia, Convener of the Sub-Committee thanked the members in the meeting and briefed the agenda which was to resolve the pending issues of members regarding K-Electric and SSGC.

Mr. Mustafa Sheikhani, Co-Convener informed that ABAD Secretariat has received 3 cases of pending issues and the letters have been forwarded to concerned department for necessary action. The convener suggested that proper follow-up to be made with concerned officials of K-Electric and SSGC to resolve pending issues on priority basis.

Mr. Rizwan Adhia informed that SSGC adopted Tender Process for projects whose new gas connections are above 1 Lac, the process of tender take time in getting approval from various departments due to which delays are causing from SSGC. However, Dr. Ejaz Ahmed Senior General Manager SSGC and concerned staff are willing to resolve pending issues of members of ABAD and the same shall be discussed with concerned officials in SSGC. He also suggested that members should report their pending issues to ABAD so that these cases should be referred to SSGC for the early resolution.

Mr. Mustafa Shaikhani informed that SSGC can consider providing new gas connections to housing schemes by linking gas lines within nearby areas where gas lines can easily be connected.

Mr. Rizwan Adhia informed that some members are facing delays in getting new gas connections due to the requirement of completion plan by SSGC. The matter of definition of completion should also be discussed with SSGC & SBCA. He suggested that members should not pay any illegal amount of K-Electric Staff or lower staff for Kunda Billing. Instead, he suggested that members should apply for the TL Connection by paying legal charges, this will soon end the provision of illegal connection and will streamline the system.

The convener also informed members about New TL Policy of K-Electric as a result of efforts of the K-Electric & SSGC Sub-Committee of ABAD. He informed that new TL Policy will be useful for ABAD Members and also asked members to inform any issues related to K-Electric.

It was discussed in the meeting that K-Electric policy is to remove meter on TL Connection after the completion of Projects. Therefore Teams of K-E regularly visit and checks under construction project in all parts of Karachi. But on the other side some lower staff of K-Electric also involve

in providing Kunda Connection on monthly charges.

Members also pointed out the issue of heavy billing charges by K-Electric. In this regards, Mr. Rizwan Adhia suggested that Mr. Mustafa Shaikhani & Mr. Danish Bin Rauf should meet with concerned officials of K-Electric, DECO / IBC to discuss and resolve the matter of members regarding removing of meters and heavy billing amount. It was also mutually suggested that the Billing Charge, Load Assessment Criteria and Bye-Laws of K-Electric should be reviewed so that to design a better proposal from ABAD for K-Electric.

Mr. Rizwan Adhia informed that K-Electric have SDC, System Development Charges and Consumer Service Manual which provides required details. He suggested that ABAD Secretariat should arrange present "Load Assessment Criteria" from K-Electric office which can be shared with all members of ABAD along with the copy of New TL Policy.

It was also mutually suggested that K-Electric & NEPRA should include representative of ABAD in meetings of Board of Directors and to get approval of appointment of ABAD Representation from Senate if necessary. Since there was no point to discuss the meeting ended with vote of thanks from the Convener.

### **Meeting of CPEC Planning and Development Committee**

ABAD shall play a proactive role in China Pakistan Economic Corridor.

A meeting of CPEC planning and Development Committee was held regarding preparation of conference which is to be scheduled at ABAD House in the mid of December, 2016.

The meeting started with recitation from the Holy Quran. Mr. M. Noman Tabani, Convener CPEC Committee informed the meeting that China Pakistan Economic Corridor project is worth about 56 billion US Dollar. But due to law & order situation in Pakistan security is the biggest issues in Pakistan especially in Southern Zone, but by the Grace of Allah our armed forces are fully aware and equipped to provide foolproof security of the said project.

Muhammad Hassan Bakshi, Senior

Vice Chairman ABAD advised the committee that ABAD intends to hold conference at ABAD House in the mid of December and it is our duty to present the figures in front of our members and to ensure a proactive role of ABAD in CPEC.

The Convener also said that we have shortage of housing in Pakistan i.e. about 12 million and due to continuously increasing the population, the shortfall is also increasing day by day but ABAD can play an important role in this sector if it is facilitated by the Government of Pakistan.

He added that for Industrial Plots the members of ABAD can work in joint ventures with Chinese Companies as the Chinese Companies did in

Sudan & Alaiers, where China have invested huge amount in Oil & Gas.

M. Hassan Bakshi said that manufacturing and construction activities shall face staff challenges due to the influx of Chinese companies. Mr. Sufian Adhia said that in Fazaiya Housing projects staffs belongs to China and they have assured the clients that they will deliver the possession of their projects before time and dates, so we should ensure to safeauard the interest of Pakistan like in the Middle East where they have safeguarded the interest of local people.

As there was nothing more to discuss, the meeting concluded with a vote of thanks to and from the chair.

#### **Meeting of MDA Sub-Committee**

The meeting was held on 22 February in which the convener Syed Khursheed Alam welcomed member and brief about the meeting agenda.

- 1. To discuss pending issues with MDA
- 2. To improve working of MDA Sub-Committee of ABAD
- 3. To discuss meeting agenda with MDA & LDA Officials

The Convener informed that ABAD Secretariat have sent messages to all members related to report any pending issues with MDA, but luckily the secretariat have not received any response from the members.

In the meeting discussions were also

made regarding availability of land in the jurisdictions of MDA & LDA that can be utilized in Low Cost Housing Schemes. It was also suggested that MDA Sub-Committee should also arrange to get details of such land owned by members working in MDA & LDA so that it can be helpful in planning low cost housing schemes.

The convener also suggested that the matter of low cost housing shall be discussed with Chairman ABAD and office bearers. He also appreciated the idea of gathering details of members working in the areas of MDA & LDA, this will help in planning low cost housing schemes in these areas.

The convener also suggested that next meeting will be called as Joint Meeting of LDA and MDA & Revenue Land Matters Sub-Committees so that issues related to these committees can be jointly taken up in coordination with the members of these 3 Sub-Committees. This will also create good working coordination among the sub-committees.

In the meeting the agenda was also discussed for the future meeting with officials of LDA and MDA. At the end, as there was not any other point in agenda, the meeting ended with the vote of thanks to and from the chair.

The meeting started with recitation form Holy Quran and then the Convener Mr. Kamran Tajani welcomed members in the meeting and briefed the agenda. Which was;

#### **Meeting of KW&SB Sub-Committee**

The policy of submitting request for new water connection should also be through ABAD in order to stream line the whole process.

Another meeting of the Sub-Committee was held on 7th January at ABAD. Syed Altaf Hussain, Convener of the Sub-Committee welcomed the members in the meeting and briefed the agenda of meeting. Among the agenda points the main was to discuss 'One Window Operations' for KW&SB.

In the meeting Chairman Southern Region ABAD asked about the progress of the Sub-Committee and efforts to resolve the pending issues of members of ABAD. He informed that a number of members have contacted him and informed about their matters related to KW&SB that were not yet resolved.

Then the convener replied that SMS have been sent to all members of ABAD to report their pending issues to ABAD Secretariat, but so far no response received from members. However, few cases have been reported verbally by members, to be taken up by the committee for early resolution in coordination with KW&SB.

He also informed that the meeting of ABAD Delegation was arranged from ABAD Secretariat in the last week of December 2016 but meeting date and time was not confirmed by KW&SB as the MD-KW&SB was out of Country. Date of the next meeting will be coordi-

nated with KW&SB as soon as MD-KW&SB will attend the office.

It was also mutually agreed that issues related to K4 projects should also be discussed in the next meeting with MD KW&SB, as some of the members were facing problems that have their projects near it.

Issues of different members were also discussed regarding excess billing and new connections and water tariffs. It was then suggested that committee shall get the details of KW&SB water tariff and will review the matter of new connection charges and bulk billing charges. It was also suggested the policy of submitting request for new water connection should also be through ABAD in order to stream line the whole process.

Mr. Altaf Tai also suggested that members of ABAD can provide list of Allottees to KW&SB to whom physical possession handed over by the builder after completion of their projects, this will help members in getting water connections easily and KW&SB can easily generate billing revenue from the allottees / residents of completed projects of members.

In the meeting, Senior Vice Chairman Mr. Hassan Bakshi suggested to finalize agenda of the meeting

with KW&SB and includes all proposals and suggestions regarding one window operations, new water connection, Bulk Billing System and Inquiries related to K4 Project.

Syed Altaf Hussain informed that the matter of formation of zone / district wise Committees so that representative of committee can easily get details / complaints of members working in their respective zone / districts, these problems further reported to ABAD for taking proper action in coordination with KW&SB.

#### Meeting with Mr. Zainul Abedin, Mukhtyarkar Karachi EAST at ABAD

A meeting with Mukhtyarkar Karachi EAST, Mr. Zainul Abedin was held at ABAD to discuss the outer development charges (ODC) and subsequent notices duly issued to members of ABAD by Mukhtyarkar Karachi East Office. The Meeting started with recitation from Holy Quran. Mr. Muhammad Hassan Bakshi, Senior Vice Chairman ABAD greeted the guest and thanked him for his time to come on a very short notice.

Mr. Zainul Abedin, Mukhtarkar Karachi, East informed the House that Outer Development Charges was fixed for Rs.520/- per sq.yds but ABAD had raised objection and the D.C.O. cancelled the said notification and rate was not fixed or collected till 2016. However, while meeting with ABAD and with the stake holders the new notification was issued in November, 2016 in which the rate parameter was fixed @Rs.235/- for Societies and Rs.250/- for builders & developers and all stake holders were agreed to pay in accordance with the new notification issued by Commissioner, Karachi.

He added that parameter is applicable to all and further 13% surcharge shall also be levied who are defaulters and not paying the outer development charges and further informed that we brought to the

knowledge to Mr. Muhammad Ayoob, Chairman (S.R) ABAD while visit in his office that we have issued 20 notices whereas, off them 8 builders have paid their outer development charges and the remaining 12 are still in pending.

Mr. Syed Khurshid Alam, Convener, MDA asked about the detail of notification issued by Mukhtarkar and the procedure adopted by his office. Mr. Zainul Abedin said we have issued 20 notices to different builders and developers and a copy of the said notices was also sent to ABAD House for information.

In the meeting, the members also asked about the Committee who currently following the present rate charges @ Rs.250/- per sq.yds. ODC which shall be charged since the layout plan approved and further 13% surcharge shall be applicable, whereas, if the property is in litigation or occupied/encroached, whether the said builder can get relief.

In the meeting different other issues were also discussed concerned to outer development charges. For that Mr. Zainul Abedin replied that we all need to sit together to sort out the problems and try our level best to resolve the issues under the given rules and regulations. It was also discussed that ABAD members

intended to make installments of the actual amount to pay as Outer Development Charges. In that reply Mr. Zainul Abedin said that post dated cheque would be acceptable to the department.

The Senior Vice Chairman ABAD assured that the concerned matters shall be finalized through negotiation and advised Mr. Tabani to prepare a draft in this regard. Mr. Zainul Abedin assured Senior Vice Chairman that he will guide the members in all respect in order to resolve the issues.

Mr. Muhammad Hassan Bakshi also asked the Mukhtyarkar regarding the procedure of release of fund to KDA & execution of development works. Mr. Zainul Abedin said that after receiving the ODC funds have been released to KDA and then Deputy Commissioner is also designated as project director who look after the entire project and process of outer development works and the fund never misused in any way.

At the end, Mr. Muhammad Ayoob appreciated the assurance of cooperation and assistance to members of ABAD for Outer Development Charges. As there was nothing more to discuss, the meeting concluded with a vote of thanks to and from the Chair.

He said that land mafias are fabricating land documents and to squash such activities a forum involving members of ABAD, revenue department, KDA, KMC and water board should be established.

Earlier, addressing the meeting chairman ABAD Mohsin Sheikhani said that we can only flourish with the development of the city and for that a district should be chosen to make it a model district with mutual cooperation of ABAD and the police department. He said that land grabbing cases in Gulistan-e-Jauhar are increases where land mafias are occupying lands on gun point and Bhatta Mafias are attacking offices of our members, who are refusing to pay Bhatta. He acknowledged that law and order are improved in Karachi after aggressive operation of Law Enforcing Agencies other-wise our members were paying Bhatta to mafias silently.

#### Construction industry ailing, thanks to govt apathy

ABAD chairman says high cost of raw materials forcing builders and developers to stop work on ongoing projects

ISLAMABAD: Despite being the backbone of the economy, the construction industry is facing manifold problems mainly due to the government's apathy.

Prices of essential items for the construction industry, including cement and steel beams et are not being controlled by authority's concerned making construction. dearer for people.

According to a conservative figure, construction cost increased by 10 percent during the last year due to rise in cement and steel beams prices. Moreover, prices of imported materials also witnessed an upward trend due to depreciation of the Pakistani rupce.

Not only that but the federal government has also cre-ated confusion by enhancing property valuation haphaz-ardly within a very short peri-od of time and simultaneousthe Federal Board of evenue (FBR) has also cre-id unpresent Revenue (1918) has also cleared unnecessary pressure on the construction sector to squeeze more taxes, forcing builders and developers to

builders and developers to stop their work, an ongoing projects as well as launching new projects.

Talking to Daily Times, Association of Builders and Developers of Pakistan (ABAD) Chairman Mohsin Sheikhani said that the government was blocking the path of the construction industry. The government is not working in the right direction for development of the

construction sector," he said adding; "According to the State Bank of Pakstan and the World Bank, Pakistan is facing shortage of 12 million housing units and almost 0.25 million units are added to this shortage experts as million units are adoed to this shortage every year, as builders and developers of Pakistan could provide 0.15 million housing units against the demand of 0.4 million units. Pakistan needs affordable housing and I firmly believe that builders, under the unitsell of ASAD are

believe that builders, under the umbrella of ABAD, are ready to build affordable housing."

He said that prices of cement and steel beams had increased by more than five and 25 percent, respectively. "Moreover, prices of import-ed construction materials are also increasing due to the

depreciation of the Pak rupee making construction more costly and higher property prices." He said that prices of apartments on an average were also increasing almost by 10 percent due to the increase in raw material

increase in raw material prices.

Dispelling the impression that the federal government has announced an annesty scheme for the construction sector, Mohsin Sheisham saidthat payment of 3 percent extra tax on the difference between the FBR rate and the DC rates was not any kind of amnesty but this new mechanism was introduced for improving revenue collection, which was affected by the suspension of property transfer and registration for almost four months.
