

Muhammad Hassan Bakshi Chairman (SR) nominated as focal person on behalf of ABAD.

In the meeting Administrator Karachi ordered to review KMC rates and formed a committee comprising of ABAD members and KMC defunct KDA officials on request of ABAD and appreciating the role of Association he said that construction industry is the back bone of economy of the country

whereas the ownership will remain the Government. with Administrator asked the delegation to submit a proposal. Administrator Karachi told that he has revoked previous order of the outgoing Administrator whereby files of over 600 sq. yards. Plots were sent to the Administrator for approval. He categorically instructed when the formalities are complete then there is no need to send the file to the administrator for initial as results wastage of time.

Some members of ABAD informed about the problem of encroachment and illegal construction on their lands. Junaid Ashraf Taloo Chairman ABAD appreciated the efforts of Administrator Karachi, Sindh Government and law enforcement Agencies for the removal of encroachment in different area of Karachi.





URBANIZATION

and its Impacts on Enviro

Human beings like other organisms, have always polluted their environment with the byproducts of their action and we all know that as an organism man creates waste. As a social creature, he removes things from his environment and adds residue to it. So long as population density has been low on the planet, the environment was able to accommodate these alterations. Now with the world population about 8 billion people and increasing by 220,000 each day, the concentration of population in cities and resulting deterioration of environment is sounding alarms. Consequently the situation is urban Pakistan is worst.

The process of economic development over last 6 decades has brought number of changes. One of the most critical dimensions of the process is urbanization of rural society. As the development has taken place primarily from agricultural to industrial economy, large scale rural to urban migration has taken place, changing the face of our cities as well as villages. The concentration of more and more people into urban areas is regarded as one of the major environmental threat today. The process is expected to escalate in Pakistan though many of our cities have already reached the point where further population concentration (by natural birth or migration) may jeopardize the delivery of basic civic services to all.

Urbanization process has affected all parts of country: villages, towns and cities in one-way or the other. The intensity of impact is most critical in the larger cities. Karachi, Lahore, Faisalabad, Gujranwala, Multan, Rawalpindi, Hyderabad, Sarghoda and Peshawar are suffering from environmental

degradation and quantifiable deficiencies in basic civic services. The civic bodies are badly failing to manage these problems.

Solid waste management has become one of the serious urban nightmares in Pakistan. The municipalities equipped with centuries old and outdated methods inefficiently lift only 60 percent of the municipal waste generated in our cities. In the absence of professionalism and proper waste disposal systems, most of the garbage lifted from the cities is crudely dumped in open spaces nearby. These dumps attract mosquitoes, rats, cockroaches,

houseflies, ticks flees as well as stray dogs and birds like vultures and crows.

One major problems of urbanization in Pakistan is the eating up of green and open spaces - so important for ecological balance - by concrete structures of ever expanding cities.

Carried by the vectors, bacterium thriving in rotten and moist garbage is spreading all sorts of diseases. Other 40 percent waste is simply not picked up and keeps rotting in streets or illegal filth depots inside the cities. As the society prospers, its trash - mainly hazardous plastic, metals packaging and pathogenic non-biodegradable rubbish - is growing exponentially.

Karachi the mega city with population estimated over 11 million, alone is generating 6000 tons of waste per day. Solid waste management department of Karachi Metropolitan Corporation is trying to keep the city clean with fleet of vehicles and an army of sweepers in its roll.

Sewerage systems only in portions of the cities are crumbling. Apart from being old they were basically designed for lesser population without catering for the future growth. Remaining population depends for waste disposal on septic tanks, soak pits or over flows into open drain. As a result of improper disposal of human waste (in many areas there is no disposal) from the housing environment a large number of children are suffering from or are vulnerable to the attacks of different diseases. The effluents from industrial units and tanneries working unchecked in the residential areas - with high concentration of pollutants are adding to the problems. Kasur, Multan and Sialkot are typical examples of the case in point. One major problems of urbanization in Pakistan is the eating up of green and open spaces - so important for ecological balance - by concrete structures of ever expanding cities. Only 25 years back Karachi, Lahore and Faislabad had several

patches of agricultural land. Today, there is no arable land within the limits of these cities. In Peshawar 2700 hectares of agricultural land were lost since last four decades. Multan had many mango orchards inside the city. They all have been converted into plazas and industrial units

The fresh water supply in our cities is dwindling as the cities are expanding. Access to the clean water is available to about 77 percent of the urban population. Only 30 percent have the luxury of piped water supply and the rest are being served by stand posts or public taps. Per capita water consumption in urban areas in bare minimum to sustain human life. Even the subsoil water reserves are decreasing due to high pumping rate. In most of the cities water pipe lines run next to the sewer lines there for, contaminating the drinking water.

Air governs the quality of our environment. The air in our cities is so polluted that it can be smelled and seen everywhere. When the wind is still, the fumes of vehicles, industrial concerns, smoke from garbage piles put on fire as well as airborne particles of dirt and pollen can be seen hung about any city. Only in Karachi 900,000 vehicles are responsible for contaminating the environment by emitting poisonous gasses. Breathing has become a health hazard in soot-choked cities, where tar coal drums, electric wires and old tyres are burnt inside the residential areas in order to separate the iron.

There is an acute shortage of houses in the cities and the real estate prices are skyrocketing. The demand for the land is growing and the supply is limited. Since the land is essential for urban growth, devising equitable and efficient land development policies is one of the major challenges facing planners and policy makers, who do not seem to be aware of the seriousness of the problem. The number of slum and katchi abadi dwellers is on the increase.

Historic buildings disappear without regret and even the protected monuments are suffering from vandalism. The roads are full of illegal speed breakers, all different in sizes and shapes. The old trees are being cut without a second thought. There is no body to oversee the overall growth of cities and to coordinate the work of city development agencies.

It is ideal if the human beings are dispersed evenly around the countryside. But people have been coming to cities for better economic and educational opportunities and better quality of life. It is the time that policy makers should think hard and plant to check the current demographic trend. This can be done, though it has yet not started to begin in Pakistan. This is one of the reasons why one can believe that future lies in rural areas.



Visit of ABAD Delegation to 23rd Turkey World-Trade Bridge **Exhibition**






The exhibition has not only provided a platform for Pakistan business community to have interaction with the world popular firm but it also increased the economic relation between Pakistan and Turkey.

Pakistan for different joint ventures. ABAD members were also offered by some Turkish developers to have development business in Turkey on 50/50 partnership.

Turkey is a very old country where most of the land belongs to private parties. The norm of business is that the land owner provides land as his equity and the developer constructs the building. Half of the constructed flats are given to the land owner and the balance half is for developer to cover his cost and profit.

Some private investors are ready to offer their land to ABAD members on the same formula. There is a



big market of buyer of constructed flats some of them are local Turkish people, others are from European, Middle Eastern Countries and some buyers are from Asian Countries also.

The construction process in turkey is much mechanized and usually a building of 500000 sq. feet is completed within 12 months. The cost of construction varies from four to six thousand Pakistani Rupees per sq. feet. The selling price is around fourteen to sixteen thousand rupees per sq. feet. There are good margins in construction business. Furthermore there are no questions asked on investment in Turkey. Here it may be pointed out that Turkish contractors are one of the best in the world and are playing important role in the development of Middle East and Eastern Europe. During the trip the delegation further came to know that some Pakistani developers are already successfully doing commercial and residential projects in Turkey.

During the trip four dinners were organized by Turkish companies in honour of ABAD delegation where the ABAD members were introduced to different business groups. Souvenirs were presented by delegation members to host companies.

Apart from business meetings, attending the Expo

and visiting under construction buildings and various factories, ABAD delegation also visited many places of historic importance some of them are Top Kapi Museum, Blue Mosque, Bosphorous Cruise and Grand Bazar. Rate of taxes and prices of building materials should reasonably be reduced in order to provide support to the development of construction sector in Pakistan, said Chairman ABAD.

Association of Builders and Developers of Pakistan held a media briefing at ABAD to give the budget proposals to the federal and provincial governments. The event was headed by Chairman ABAD Mr. Junaid Ashraf Taloo, Vice Chairman Mohammad M. Hanif Memon, Chairman Southern Region Mohammad Hassan Bakshi and Convener Budget Sub-Committee M. Saleem Kassim Patel.

construction companies to import steel products and steel bars without any regulatory duty. He added that duties on construction machinery should also be reduced and brought to 20% so that construction cost is reduced. New and used construction machinery that included tower cranes, batching plants, earthmoving machinery, forklifts, shovels etc. are very useful in the construction processes.

The proceedings started with the recitation from Holy Quran. Then Vice-Chairman M. Hanif Memon



greeted the members and guests from media and also briefly discussed the agenda of media briefing. Expressing his views regarding taxes on building materials he said the Government has imposed 5% regulatory duty on steel billets, which has resulted in increase in prices of steel products including steel bars. It is pertinent that Government should abolish this regulatory duty or it should allow builders and

M. Saleem Kassim Patel, former Senior Vice Chairman and Convener ABAD Budget Sub-committee expressed his concerns in a proficient manner and through light on the dark sides of our construction sector. Started with focusing the housing finance he said revolutionary steps should be initiated in the Federal Budget to increase Housing Finance. In order to provide momentum to construction of low cost housing units, the finance should be made available on low markup. In addition to this Government should also provide compensation for construction of low cost housing. He added that ratio of mortgage finance to GDP is lowest in Pakistan which is just 0.66 percent. The Federal Finance Minister has already announced the formation of a Housing Mortgage Re-finance Company. It is essential that Federal Budget should include further incentives for this purpose. The loan taken by individual allottees for paying installments should be considered as expenses in their accounts. The financial institutions should be





encouraged to issue loans on a markup, which is less than the market rates. Steps should be taken to increase the Mortgage to GDP ratio to 5%. It should be made mandatory for commercial banks and financial institutions to reserve a minimum of 5% of their portfolio for housing finance.



After that Chairman ABAD Juanid Ashraf Taloo addressed the gathering and highlighted some major points from the proposal. He said that Federal Government should act upon the proposals of ABAD about reduction in taxes imposed on construction industry and building materials. A high rate on taxes and high prices of construction material shattered the dream of a common person for a house of his own. He added that increase in construction activities

also resulted in the revival of the national economy as over one hundred allied industries benefit from this. Resultantly the government also receives sizeable revenue generated through construction activities. Over 120 million people are getting job opportunities

directly or indirectly through the construction industry. The Chairman informed the media that ABAD is practically involved in the Prime Minister's Vision 2025 for housing according to which 500,000 housing will



be built annually. The overall shortage of housing units has reached 8.8 million and in order to bridge this gap it is essential that incentives be offered including reduction in taxes. Chairman ABAD said last year the decrease in

production cost should have resulted in decrease in prices of cement but regrettably, this did not happen. This relief was not passed on to the common people of Pakistan. The Government has to take prompt and drastic steps to reduce construction cost.



Chairman Southern Region Mohammad Hassan Bakshi said that no taxes should be imposed on first time buyers. The total cost of any residential should be assessed and the relevant income tax should be charged in three annual installments and this should be considered as final liability. The turnover should be increased from five crores to 10 crores for taxation purpose. Stamp duties and registration fees should be reduced and brought to 1%, which will help in

> increasing documentation, which will increase revenue generation for the Government. The Government should also abolish charges on housing mortgage, stamp duty and registration fees etc. All banks and financial

institutions should be given directives to provide loans on machinery used in construction on BMR basis. He added that in the upcoming budget, government should provide incentives on financing for construction of housing units. At the end discussing the issue of gas he further said in Sindh, including Karachi and Hyderabad a moratorium of gas connections is imposed since 2011. The total consumption for these connections is less than one MMCFD, which makes it important that the ban on gas connections is lifted without any further delay. He then thanked all the guests and members for their valuable time.

POST BUDGET

Press Conference at ABAD

We appreciate Federal Finance Minister Mr. Ishaq Dar for taking positive steps for Construction Industry, Junaid Ashraf Taloo – Chairman ABAD



A media briefing after the Federal Budget was held at ABAD to discuss the prospects of announced budget. The program started with the recitation from Holy Quran. After that addressing the Conference Mr. Junaid Ashraf Taloo, Chairman ABAD said that for the first time importance of Construction Industry has been recognized and 10% of proposal sent by ABAD for Federal Budget 2015-16 has been accepted. He added that if our proposals would have been accepted in total, it would have reduced the Housing Cost by 15% and increase in Revenue Collection of Government.

Junaid Ashraf Taloo appreciated the Federal Finance Minister Ishaq Dar for taking some positive steps for Construction Industry. He said that few automatic Re-Rolling Mills have the Monopoly and selling the Steel Bars at a much higher rate. In the Local Market Steel Bars are being sold through Cartellization at the rate of Rs.85,000 per ton. He then appealed to the Government to allow import of Steel Bars to the Members of Association of Builders & Developers directly resultantly common man will be benefitted.

After that M. Saleem Kassim Patel, former senior vice chairman ABAD said that federal Excise Duty on sale of Cement may be abolished. ABAD proposed that Sales Tax on Cement to be charged Ex-Factory rate instead of the market rate. Cement is exported at less than the market price, whereas in India 50 KGs

of Cement Bag is availabe in Rs. 350/- in Pak Currency. He urged the Government to establish Mortagage Finance Board to boost the Housing Sector so that the shortage of 80 Lacs houses is minimzed. The Government has to provide discount in Mortagage Financing and the Markup should be decrease to 4% or 5%, it will improve the purchasing power of common man. He also demanded to lift the ban on Gas Connection and further said that first phase of Motorway M-9 to be started from Karachi instead of Hyderabad.

Discussing other issues Zaigham Mehmood Rizvi, Housing Expert also addressed the gathering. Focusing on contemporary water shortage he said that the Federal Government must allocate funds for K-4 Water Project to solve the water problem of Karachi. Added that Provincial Services Sales Tax on Builders to be abolished being builder not service provider and on the other hand markup on Housing Finance to be fixed at 3% only.

Concluding the gathering Regional Chairman Mr. Hassan Bakshi said that in Islamabad Capital Development Authrotity (CDA) is not providing infrastructure on plots purchased in auction and further CDA is also not issuing approval for construction resultantly Billion of Rupees of Builder and Developer are stuck up for long periods.

MEETING WITH

The Delegation of JICA at ABAD HOUSE

A Japanese Delegation of Japan International Co-Operation Agency (JICA) held a meeting with office bearer of Association of Builders & Developers (ABAD) at ABAD House. The purpose of visit was to discuss on the issue of energy conservation in Pakistan. The delegate consists of Hideaki Kuroki and Satoshi Kohno along with Choudry Muhammad Ilyas Interpreter. From ABAD, Chairman Junaid Ashraf Taloo, Chairman Southern Region Muhammad Hassan Bakshi and Muhammad Hanif Memon Vice Chairman along with other senior members attended the meeting.

Hideaki Kuroki head of the delegate explained that Pakistan has the structural problems in the power sectors, which included high power generation, high ratio of power transmission and distribution losses in efficient operation and inappropriate governance. Due to such problems Pakistan faces the gap between supply and demand of electricity.

Junaid Ashraf Taloo Chairman ABAD appreciated the concerns of JICA regarding housing and construction sector of Pakistan. He then informed the delegates about shortage of power in the country

and governments efforts to overcome the crisis as soon as possible. He also highlighted to the delegate the importance of construction industry in the economic development of Pakistan.

In replying to a question from JICA, Muhammad Hassan Bakshi Chairman Southern Region discussed that there is no survey of buildings in Pakistan. Hence it is also not possible to speculate numbers of buildings constructed till date. He also informed the delegate that construction in Pakistan is 22 US Dollar per Sq. ft. in comparison to India and UAE where it is 45 US Dollar and 65 US Dollar respectively.

Focusing on the issues of lighting in the projects, Muhammad Hanif Memon Vice Chairman said that there is no lighting and ventilation problems due to moderate climate in Karachi, buildings are constructed keeping in view the weather condition of Karachi city.

At the end, the delegate also visited some projects of ABAD members that are under construction for their survey purposes.



SEMINAR AND STUDY LAUNCH

Low Income Housing through Market: Prospects, Policy & Strategy

ABAD is ready to build 4-5 marla houses for low income at around Rs. 1 million, Mr. Arif Jeeva, Member ABAD

Low income housing is not only a basic social need but also a stimulus to the economic development of a country. Despite being such an important agent of economic growth it is the least discussed area in socio-economic advancement in Pakistan. Recently, Policy Research Institute of Market Economy (PRIME),



launched a study conducted by Mr. Shahid Mehmood titled "Low Income Housing through Markets: Prospects, Policy and Strategy" at a seminar in Islamabad

Dr. Almut Besold, resident representative of Friedrich Naumann Foundation for Freedom, welcomed the guest speakers and participants in the Seminar. According to this study, the gap between supply and demand of housing is approximately 9 million units, continuously increasing by an estimated 0.7 million units per year. Furthermore the situation is adverse in urban areas due to rural urban migration. The study identified the inability of the people from low income strata to own assets preventing them from securing loans and thus making the construction of their house extremely difficult. Based on his study, Mr. Shahid recommends that the government should work in tandem with the private sector and redefine its role in provision of low income housing; it should also develop primary and secondary mortgage market to develop innovative financing methods. Upon commenting on the impact of improved housing, he said that globally construction and housing are seen as GDP enhancing activities and also create both short term and long term employment.

Addressing the seminar, Muhammad Irfan, Director General National Housing Authority and focal person of Prime Minister's Low Income Housing Programme highlighted various policy measures that the government is undertaking to expand housing access of the low income segments.

Deputy Governor State Bank of Pakistan (SBP) Mr. Saeed Ahmad, congratulated PRIME Institute and Mr. Shahid Mehmood on launching of this study. In his message, he said that construction and housing sectors have forward and backward linkages with almost 40-50 industries and a large percentage of the unskilled labor is linked with this sector. Resultantly, an increase in spending towards this sector has a multiplier effect and capacity to generate earnings as high as five times of the expenditure incurred. Furthermore he shed light on some of the initiatives taken by SBP including issuance of Prudential Regulations for housing finance and the incorporation of Mortgage Refinance Company (MRC).



While commenting on the study Mr. Zaigham. M Rizvi, Secretary General Asia-Pacific Union for Housina Finance & Former Chairman HBFC. highlighted the usage of low cost housing in political sloganeering and said that the last aovernment of Pakistan

Peoples' Party (PPP) and the current government of Pakistan Muslim League Nawaz announced their own low cost housing programs. The previous government promised to build one million low-cost houses whereas the present one promised to build 500,000 but unfortunately both the programs failed to achieve the set targets. Furthermore he also discussed the low-cost housing statistics and said that Pakistan is one of the very few countries where housing finance is gradually on the decline. This is evident from the fact that the Outstanding Mortgage Debt to GDP ratio in Pakistan has declined from 1.0 % a few years ago to around 0.5% presently.

Sharing his comments, Mr. Arif Jeewa, representative of Association of Builders and Developers (ABAD) from Islamabad region, congratulated PRIME Institute for undertaking this initiative. Arif Jeewa shared private sector proposal for the PM Low Income Housing program. According to him, ABAD is ready to build 4-5 marla houses for low income at around Rs. 1 million, including the cost of land, as long as the government can provide trunk infrastructure and utilities.

Addressing the seminar, Dr. Zahid Asahar said that there has been over focus on private sector engagement but without due focus on changing



zoning laws which are main hurdle for not attracting private sector investment in construction sector. Dr. Asahar favoured mixed zoning, combining commercial and residential activities. He also proposed a ban on new housing societies unless existing housing

societies reach a minimum density standard of around 1500-2000 people per hectare.

According to estimates by a low income housing entrepreneur, Jawad Aslam, 68% of Pakistan's population has only 1% of total housing stocks whereas 56% of housing stock is meant for 12% of upper income segments. There appears to a huge untapped market and unmet demand for housing units in the urban areas particularly for the low and lower-middle income segment.

Executive Director PRIME, Mr. Ali Salman highlighted the current policy towards housing which is focused on horizontal expansion of cities, rigid zoning laws in urban areas, restrictions on building heights and high mortgage costs. According to him, this has led to a manifold escalation in real estate prices which has negatively affected the construction of low cost houses. He was of the opinion that the government should ban on development of empty plots either by itself or by the private sector, heavily penalize ownership of more than one house and relax building height limits. These three steps will at once eliminate speculation and deflate property prices - thus developing housing market for the two-third of Pakistan's population.






CONFERENCE ON

MEETINGS OF SUB-COMMITTEES OF ABAD

K-ELECTRIC / SSGC SUB-COMMITTEE

The Sub-committee kept in regular contact with K-Electric and SSGC for the resolution of issues of members of ABAD. The committee held regular meetings to discuss and decide the course of action to be followed with these two organizations so the issues of members may be resolved.

Due to consistent hard working and dedication of the Convener - Mr. Rizwan Adhia with his Co-Conveners Mr. Mustafa Sheikhani and Mr. Favvaz Ilyas and all committee members and especially because of the sincere devotion of the office bearers of ABAD towards this issue the government has announced to release the gas connections to the buildings / projects up to the height of 115 feet / 35 meters. This is another feather in the cap of ABAD that after more than 3 years of complete ban on the gas connections of high-rise now the authorities have realized the importance of this matter.

In this connection a meeting was also held with Director General SBCA regarding the issue of highrise buildings – its definition and further explanations. In the meeting after fruitful discussions it was also assured by the DG SBCA that the buildings having

height up to Ground+20 would be considered as highrise and it soon should be agreed upon by the concerned authorities.

The issues from the builders developers Hyderabad Region were also resolved by the Sub-Committee. The Committee also held meetings with Managina Director SSGC in which issues of the members were discussed

The Convener is also very active with the K-Electric and a number of issues have been discussed durina meetings with high officials and soon be resolved. In this regard different meetings were held with high officials of K-Electric and the issues discussed mainly were new policy for T/L connections and Bank Guarantee with some relaxations to the builders and developers.

LAW AND ORDER SUB-COMMITTEE

The law and order subcommittee of ABAD held a number of meetings with the officials of law enforcement agencies and to discuss the issues of ABAD members.

The Association of Builders and Developers of Pakistan (ABAD) has constituted ABAD Police Ligison Committee (APLC) to deal with the cases of fraud, theft, kidnapping, land arabbina and encroachment. An order on

the directive of I.G Sindh Police has been issued.

The APIC will be functional round the clock, A 24 hours functional control room will be created and a mobile will be procured to facilitate the operation. The term of reference of APCL would be to effectively deal with all crimes such as deceptions, adverse law and order situation, threats of life to builders, demand of bhatta, car snatching and encroachment on the lands of builders. All actions taken by this committee will have the necessary legal cover.

A very active and prominent member of ABAD, Mr. Asif Sumsum has been announced as Chief APLC. while the Inspector General Sindh Police as the chairman and Additional IG Police Karachi and Former Chairman ABAD Mr. Mohsin Sheikhani are the Vice Chairman of the APLC. All the DIGPs are the member of APIC.

APLC is an independent institution. A 24-hour control room equipped with wireless system and mobiles will be established in ABAD soon to attend to the complaints of members.

ANTI-ENCROACHMENTS CELL OF ABAD

Informing the members the convener said that, Anti-**Encroachment Cell of ABAD** has carried out the operations in different areas like Surjani Town, Scheme 33, Gulistan-e-Johar etc with the help of Anti-Encroachment

Cell of Government of Sindh and Commissioner Karachi as per the directions of Chief Minister of Sindh. From ABAD the Anti-Encroachment operations were supervised by Mr. Muhammad Sohail Warind who is working as Convener in the Anti-Encroachment Cell of ABAD and Mr. Zubair Esani as

Co-Convener.

It was a remarkable effort by Muhammad Sohail Warind, who is also serving as Associate member of Central Zone in CPLC. Head of Task Force in ACLC and Deputy Chief Coordinator in APLC. In this connection encroachments were removed from the below mentioned areas:

- Encroachment removed from 200 Acres land in Sector 35-A, Scheme 33.
- Encroachment removed from FL-2, Sector 18-C. Corridor Scheme 33.

It was really a great achievement of antiencroachment cell of ABAD as in result the properties were restored form the illegal occupation that worth billions of rupees.

REDUCTION IN CEMENT PRICES FOR THE MEMBERS OF ABAD

Cement is among the most important products used in the construction and building industries. In our country there are a number of industries that produces different kinds of cement products used for the construction processes. As it is among the main requirements for building industry so the fluctuation of its prices also affected the aver-all cost of the projects.

We have already witnessed the price hike in this product for last so many years that also affected the general public in terms of paying high prices for their booked properties. In this regards, the Office Bearers of ABAD have worked a lot with their team to low down the price of this essential commodity.

After constant efforts and dedication of all the Office Bearer and especially due to the sheer devotion of Mr. Mustafa Sheikhani - Co-Convener of Allied Industries Sub-Committees of ABAD, a special discount of 50 rupees on each cement bag was achieved. Surely it is a very prominent accomplishment and considered another feather in the cap of ABAD that all the ABAD members got this much discount on it.

It is also noted that since that discount approx. 34 thousand tons of cement have been purchased from different

MEETING OF CANTONMENT BOARDS SUB-COMMITTEE

The meeting started with the expression of thanks from the convener Mr. M. Arif Siddik to the members who attended the meeting. He said that issues pertaining to cantonment boards have increased and we have been accorded a cold shoulder by DML&C. We have been trying our level best but were not able to

Convener informed the meeting that during the visit of Director General ML&C to Karachi an approach was made and a delegation of ABAD was given a time. Director General gave instructions that issues of ABAD to resolve but no movement have been seen by DM&LC. Some issues of our members were taken up but only through traditional means. He added that we have a good rapport with the CEO's of various cantonments. Mr. Shahrome Khattak has good influence on DML&C. We have requested him to narrow the rift between ABAD and DML&C. He also informed the house that the current DML&C have been promoted. The new Director will be in place soon. Similarly, two Cantonment Executive Officers have also been changed. Projects of our members are being delayed unless traditional wavs are used and in result working with cantonments is getting difficult.

Mr. Mohammad Hassan Bakshi said to finalize the new byelaws ABAD should be taken on board. Mr. Arif Siddik said that as I have informed earlier, we have been given a cold shoulder. There is no interest shown by the relevant authorities. Any objection raised on our member puts down the project by two months. Chairman ABAD Mr. Junaid Ashraf Taloo said that Director General had given clear instructions to Director to take ABAD on board on relevant matters, monthly meetings should be held, we have discussed that a timeframe of sixty days should be fixed but it has not been implemented. We should send a letter to DG ML&C that his instructions are not being followed.

MEETING OF SHELTER AND PUBLICATION SUB-COMMITTEE

The meeting of Shelter and Publication Subcommittee was held to discuss certain issues like printing strategy of Magazine, problems related to advertisement and their recovery, changing in the format of magazine and proportion of content and advertisement printed in the magazine. The meeting was chaired by Convener – Engineer Zaheer Qadri. In the meeting he briefed the members about problems confronted in the printing and publishing of magazine. The Convener informed the Regional Chairman about the previous meetings of this committee held in his absence. He then suggested that ABAD can print the magazine on its own as the House has already been taken enough amounts from its registered members in the account of this magazine.

A member also seconded the suggestion and said that we have already received some quotations regarding the printing and publishing so from them we have to find a better and reasonable person for our work. During the meeting suggestions were also given regarding the material selection of the magazine.

Other issues regarding advertisement and there recovery were also discussed in the meeting. Some suggested that members should cooperate in this matter and try to

manage advertisement from allied industry.

Discussing the content of magazine it was mutually agreed that reports and news related to latest construction technologies and machineries should be on focus in the magazine.

JOINT MEETING OF CEC AND REC

Joint Meetings of CEC and REC were held on 23rd May and 27 June. Chairman ABAD Mr. Junaid Ashraf Taloo chaired the meetings with other office bearers. Started with the recitation from Holy Quran the agenda items were followed one by one. Discussing the proposals to FBR Chairman informed the house that two opinions have emerged on the subject of imposition of income tax. First opinion is that tax should be imposed on construction area on square foot basis and the second opinion is that tax should be imposed on percentage basis on the annual turnover. Main reason for not recommending the tax on square foot basis is that there is no surety if the rate of tax stays fixed. He also informed that we have to submit the proposals as soon as possible so, will take a decision in this meeting. After that different suggestions were made and after much discussion it was at large agreed that income tax should be collected on square feet basis.

Then membership cases were presented before the house some of them were approved completely while some were conditionally. In the meeting the Chairman also informed about the meeting with Director General Sindh Building Control Authority. He added that in the meeting issue of builders' license without membership of ABAD was very elaborately discussed with DG. He was informed that a number of builders' licenses were issued by SBCA without the mandatory requirement of ABAD membership. Then the DG instructed the officials to cancel their Builders' Licenses with immediate effect.

On the issue of definition of high-rise buildings, Chairman ABAD informed the house that SSGC has lifted the ban on G+10 floors. The house applauded the efforts of the office bearers. Chairman ABAD Mr. Junaid Ashraf Taloo said the previous office bearers and Mr. Rizwan Adhia had a very important role to play in this achievement. We also kept a very tight grip on the issue and followed the guideline set by the previous office bearers. Chairman also informed the decision has been made by the Board of Directors of SSGC. Mr. Rizwan Adhia said a letter from MD SSGC had defended our stance. We had discussed with DG SBCA and requested him to declare that G+20 habitable floors should be removed from the ban.

The Chairman also informed the house that KMC has increased rates of various fees. Chairman said that when we ask for favours we have to give also. We agreed that a 10% increase on all fees is acceptable. We have sent our proposals on KMC rates.

Chairman Southern Region Mohammad Hassan Bakshi said a delegation of ABAD would proceed to Turkey to attend an exhibition being held in Istanbul. It may be noted that all expenses with regard to this trip are to be borne by the member. It is expected that around twenty five members from both ABAD regions will participate. He also invited that if any more members want to participate should give their names provided if they have Visa for USA, Schengen countries or UK. And a total expense of US\$ 1500 is expected.

Discussing the issues of land grabbing a member said Land Grabbing is being carrying out with the collusion of Police. Chairman said that we are receiving letters of appreciation from members whose problems have been addressed. Recently SHO was suspended due to his collaboration with land grabbers. We have a good liaison with all Law Enforcement Agencies and they always respond to our requests. The members also paid tributes to Mr. Sohail Warind for doing a very good job.

In the meeting keeping in view the extreme and tragic situation of Karachi the issue of heat stroke was also discussed. Regional Chairman said it would be good if we donate some amount to the victims. Chairman ABAD said anybody who wants to make a donation should contact ABAD Secretariat. A member suggested that we should invite DG Rangers and donate to the Sindh Rangers. In reply to this Chairman said the Rangers have surplus of kind and cash at each camp. He suggested we might contact major hospitals and donate to them. Mr. Haris Ali Mithani suggested that we should also look into the availability of cold storage. Now, regrettably, misuse has started. Fear is also a main factor, which has created a panic. Village culture is reason that 10-12 people accompany one patient. It will be good if we adopt a ward in Civil Hospital. We should also make a visit to find a deserving hospital. Members suggested that a special Disaster Management Committee under Mr. Haris Mithani should be formed.

MEETING OF UPDATING BUILDING BYE-LAWS SUB-COMMITTEE

The meeting started with the recitation from Holy Quran. It was called to discuss the issues of updating building bye-laws. It was chaired by the Regional Chairman South Muhammad Hassan Bakshi with the Convener of Sub-Committee Mr. Sohail Naviwala.

In the meeting number of issues was discussed. The issues of violation and updating the bye-laws were the main. Members suggested that bye-laws should be made friendly so that every person can follow them and as a result no one will go towards any violation

Expressing the personal opinions members said that it was also observed that sometimes they were restricted indecently due to those bye-laws. So, byelaws should be amended time to time considering the different situations of our environment.

In the meeting it was mutually decided that members should raise the voice for their rights and for this the platform of ABAD would be the best. High authorities and dignitaries should be invited at ABAD to discuss these issues. It was also decided in the meeting that by following the rules and regulations members should contribute in maintaining peace and prosperity of the city. Members suggested that high density zones should be made clear and highlighted so that builders will know about the actual position and feasibility of the project.

It was also mutually agreed that ABAD should take part in making policies for all the members not take up the individual cases until it is very necessary. It was also agreed that building ratio is not as important as the open spaces in the buildings are more important. At the end it was also decided that builders should make themselves clear in all issues so that they cannot be forced to do any illegal activity.

MEETING OF HBFCL SUB-COMMITTEE

The meeting was called to discuss certain issues regarding HBFCL. It was chaired by the Convener of the sub-committee, Mr. Hanif Memon. The meeting started with the recitation from Holy Quran after that convener informed the members about the agenda of meeting.

In the meeting the members discussed their issues with the Company. In the meeting the issue of project processing fees was discussed. At present this fee is charged from both, the builder and the client, which is unjustified. ABAD suggests that the fee be charged from either and not from both. Another issue was policy file, it was mutually suggested that it should

be approved in one go operation and should be approved within 30 days' time.

Discussing the issue of financing, the members suggested that block wise financing be restarted as it was in practice prior to 2009. In the meeting the issue of bulk loaning was also discussed and suggested that bulk loaning facility should only be

given to the builders registered with ABAD.

The members were received by Mr. Ghulam Hussain Memon – a very senior member from Hyderabad Region and a number of current members at Royal Banquet Hall, Hyderabad. In this meeting lunch was also organized for all members of delegation by the organizers.

The meeting started with the recitation from Holy Quran, after that the builders from Hyderabad introduced themselves to delegation of ABAD. The meeting was attended by large numbers of members from Hyderabad Region. After the introduction, builders from Hyderabad stated that they had problems with different authorities and utility organizations. Builders also mentioned their individual complaints and issues with various departments in Hyderabad.

A number of builders stated that they wish to become a member of ABAD. 


