



# Empower the investors

The year 2019 was like a roller coaster ride for the construction industry as whole with many challenges and check-lists at hand for economic planners and stake holders, to accomplish. The economic situation of the country, as projected by global institutions, hasn't been at its best. The Asian Development Bank has predicted that the economic growth rate in Pakistan will be 2.8% and the inflation rate will be 12% the highest in the block of eight nations in this fiscal year, 2019-20. It is high time that the government must support local investors, particularly the construction sector that has been a major contributor to the national economy, to effectively address prevailing economic challenges. The national economy has full potential to recover on its own, provided that right and judicious decisions are taken keeping in view the recommendations of all stake holders who are serving the country with sheer passion and patriotism.

ABAD is registered under the Companies Ordinance, 1984 with Registration No. KAR No. 4967 of 1977-78

and licensed under Trade Organizations Ordinance, 2007 and it's affiliated with the Federation of Pakistan Chamber of commerce and Industry (FPCCI).

Today, ABAD has in its fold more than 1,000 leading construction companies of the country. Most of its members' offices are equipped with up-to-date systems of designing, cost control, project management

The Chairman & Sr. Vice Chairman is elected among Full / Ordinary members and the Vice Chairman from Associate Members and One Chairman each from its two respective.

the Federal Budget.

In the provincial capital of Sindh, ABAD has played a pivotal role in procurement of land for its members and also for the issuance of no objection to them by Karachi Development Authority. Other achievements of ABAD include increasing the covered area of flats, fixation of the selling price of housing units, inclusion of a provision of escalation, simplification of the procedure for the permission to mortgage and registration of leases, increase in the period of completion and streamlining of documentation procedures regularly. Although there is a pressing requirement for houses in the city yet on account of non-availability of infrastructure and other amenities, some schemes cannot be developed due to scarcity, efforts to remove these bottlenecks are continuing on all possible levels.

As a socially responsible organization in addition to the above core functions ABAD also extends donations and other kinds of support to deserving institutions and welfare organizations. A safe shelter to live in is recognized the world over as a fundamental human right and that is the vision behind ABAD's efforts and ventures.




Mr. Mohsin Sheikhani Chairman ABAD








Dr. Talha Farooqui




Mr. Sohail Naviwala






Mr. Rameez Qasim Gaziani



The names of newly-elected office-bearers of ABAD for the term 2019-20 were announced in the AGM; the meeting also approved concept and plan for setting up ABAD Foundation; while the outgoing office-bearers recounted their achievements



The Association of Builders and Developers of Pakistan (ABAD) pursues democratic course in holding elections every year to elect new body of office-bearers. The procedure to choose by ballot new members is conducted in a transparent manner and this practice is religiously adhered for years.

The Annual General Body Meeting (AGM) is a significant event of ABAD that is held every year, at the culmination of tenure of the outgoing office-bearers. The AGM for the tenure 2018-19 was held on September 30, 2019 (Monday) and was presided over by outgoing Chairman Mr. Muhammad Hassan Bakshi. The meeting was convened to approve various items on the agenda including approval of expenses incurred on ABAD House

Shortly after recitation from the Holy Quran and offering of Fateha for the departed souls, the results for the election for the Central Executive Committee (CEC) and Regional Executive Committee (REC) for the term 2019–20 were announced.

Thereafter, the newly-elected CEC and REC members were called out for oath-taking ceremony. Senior member ABAD Mr. Abdul Majeed Adhia administered oath to the newly elected members.

In the CEC oath-taking, Mr. Mohsin Sheikhani

was unanimously elected as Chairman ABAD, while Mr. Sohail Warrind was elected Senior Vice Chairman and Mr. Abdul Rehman as Vice Chairman.

Later in the oath-taking of REC, Mr. Muhammad Ali Ratadia was unanimously elected as Chairman Southern Region (SR), Mr. Faisal Moosa Memon as Vice Chairman Hyderabad Sub-Region. Meanwhile, Engr. Akbar Shaikh was elected as Chairman Northern Region (NR) by their members through voting in Lahore.

Outgoing chairman Mr. Hassan Bakshi, Senior Vice Chairman Mr. Anwar Dawood, Vice Chairman Mr. Abdul Kareem Adhia, Chairman SR Mr. Ibrahim S. Habib, and Vice Chairman Hyderabad Sub-Region Mr. Raheel Iqbal were also present on the occasion.

Shortly afterwards, Mr. Noman Tabani, the convener of FBR Sub-Committee of ABAD, presented audited accounts for the year 2018-19, which were approved after a brief discussion.

## Discussion on ABAD Foundation

The House was also informed about a proposal to set up ABAD Foundation, as it had been discussed in earlier CEC and REC meetings. Mr. Noman Tabani said ABAD currently cannot undertake any profit-making activity, hence the Foundation will provide this platform to take initiatives under corporate social responsibility.

"In future, we plan to build ABAD University of Technology and for that purpose Foundation will be needed to materialize the plan," the outgoing chairman said.

He said the benefits of proposed Foundation will be visible in years to come. "Currently we are black-mailed by allied industries like those from cement, steel sectors... but once we establish foundation, we can set up our own industry," Mr. Bakshi explained.

"The work we are capable to undertake, no other individual or institution can do that," said Mr. Hassan Bakshi.

Mr. Mohsin Sheikhani added that the Foundation will have stake holders and it will have a structure like that of a corporate firm.

Mr. Younus Lakhani, a member of ABAD, stated that he made out from the speeches that Foundation will largely serve the individuals with greater wealth.

While, Mr. Ahmed Mustafa Thanvi said there

should be clarity in modalities of a proposed Foundation before we move forward.

Mr. Asif Sumsum, Convener of the Law & Order Sub-Committee, supported the idea, but said Foundations can't be profit-oriented. "Making a profit and establishing a foundation are different extremes, if we clarify definitions in this regard it will be helpful," he opined.

After gestures of support from most of the members, the concept and idea for setting up a Foundation was unanimously approved.

## Renovation of police station(s)

Another point was taken up during the meeting regarding a proposal for voluntary contribution of members for renovation of couple of police stations.

After a little debate and exchange of views, the proposal for voluntary contribution of Rs 5,000 by members for renovation of police station of Bahadurabad/Ferozabad was approved.

#### Recounting achievements

In his speech, outgoing chairman Mr. Hassan Bakshi underlined achievements during his tenure which included protest rally against Karachi Sewerage and Sewerage Board (KWSB) on Nov 22, 2018 and resumption of NOCs issuance in its wake; extension of ABAD House, partnership between CDC and ABAD; opening of ABAD's regional office in Hyderabad, Representation of ABAD in PM's Task Force on Housing; and initiation of inquiries against cartels in steel, cement sectors on complaint of ABAD.

He, however, said he regretted that: "we were not able to eliminate corruption from this field."

He said the above benchmarks were achieved in just 28 percent of his chairman tenure as a fully-fit person. It is pertinent to mention here that later Mr. Bakshi had an accident and he suffered injuries in its wake, hence there was some recess in his activities due to health reasons.

Senior member ABAD, Mr. Altaf Hussain, also recorded his reservation to Mr Anwar Dawood, saying the latter's attitude with him throughout the tenure was not cordial. He recounted his achievements on the KWSB front, adding that it was regrettable that Senior Vice Chairman just highlighted his works and forgot the hard work done by others.

In his reply, Mr. Hassan Bakshi acknowledged the efforts put in by Mr. Hussain for ABAD. While, the Senior Vice Chairman said we all have worked harder in our capacity but he asked the House to

He called upon the upcoming office-bearers to aggressively pursue campaign against illegal constructions and work to wipe out this menace once and for all.

Mr. Abdul Kareem Adhia thanked the outgoing office-bearers and shared it was a great working experience. He proposed that ABAD has built a state-of-the-art hall for holding events; hence we could rent it out for events to corporate sector.

The proposal was accepted unanimously by the members.

Mr. Ibrahim S. Habib thanked Mr. Shahid Khairi for his guidance and expressed gratitude to all office-bearers.

Addressing the occasion, Patron-in-Chief and new-ly-elected chairman of ABAD Mr. Mohsin Sheikhani said it was an honour for those who served or serving the Association in their respective capacities.

He said a member from Hyderabad Sub-Region will also be given representation in the CEC.

Mr. Sheikhani said ABAD had been largely covered by the media previously, adding that some areas have to be managed efficiently.

He explicitly said if any Convener was not willing or unable to work, he should give up the assigned task.

"We will also have to put in place a few restrictions for yielding intended results."

After discussion of all relevant points and discussion on pertinent matters, the meeting ended following outgoing office-bearers presented bouquets to newly-elected body of ABAD for the term 2019-20.

# The problem of sprawling illegal constructions

Housing is one of the core necessities for people, and once inevitability of a shelter is gravely felt by citizens, especially those belonging to the downtrodden segment – some devious elements enter the game for their own gain.

Once the authorities falter in fulfilling the annual housing requirement of the masses keeping in view growing population, the rule of law gets in a fix and illegal constructions start to spring up in disguise of a safe haven, leaving people in the dark about reality of such buildings being actually death-traps.

The illegitimate builders do not adversely impact the economy by promoting the culture of kickbacks and flouting stipulated rules, but also hurt the legitimate business of builders and developers – especially those affiliated with the Association of Builders and Developers of Pakistan (ABAD) – and create obstructions in lawful construction activities.

It is a bleak reality that 54% of the population of Karachi does not have any shelter, access to clean water and basic facilities of life as guaranteed by Constitution of Islamic Republic of Pakistan

Without following structure and building codes, illegal buildings are a serious life threat for millions of residents.

Tribulations faced by legitimate builders

The legitimate builders are bound to get approvals and NOCs from at least 18 institutions and departments before commencing a project and usually seeking such multiple NOCs frustrate the client, cause delay, surges construction cost, hence affecting the very foundation of an authorized constructions.









On the contrary, elements who build illegal structures and buildings are not entitled to follow the legal route and grease the palms of officers in regulatory authority, which is virtually a one-window for them. Since officers in the building control authority gobble such huge amount in kickbacks to permit illegal constructions, they sheerly neglect the genuine cases of legitimate builders, and on the parallel, illicitly demand money to process bona fide cases.

## Illegal constructions are life-threatening

It is an undeniable fact that life of millions of people is at stake living in self-destructive buildings, which are unauthorized structures.

Besides, the infrastructure of these buildings does not allow any rescue operation in case of any emergency due to inaccessibility of ambulances and fire trucks, etc.

In case of any natural disaster these buildings will collapse like a pack of cards

For illegal constructors, no permit is required from any regulatory authority.

The term NOC does not exist in the norms of illegal construction. While no sign offs and super vision from Architect, Town Planner and Structural Engineers are conducted. It means no liability on anyone, in case of any disaster resulting in human catastrophe.

It is also a fact that authorities concerned do not sign any approval documents and take their share by over-looking the illegal activity.









# Central Executive Committee (CEC) meeting



The first CEC meeting of the tenure 2019-20 discussed in detail modalities for formation of ABAD Foundation, and conversed about SBCA-related issues.

A meeting of the Central Executive Committee (CEC) of the Association of Builders and Developers of Pakistan (ABAD) was held at the ABAD House on Thursday (October 17) at 4pm to discuss issues faced by members related to the Sindh Building Control Authority and other correlated matters.

The meeting was presided over by Chairman ABAD, Mr. Mohsin Sheikhani, and attended by Vice Chairman Mr. Abdul Rehman; Chairman Southern Region, Mr. M. Ali Taufique; former chairmen Mr. Junaid Ashraf Taloo, Mr. Hanif Gohar; former Senior Vice Chairmen Mr. Fayyaz Ilyas, Mr. Anwar Dawood as well as other senior members of the Association.

At the outset of the CEC meeting, the cases of new memberships were presented before the House for approval by Mr. Zeeshan Siddiqui, Convener of New Membership and Renewal Sub-Committee.

Mr. Hanif Gohar raised an objection on couple of applicants with respect to title of their firms. He pointed out that aspiring members should have their company registered under a proper and standard name, instead of informal titles. "ABAD has its own stature and we must not approve membership requests from applicants with bizarre company titles.

Mr. Mohsin Sheikhani admitted the objections raised by the senior member and said the highlighted cases should be kept with the Sub-Committee for review.

Another membership case was pointed out by the Chairman that was deferred in the joint CEC-REC meeting pertaining to an applicant who had allegedly misbehaved with the ABAD Sub-Committee members.

Mr. Zeeshan Siddiqui told the House that our internal probe didn't find any misbehavior on part of the applicant, hence his case could be considered.

The Chairman asked whether the Sub-Committee served any show-cause notice to the person responsible in the case. Vice Chairman Mr. Abdul Rehman also mentioned that he was part of the Committee tasked with probing the matter and the applicant was not found guilty.

Mr. Zeeshan said his Committee will prepare its report and submit to the Chairman.

Another member suggested the House that Sub-Committee for New Memberships must also vet land record of aspiring members before considering their cases.

The Chairman responded asked the Sub-Committee not to push the applicant into hassling situation by asking them to verify land record on their own. "It's our responsibility that a Committee member should

approach relevant authorities and get the land record and other details verified. We must not push away the applicants," he observed.

#### SBCA issues

Discussing another agenda point regarding misinterpretation court order by the SBCA, the Chairman said we are in contact with the relevant government officials and hoping for a favourable names and instead induct new outcome.

It is a fundamental right of citizens to get a housing facility, but not at the cost of evading legalities of the process.

Amid growing need of houses in the country, some unscrupulous elements set up slums (Katchi Abadis) in connivance with government quarters, thus eventually compounding problems for legal builders.

Slums across the world

Around a quarter of the world's urban population lives in slums. And this figure is rising fast. The number of slum dwellers in developing countries increased from 689 million in 1990 to 880 million in 2014, according to the United Nations World Cities Report 2016.

In some cities in the developing world slum residents make up more than half of the population and often do not have adequate shelter, clean water and sanitation, education, or healthcare.

A lack of legal rights to land only makes the daily struggle worse, threatening people's homes and efforts to invest in essential services.

## The situation in Pakistan

According to one estimate, approximately 35 to 40

million people in Pakistan are slum dwellers. This constitutes a small but significant share of the one billion slum dweller across the globe. The influx of migrants from other countries during the 1980s added to the number of katch abadi inhabitants.

Because of it being unauthorized structure, the living conditions in these Katchi Abadis also speak appalling stories of deprivation. Not conforming to even the most basic requirements for a healthy human existence, people residing in slums experience a highly unhygienic habitat and are susceptible to terrible sufferings during extreme weather conditions. Living on the margins of our society, residents of slums are people deprived of sufficient means, often with no resources to maintain their own health as well as that of their children.

The state bears the responsibility to provide shelter to these people and take action to cap slums from springing up.

Article 38-D of the Constitution of Pakistan states, "The state shall provide basic necessities of life, such as food, clothing, housing, education and medical relief for all such citizens, irrespective of sex, caste, creed or race, as are permanently or temporarily unable to earn their livelihood on account of infirmity, sickness or unemployment."



# The problems arising out of slums

According to Martin Ravallion, from World Bank, currently a quarter or 25% of the world's poor dwell in urban areas, and this percentage is going to be 50% by the year 2035.

Rape is another serious issue related to crime in slums. Absence of state's formal recognition results in little to no formal policing and there is no access to public justice institutions for slum dwellers.

Chronic paucity of resources in the household contributes to increasing marital stress, leading to domestic violence. Children seldom get early vaccination, increasing the incidence of polio, pneumonia, whooping and chronic cough and other respiratory diseases, given their proximity to industrial establishments and closeness to where the toxic waste is usually dumped. Thousands die annually due to these unhygienic and diseased dwelling conditions.

Adults and children in slums do not have adequate clothing for harsh climate extremes, frequently exposing them to many illnesses and diseases.

The weather is always quite a challenge, when there

are heavy rains our shack is filled with water, making it difficult to live in, and inhabitants have no other place to move.

Living with a large family it is really difficult to make ends meet. Some of children suffer malnourishment. Malnutrition is often fatal, especially for children. Because they are out through the day for vending, mothers are left with no time take care of children, resulting in malnutrition due to neglect.

### What needs to be done?

To alleviate this, the government and the private sector must come together to address this issue. Given the dreadful trends and numbers, which are progressively despairing, the departments concerned cannot handle the issue on its own, for a number of reasons. In order to bring the private sector on board the administration must propose suitable incentives. Though housing is a major challenge, it can be tackled with a sound and planned response through a strong public-private partnership.

The authorities must take the first step by approaching the private sector with an open mind and the determination to change things in better interest of people and the society.



# The baggage of garbage in Karachi

Worldwide cities are rapidly expanding, creating visible environmental and social challenges. The generation of waste is one of the central concerns in urban agglomerations, particularly in the global South, where inadequacies, absences and weaknesses shape the local waste management system.

# Tackling a 'waste' challenge

Waste constitutes a major challenge to city administrators and urban populations at large. Urban communities have a say in what happens to their waste and who has access to waste. Waste governance decisions need to also be based on governance" principles, including democracy and consensus orientation, participation, accountability, transparency, responsiveness, equity and inclusiveness, be effective and efficient and following the rule of law. These guiding principles should also be applied to waste governance and specifically applied in waste management.

# What's happening in Karachi?

Karachi's waste management problem is nothing new, as around 13,000 tonnes of garbage generated daily in the city by a population of over 13 million residents. About 69-70 % of it makes it to two huge landfills in the city but around 30 percent remains on the streets.

The problems start to compound when ravaging monsoon season that hit the metropolis in July-September 2019, flooded streets, making it more difficult for municipal authorities to sweep roads to the core. While the response by the authorities to dispose of garbage from different places also raised questions on performance of the officials. A federal minister took the lead in the matter, coming up front with an assertion that he could clean up Karachi in two weeks as he called upon residents of the city to help where they could and asked for assistance from the Frontier Works Organisation (FWO).

Like other developing countries, Pakistan lacks waste management infrastructure, creating serious environmental problems. Most municipal waste is either burned, dumped or buried on vacant lots, threatening the health and welfare of the general population.

The Government of Pakistan estimates that 87,000 tons of solid waste is generated per day, mostly from major metropolitan areas. Karachi, generates more than 13,000 tons of municipal waste daily. All major cities face enormous challenges on how to manage urban waste. Bureaucratic hurdles, lack of urban planning, inadequate waste management equipment, and low public awareness contribute to the problem.

# Where does the problem lie?

Much of Pakistan's solid waste does not reach final disposal sites. In developed countries, most solid waste generated winds up in landfills, incinerators, or other recycling centers. In Pakistan, much of the waste generated is recovered for recycling, mostly by scavengers, before it ever reaches disposal points.

As put up on record by the Federal Minister of Maritime Affairs Mr. Ali Zaidi during his visit to ABAD House in September 2019, he shed light on various subjects including the cleanliness campaign in Karachi, hurdles faced by his ministry in garbage dumping as well as political matters impeding execution of works initiated by him.

Mr. Ali Zaidi said garbage collec-

tion and disposal was originally not the responsibility of his ministry, however, he was doing it for the sake of Karachi.

He said there were five garbage transfer stations (GTS) in Karachi which were actually not adequate to cater requirement of the entire city.

It is also a shocking reality that Karachi almost consists of 55% slums and they need to be streamlined as their expansion is causing serious



problems to city's infrastructure.

Karachi faces an assortment of challenges — ranging from garbage problems and lack of proper waste disposal systems to fumigation-resistant bugs, and such problems mainly occur due to political poor cleanliness condition.

The national census of 2017 has put Pakistan's population at 207.8 million. After last census conducted in 1998, the population of the country has grown by 57 per cent now. It is estimated that by 2025 nearly half the country's population will live in urban areas.

### The remedy

The gravity of the situation now demands end to bickering between stakeholders. The authorities must have to work in unison to get the required funds and manpower to remove the garbage first and then create an appropriate waste man-

agement infrastructure for proper and efficient disposal in order to resolve this issue once and for all.

Millions of informal waste pickers collect household waste daily in cities around the globe to earn a living. In doing so they contribute to reducing the carbon footprint of cities, recover resources, improve the environmental conditions and health in the city.

Recovering materials for reuse or recycling is a step towards that direction and helps avoid natural resource extraction. Inclusive recycling addresses poverty and unemployment issues. The work of informal recyclers, as resource reclaimers-for recycling and reuse-and the role they play as environmental educators can be extended to gradually recover more of the materials that are still wasted in landfills or incinerators, progressing towards more resilient and healthy communities; this implies a different, participatory waste governance.

# Inauguration of ABAD's sub-region office in Hyderabad

Expressing his views at the inauguration of ABAD office, the Minister vowed that the government will establish a 'Master Plan Authority' on the pattern of Sindh Building Control Authority to resolve problems and involve all stakeholders, especially builders and developers.

According to Mr. Shah, initially district level master plans would be finalised and then they would be replicated at town and taluka level to help resolve peoples' problems on a priority basis.

He said that he believed Sindh

Building Control Authority should be strengthened to resolve various issues related to construction and builders.

Chairman ABAD Mr. Mohammad Hassan Bakhshi urged the minister to form a governing body of SBCA and induct ABAD in it. "All illegal works are being done and hindrances were being created to legal processes concerning construction," he stated.

Mr. Bakshi said that SBCA officers were minting money for doing favours in illegal matters because they did not have to sign papers in such cases. Establishment of a governing body of SBCA is essential, he said.

The Chairman of ABAD said that cities like Karachi did not have their master plans although every district having 1.5 million population must have its master plan. He demanded



that high-density zones should be identified in Hyderabad and Sukkur as well like Karachi.

He said that powers of SBCA should be delegated to regional offices of Hyderabad, Sukkur and Larkana so that people did not have to travel to Karachi for getting their matters resolved.

Sheikhani stated that illegal projects continued to mushroom everywhere but builders were denied permission for their legal projects.

The Honourable Federal Minister for Maritime Affairs, Mr. Syed Ali Haider Zaidi, visited the ABAD House on September 6 (Friday) at 5.00pm on the occasion of Defence Day.

The Minister was accompanied by Adviser Ministry of Maritime Affairs Mr. Mahmood Maulvi, Members Provincial Assembly of Sindh (MPAs) Mr. Jamal Siddiqui and Mr. Bilal Ghaffar.

ABAD was represented by office-bearers of the time, Chairman Mr. Muhammad Hassan Bakshi, Senior Vice Chairman Mr. Anwar Dawood, Vice Chairman Mr. Abdul Kareem Adhia, Chairman Southern Region Mr. Ibrahim S. Habib and other senior members of the Association.

At the outset of discussion, Mr. Muhammad Hassan Bakshi welcomed the delegation for sparing their valuable time to visit

ABAD House. Mr. Bakshi underlined that 6th September was a memorable day for Pakistan as it reminds the country of gallantry and heroism of its armed forces in battle against our enemy and its nefarious designs.

Talking about the 'Clean Karachi Campaign', the Chairman ABAD appreciated Minister Mr. Zaidi for stepping forward to rid the city of garbage and said we should help the Minister in our capacity to transform his campaign into a success story.

### 'Declare Karachi as the second capital of Pakistan': Mr. Hassan Bakshi

Mr. Bakshi said Sindh contributes 70% to the national economy inclusive of greater contribution from its capital. The chairman requested the Minister to convince his government to declare Karachi as the second capital of Pakistan,

keeping in the view the contributions made by the city on financial and development fronts.

Mr. Bakshi also drew attention of the Minister towards ban on construction of high-rise buildings in Karachi and urged him to raise the issue with Prime Minister of Pakistan, Mr. Imran Khan, for its earliest resolution.

He said ABAD members follow the legal procedure for building their projects and it takes them to acquire at least 18 no objection certificates (NOCs) that consumes around three years for completion of the process.

He also thanked the Minister and all those concerned for getting the Real Estate Regulatory Authority (RERA) proposal deferred from being discussed in the Cabinet meeting.

Senior Vice Chairman ABAD, Mr.



Anwar Dawood, said garbage all over the world was utilized and recycled for revenue generation however, in Pakistan it is disposed of.

He said garbage was not just a waste lying on streets, "those who construct illegal buildings and indulge in corruption are also no less than garbage, hence they should also be get rid of to overhaul the entire system."

Mr. Dawood constructions in Karachi were often erected without proper planning and God forbid, in case an earthquake strikes a city "the loss will be horrendous". He said the prime responsibility for the losses in case of any natural disaster will be on the government.

He stressed the need for formulation of proper planning in the long run to address problems faced by Karachi.

In his remarks, the Minister shed light on various subjects including the cleanliness campaign in Karachi, hurdles faced by his ministry in garbage dumping as well as political matters impeding execution of works initiated by him.

Mr. Ali Zaidi said garbage collection and disposal was originally not the responsibility of his ministry, however, he was doing it for the sake of Karachi.

He said awareness among people was vital to resolve these issues. "A couple of decades earlier, there was a subject called civic studies that used to be taught in schools, and once it's abolished from the curriculum the children and in fact everyone are unaware of their civic responsibilities."

He explained rational behind initiating cleanliness campaign in Karachi by showing a picture of a boy lying dead in a heap of garbage along a coastline. Mr. Zaidi said the deceased boy was a diver who would come with a foreign ship to clean garbage from beneath ships. "However, he lost his life due to our polluted sea and accumulation of garbage there."

The Federal Minister said such situations also prompted him to launch the cleanliness drive.

### 'Shortage of garbage transfer stations in Karachi'

He said there were five garbage transfer stations (GTS) in Karachi which were actually not adequate to cater requirement of the entire city. He said Sindh government had a list of GTS which mentions number of GTS in city at 11; however six of them don't even exist.

He highlighted that Frontier Works Organisation (FWO) was roped in for Karachi cleanliness drive and it lifted garbage at a cost of Rs 1.65 per kg from collection to disposal of trash to landfill sites. The Minister said it was astonishing to discover that Sindh government contractors were charging Rs 4 per kg for the same work.

### 'Slums create more problems'

The Minister said the city consists of 55% slums and they need to be streamlined as their expansion was causing serious problems to city's infrastructure.

He said as a result of works done through his campaign, none of the drains (Nullahs) were choked during rains and rainwater flowed smoothly without accumulating on streets.

To a question by a journalist regarding status of Rs 162 billion funds for Karachi, Mr. Zaidi said he would urge the Prime Minister to not release single penny to Karachi until a proper monitoring mechanism was established in order to prevent funds from being siphoned off.

He informed that Rs 100 million have been collected so far with donations from different organizations for 'Clean Karachi' Campaign.

The Minister said it would be totally up to ABAD if it donates any amount for the cleanliness work. The Chairman said the Association will assist in the cause.

At the end, Mr. Ibrahim Habib gave a vote of thanks to the Minister and his delegation for visiting ABAD House.

# The visiting dignitary discussed investment opportunities for Canadian investors in Pakistan's housing and construction sector.

A Senior Trade Commissioner in High Commission of Canada, Islamabad, Ms. Mafgaux McDonald, visited ABAD House on October 8, 2019 (Tuesday) and held a meeting with office bearers of Association of Builders and Developers of Pakistan (ABAD) to discuss emerging investment opportunities in Pakistan's housing and construction sector and bilateral trade ties between the two countries.

ABAD was represented during the meeting by its Senior Vice Chairman Mr. Sohail Warrind, Vice Chairman Mr. Abdul Rehman, Chairman Southern Region (SR) Mr m. Ali Taufique, former chairman ABAD Mr. Hassan Bakshi, senior member ABAD, Syed Shahid Khairi and other office-bearers.

The Canadian Trade Commissioner was accompanied by Trade Commissioner of Canadian Commercial Office.

The meeting began with introduction of ABAD and its members by Vice Chairman Mr. Abdul Rehman.

He apprised the visiting dignitary about investment opportunities in Pakistan with a background of impediments existed until recently for foreign investors. "The milieu for investment has now changed and Pakistan is open for potential

Ms. Mafgaux McDonald said it would be helpful if she could get a



investors to grow their businesses," Mr. Rehman told the Canadian Trade Commissioner.

The Vice Chairman said he has been involved in construction activities in Canada for years, and there was complete support from allied industries. He underlined that Pakiproposal from ABAD, shedding light on investment prospects in the country.

The Vice Chairman of ABAD said we were waiting for tax-friendly regime before inviting foreign investors, and now things are feasible for foreign firms.



Ms. McDonald observed that we need to diversify our trade partners, adding that Canada faced some challenges in trade ties with the United States, of late. "A lot of firms are also reaching out to Canadian companies for investment in their respective countries."

Mr. Abdul Rehman said construction and material cost is jacking up in Pakistan. He proposed that Canadian Mortgage Companies can also offer their expertise to Pakistan and its untapped market.

The Trade Commissioner responded that Canadian banks had strict regulatory mechanism and they hardly go overseas. "That is one reason we [Canada] were not affected by recession that struck the US in 2008."

She stated that Canada is looking to explore investment opportunities in Pakistan. "The market in Pakistan is high-risk, yet high-rewarding," she remarked.

Bakshi said Pakistan is ready to facilitate the foreign investors.

He said Pakistan is facing shortage of 12 million houses, while the demand of 0.3 million housing units is increasing every year. He stated that 58 percent of Karachiites live in slums (katchi Abadis), which reflects the grave dearth of houses in the metropolis.

The former chairman highlighted three areas there were holding the construction sector until recently that included Foreclosure laws, Federal Board of Revenue-related issues and local regulatory regime.

Mr. Bakshi said acquiring about 18 NOCs from different institutions for a project was hassling for builders, adding the things were changing now.

He informed the Canadian diplomat that change was in the bag and would be visible in a few months in Pakistan. He said sizable government land was also available in the country. Mr. Hassan Bakshi also shared an example of China where use of advanced technology has reshaped the construction sector. He, however, added that investors from Pakistan couldn't rely on a single country; hence diversification in trade was the need of the hour.

Mr. Abdul Rehman said technology is evolving rapidly, saying some companies in China are proud to build '50 floors in 50 weeks' and using this phrase as their slogan.

Ms. McDonald remarked that there were firms introducing tech innovations, but "cheapest is not always the best.

She proposed ABAD to also visit Big-5 exhibition in Dubai that is held every year for exploring global construction sector. "We can help ABAD connect with Canadian investors through the Big-5 platform," she suggested.

She also recommended arranging a webinar or video conferencing-like communication with ABAD to connect builders' guild with Canadian investors to build liaison among them.

After a detailed discussion on trade ties and investment opportunities, the meeting ended with a note of thanks from office-bearers of ABAD.

Later, the Senior Trade Commissioner Ms. Mafgaux McDonald was presented bouquet and memento of ABAD.

A delegation of the Association of Builders and Developers of Pakistan (ABAD) led by Mr. Muhammad Hassan Bakshi - the then Chairman - met Secretary Environment, Climate Change and Coastal Development Sindh, Mr. Khan Muhammad Maher, at his office on August 8, 2019 at 12.30pm to discuss issues pertaining to non-issuance of NOCs and lacunas in environment-related laws that hampers execution of different projects.

The ABAD delegation comprised Mr. Hassan Bakshi, Convener Environment Protection ABAD, Mr Farigh Nadeem and another member of the Association. The meeting was chaired by Secretary Environment.

Mr. Hassan Bakshi informed the Secretary that around 50 no-objection certificates (NOCs) of different projects were pending for two and a half years despite fulfillment of all requirements of the projects.

Mr. Bakshi said NOCs should be issued forthwith keeping in view the fact that all projects are complying with stipulated legal requirements. He said the environment laws were

enacted some ten years ago and their review and upgradation has now become the need of the hour.

Mr. Hassan Bakshi proposed to the Secretary Environment that projects above 15 lac square feet should be sent for public hearing, while those below the above value must be decided internally by the competent authority.

Mr. Farigh Nadeem said builders have to pay Rs 4.5 million to Rs 5 million to authorities for Environmental Impact Assessment (EIA), while fee prescribed under the law is Rs 100,000 for the same work.

Responding to the points raised by ABAD members, Secretary Environment Mr. Khan Muhammad Maher sought a detailed proposal from ABAD with their intended amendments in the law, adding that the proposal would subsequently be sent to provincial government for consideration and approval.

The Secretary assured that he would convince the Minister and other relevant government high-ups to approve proposed changes as per law.

Mr. Maher also suggested the ABAD delegation to invest in public projects along coastal areas like Keenjhar Lake, Haleji Lake, saying such areas have huge potential for investment.

Mr. Bakshi urged the Secretary to identify a piece of land of around 1,000 acres so ABAD members could invest on it.

The Secretary assured ABAD members of taking measures to begin one-window operation for ease of doing business.

# Renovation of public park(s)

It was also decided during the discussion that a meeting would soon be arranged with Sindh Chief Secretary with an agenda to discuss issue of pending NOCs of ABAD as well as refurbishment of public parks with the help of ABAD.

At the end of the meeting, the Chairman ABAD thanked the Secretary Environment for sparing time for the meeting and assuring resolution of problems at the earliest.

The DIG begun the discussion by shedding light on renovation of Ferozabad Police Station being carried out by ABAD. He said the police department has planned to transform police stations of three zones into model police stations.

He informed that police stations of Ferozabad and Bahadurabad have been merged to form a single one. Similarly those of Liaqatabad and Super Market; and Clifton and Boat Basin's stations have also been amalgamated, respectively. He added that strength of the said police stations has also been increased simultaneously.

The DIG said bottleneck in government works often occur, hence we decided to seek help of ABAD for

speedy renovation of [specified] police stations.

Mr. Asif Sumsum said he has visited Ferozabad Police Station for more than couple of times recently and inspected renovation work.

Mr. Raheel Rinch suggested that a joint visit with a team of officers can also be paid to analyze and decide things.

Later, Mr. Asif Sumsum suggested Ms Umme Mansoor to visit the renovation site with respective officials, examine work and propose design of the building so that the construction could be done with incorporating input of the police department.



# The members of ABAD sought SBCA action against thriving illegal constructions, and measures to resolve problems of Hyderabad builders

A delegation of the Association of Builders and Developers of Pakistan (ABAD) met the Director General of Sindh Building Control Authority (SBCA), Mr. Zafar Ahsan, at his office on August 6, 2019 at 3.00pm to converse over various issues faced by builders of Hyderabad and Karachi related to SBCA bye-laws and pending approvals of projects.

The then Chairman ABAD Mr. Muhammad Hassan Bakshi; Senior Vice Chairman ABAD, Mr. Anwar Dawood; Vice Chairman ABAD, Abdul Kareem Adhia; Chairman Southern Region ABAD, Mr. Ibrahim S. Habib; Mr. Rizwan Adhia, Hyderabad region representative, Mr. Farooq Sheikhani and other prominent members of the Association attended the meeting.

The Director General of the SBCA presided over the meeting.

The delegation apprised the DG SBCA of issues faced by members of Hyderabad regarding a few bye-laws as well as floor area ratio (FARs) that are hindering execution of projects.

Mr. Zafar Ahsan, the head of the SBCA, said rules can be amended to

streamline affairs. One of the SBCA members told the meeting that a Senior Director of Masterplan, who is part of a committee formed by the building control authority, has the powers to amend regional bye-laws and the case(s) could be forwarded to the said committee for review.

Zulfiqar Farooqui from Hyderabad suggested SBCA to empower director town planning to resolve cases pending for a long time.

He also requested the SBCA to probe whether the water commission was lawfully mandated to impose a ban on conversion of plots. "The suspension of construction work on the commission's order is delaying projects and inflicting financial loses," he told the SBCA DG.

The SBCA head responded that a committee was operating under Chief Secretary Sindh that examines cases, dealt by the Water Commission, every month.

The ABAD members said a meeting could be arranged with Sindh Chief Secretary to hash out the matter.

Mr. Anwar Dawood raised the issue of pending completion plans of

already approved projects as per law. He said the ultimate affectees of the problem created through SBCA order were allotees, adding that the matter should be considered and addressed at the earliest.

The ABAD delegation also pointed out several areas where illegal constructions were rampant. Mr. Bakshi asked the SBCA head whether he was supporting the Association of Builders and Developers in their fight against illegitimate constructions. Mr. Zafar Ahsan replied in affirmative and said his organization was also against any wrongdoing and will go all-out against it.

The ABAD members stated that some elements are indulged in illegal constructions and their unlawful activities is bringing disrepute to legitimate builders. The DG SBCA agreed upon the fact and assured to take necessary steps to address the issue.

The meeting ended after the SBCA team assured to look into problems raised by the ABAD delegation and resolve them before long.

The meeting discussed various matters including ABAD's proposal to get representation in HDA governing body as well as identification of high density zones in Hyderabad

The Director General of Hyderabad Development Authority (HDA), Mr. Ghulam Muhammad Qaimkhani, visited the sub-region office of Association of Builders and Developers of Pakistan (ABAD) in Hyderabad on September 4 (Wednesday) to hold meeting regarding different issues faced by the members.

The meeting was chaired by Mr. Raheel Iqbal, Vice Chairman Hyderabad Sub-Region of ABAD.

The members of sub-region Hyderabad welcomed the DG HDA to the newly-inaugurated regional office of ABAD.

At initiation of the meeting, the Vice Chairman, in pursuance of agenda, mooted the demands and suggestions enlisted by ABAD.

He requested the DG that ABAD should be given representation in the Governing Body of Hyderabad

Development Authority. To which the DG replied that HDA will consider this proposal.

The Vice Chairman also sought formation of Master Plan for Hyderabad.

The members of ABAD called for conversion policy for residential plots and discussed strategy to deal with stay given by the Water Commission. The DG said the Authority had submitted its reply in the court regarding the matter, adding the response filed by HDA contained no negative observation.

The Vice Chairman of Hyderabad Sub-Region also clamoured for provision of basic infrastructure in Kohesar Extension, Gulistan -e-Sarmast and other HDA schemes.

The ABAD also demanded identification of High Density Zones in Hyderabad and completion of development works at Bypass area by HDA including pending schemes of Hyderabad Development Authority.

The DG HDA said Master Plan Authority of Sindh was in the phase of formation and he nodded to have representation of three members from Hyderabad sub-region in the proposed Authority.

The Director General also informed that a water supply project at a cost of Rs 520 million was being initiated that will address water issues in the Bypass area. He added that another water supply project was being launched in Gulistan -e-Sarmast.

The head of HDA assured the ABAD members that all their problems will be addressed on priority basis.

The meeting later ended with a note of thanks from the Chair.

# KWSB Sub-Committee



The issuance of no objection certificates (NOCs) to legitimate projects by the regulatory authorities has been a cumbersome process for a long period in the provincial capital of Sindh, and inordinate delay in this regard takes a toll on builders as well as general public who wait for completion of projects in time.

The Karachi Water & Sewerage Board (KWSB) Sub-Committee of ABAD strives to get such cases of its members resolved by remaining in contact with the KWSB head and other relevant officials.

A meeting of the KWSB Sub-Committee of ABAD was held on November 20 with Senior Vice Chairman ABAD, Mr. Sohail Warrind, in the chair.

The meeting was also attended by Vice Chairman Mr. Abdul Rehman, Chairman Southern Region, Mr. Ali Ratadia; Convener KWSB Sub-Committee and senior member ABAD, Mr. Altaf Hussain, Mr. Nusrat Chughtai, Mr. Younus Lakhani and other members of the Association.

Mr. Altaf Hussain said there 256 cases, of them NOCs have been issued in 203 cases, while 53 are pending.

He informed the House that 30 cases were new and 18 of them pertained to seeking new connection of above 18-inch diameter water line, which was not being issued by the KWSB to anyone.

Mr. Hussain said he has been meeting with Chief Engineer and other relevant officials of the KWSB to discuss and resolve cases of ABAD.

Vice Chairman, Mr. Abdul Rehman, said the KWSB must give new water connections to projects which have fulfilled all formalities. Chairman SR, Mr. Ali Ratadia, suggested a group of affected builders must hold a meeting with KWSB high-ups to inform them about their cases for its earliest resolution.

Mr. Nusrat Mirza Chughtai said a time for meeting has been sought from Managing Water KWSB on Monday (November 25) to brief him about these matters.

Mr. Sohail Warrind said all persons concerned whose cases were pending should be roped in for the upcoming meeting with KWSB MD.

Mr. Younus Lakhani said his case was also pending with the KWSB, despite payment it's not yet resolved. He said challan has also been issued to him, but no further progress was made by the KWSB from its end.

# SBCA Sub-Committee



A meeting of the SBCA Sub-Committee of Association of Builders and Developers of Pakistan (ABAD) was held on November 16, Saturday, with Chairman Mr. Mohsin Sheikhani in the chair to discuss issues related to the Sindh Building Control Authority braved by members of the Association.

The meeting was also attended by Vice Chairman, Mr. Abdul Rehman; Chairman Southern Region Mr. M. Ali Taufeeq; former Chairman Mr. M. Hassan Bakshi, former Senior Vice Chairman Mr. M. Anwar Dawood and other members of ABAD.

Initiating the discussion, the Chairman asked Mr. Dawood to brief the House about the complaints builders and developers have communicated to him.

Mr. Anwar Dawood said an

amendment has been proposed by ABAD in Regional Interim Building and Town Planning Regulations in the 'chapter of amalgamation'.

He said the existing law is causing hurdles in construction of building, hence amendments were needed in chapter 18 and 22 of the regulation was needed.

Similarly, he pointed out flaws in Chapter 25 of Karachi Building & Town Planning Regulation. He said the particular chapter was also causing hurdles to the members of ABAD and they have been complaining about foot-prints for a long time, adding that the foot-prints for large-sized plots should be minimized to meet the genuine requirement of builders.

Mr. Dawood stated that land in Karachi was now expensive, therefore we could also discuss with SBCA regarding raising floor permission for 120 square yards plot from ground+2 to ground+3 floors. "We need this relaxation keeping in view expansion of the city and growing cost of land."

Mr. Anwar Dawood highlighted another issue pertaining to KDA, as the latter seek sub-lease charges in advance.

The Chairman said this should not be done, and asked Mr. Dawood to prepare a report so it could be raised with the Minister during a prospective meeting with him.

The members also raised issues related to issuance in sale NOCs, and conditions for NOCs. The Chairman asked them to jot down the issues faced by them so they could be pursued in upcoming meeting with SBCA team.

# Law & Order Sub-Committee



A meeting of the Law & Order Sub-Committee of ABAD, presided over by Convener of the Sub-Committee Mr. Asif Sumsum, was held on November 20 (Wednesday) at ABAD House to discuss complaints submitted by members and measures taken by the Association in its wake.

The meeting was attended by Senior Vice Chairman, Mr. Sohail Warrind; Vice Chairman Mr. Abdul Rehman, Chairman Southern Region Mr. Ali Ratadia, Mr. S. Shahid Khairi and other members of ABAD.

At the outset of the meeting, Mr. Sumsum sought files of complaints submitted by members to discuss their progress.

Complainants put forward their issues which were resolved and also those whose resolution is awaited.

A case was brought up by Ruknuddin Private Limited before the House and the complainant, Mr. Chaudhry Arshad, said his case has been settled. Mr. Asif Sumsum asked the complainant to submit a letter addressing to Chairman ABAD with a confirmation of his case status as resolved. He said we are in the process of wrapping up pending cases and all complainants whose cases have been resolved/settled should write a letter to ABAD Chairman, assuring in writing that their case has been settled. "It will help us prepare a log of resolved cases," said Mr. Sumsum.

Former Vice Chairman ABAD, Mr. Abdul Kareem Adhia, also raised

his complaint regarding a dacoity on his site. He said the DIG West was well-informed about the case, however, neither geo-fencing of the area was conducted nor any progress was made.

Mr. Sumsum asked Mr. Adhia to once again contact the SP Investigation, today and tomorrow. "And if nothing happens for two days, I will accompany with you personally to the police high-up concerned to discuss the matter."

Another file of the case of member

Mr. Mumtaz Ghazi was brought to discuss, however, the complainant said his case had virtually been settled and it was in the court now.

Mr. Asif Sumsum asked Mr. Ghazi to send a letter to ABAD, addressed to its Chairman, confirming that the case has been settled.

Besides, another complainant affiliated with Central Builders and Developers raised his issue about encroachment on his plot in block-1 of Clifton, in front of Ziauddin Hospital.

Mr. Asif Sumsum responded that this case is near resolution, saying an anti-encroachment operation will be launched on the said plot to vacate it from encroachers.

Later at the end of the meeting, the Convener of the Sub-Committee also asked an officer of ABAD, Mr. Muzammil Sheikh, to prepare a note-sheet of complainant who didn't turn up in the meeting for future reference.

# CONSTRUCTION INNOVATION



The way constructions are done across the globe is rapidly evolving and technology is playing a crucial part in reshaping the conventional methods of raising a building.

With changing times, new construction models are being introduced in different countries mostly the developed ones, where use of machines and advanced tech has a crucial role.

Over the past ten years the development of intelligent construction models, closely tied to energy efficiency, has introduced new materials that have one or more properties modified, in a controlled and partial way.

Introducing his own innovation, Dr. José Carlos Rubio Ávalos, a materi-

als scientist at the Universidad Michoacana de San Nicolas de Hidalgo, Mexico, has developed a cement with the capacity to absorb and irradiate light energy, in order to provide greater functionality and versatility to concrete in regards to energy efficiency.

The cement can be used to illuminate highways, bike paths, and buildings without the use of electricity.

The new smart material developed by Rubio Ávalos was released a few years ago, in an official press statement released by the Agencia Informativa Conacyt.


Rubio Avalos added photoactive materials to the cement to absorb and emit light, but the greatest challenge was to make the cement, an opaque material, soak up UV rays. To do this, he had to alter its microstructure.

In the beginning of the concrete-making process, cement powder is mixed with water and the material starts to gel. The gel makes it form crystals.

"They look a little like cornflakes," he says, and are an unnecessary byproduct.

In Rubio Avalos' concrete, these crystals have been removed, which allows the sunlight to enter the cement matrix without being reflected. The result: a material which absorbs UV rays during the day and releases light at night.

"Some say it is a completely new



is estimated to be greater than 100 years, according to its creator.

Charging the material using natural or artificial light, it hopes to offer new light and thermal functions to the most used construction element in the world in order to reduce the energy consumption generated by current light and thermal systems.

material," says Rubio Avalos.

At the time of its creation of illuminating cement, only marine blue and bright green were the colors available, but Rubio Avalos said he was working on cement that can glow white, red and purple. But he sought more funding for the purpose.

The researcher says that the technology works even on cloudy days. It can work indoors, as long as the UV rays come in through the windows.

The researcher claimed that the applications are very broad, and those which stand out most are for the architectural market: facades, swimming pools, bathrooms, kitchens, parking lots, etc. It would also be useful in road safety and road signs, in the energy sector, such as oil platforms, and anywhere you want to illuminate or mark spaces that don't have access to electricity since it doesn't require an electrical distribution system and recharged only with light. # Aerated Concrete Blocks: A revolutionary construction material

Autoclaved aerated concrete (AAC) is a type of precast concrete that is now virtually revolutanizing the way constructions are undertaken.


AAC are composed of natural raw materials. It was first developed in Sweden in the 1920s, when an architect first combined the conventional concrete mixture of cement, lime, water, and sand with a small amount of aluminum powder.

The aluminum powder serves as an expansion agent that causes the concrete to rise, somewhat like bread dough. The result is a concrete that consists of almost 80 percent air. AAC concrete typically is made into blocks or slabs and is used to build mortared walls in a manner similar to that used for standard concrete block construction.

# How Aerated Concrete is manufactured

Autoclaved aerated concrete begins with the same process used to mix all concrete: Portland cement, aggregate, and water are mixed together to form a slurry. Upon the introduction of aluminum as en expansion agent, air bubbles are introduced throughout the material, generating a low-density lightweight material. The wet concrete is molded into shapes using forms, then cut into slabs and blocks once partially dried. The units are then moved to an autoclave for full curing under heat and pressure, which takes only 8 to 12 hours.

AAC concrete units are highly workable and can be cut and drilled with conventional woodworking tools, such as band saws and ordinary power drills. Because



it is lightweight and relatively low-density, the concrete must be tested for compressive strengths, moisture content, bulk density, and shrinkage.

### **Building with Aerated Concrete Block**

AAC concrete can be used on walls, floor, roof panels, blocks, and lintels.

- Panels are available in thicknesses of between 8 inches to 12 inches and 24 inches in width, and lengths up to 20 feet.
- Blocks come in lengths of 24, 32, and 48 inches, and thicknesses of 4 to 16 inches; height is 8 inches.

Cured blocks or panels of autoclaved aerated concrete are joined with thin bed mortar, using techniques identical to those used with standard concrete blocks. For additional strength, walls may be reinforced with steel or other structural members run vertically through spaces in the blocks.





AAC concrete can be used for walls, floors, and roofs, and its light weight makes it more versatile than standard concrete. The material offers excellent sound and thermal insulation, and is strong and fire resistant.

However, in order to be durable, AAC must be covered with an applied finish, such as polymer-modified stucco, natural or engineered stone, or siding. If used for basements, the outer face of AAC walls must be coated with a thick layer of waterproof material or membrane. AAC surfaces exposed to weather or soil moisture will break down.

Interior surfaces can be finished with drywall, plaster, tile, or paint, or can be left exposed. Features' of Aerated Concrete

Inherently, AAC offers only moderate insulation values—about R-10 for an 8-inch-thick wall and R-12.5 for a 10-inch-thick wall. AAC offers an R value of about 1.25 for each inch of material thickness. But AAC has a high thermal mass, which slows the transfer of thermal energy and can greatly reduce heating and cooling costs. And AAC structures can be



made very airtight to reduce energy losses due to air leaks. AAC also creates an excellent soundproofing barrier.

### **Benefits of Aerated Concrete Block**

Some of the benefits of using autoclaved aerated concrete include:

- An excellent material for soundproofing material and acoustic insulation
- Highly fire- and termite-resistant
- Available in a variety of forms and sizes
- High thermal mass stores and releases energy over time
- Recyclable material
- Easy handling and installation due to light weight
- Easy to cut for chases and holes for electrical and plumbing lines
- Economical shipping and handling when compared to poured concrete or concrete block

### Are there any drawbacks?

Like all building materials, AAC has some disadvantages:

- Products often show inconsistency in quality and color.
- Unfinished exterior walls require exterior cladding to protect them from weather.
- If installed in high humidity environments, interior finishes require low vapor permeability and exterior finishes require high permeability.
- R-values are relatively low when compared to ener gy-efficient insulated wall construction.
- Cost is higher than a conventional concrete block and wood-frame construction.
- Strength of AAC is 1/6 to 1/3 that of traditional concrete block.







## Govt to sell unused state properties at Dubai Expo

ISLAMABAD: The federal government has decided to sell its precious unutilised state properties at the Dubai Expo to attract foreign and Dubar Expo to attract foreign and Pakistani investors to the country and the funds generated through the exer-cise will be spent on public welfare schemes related to education, health, food and housing.

It was decided at a meeting on aban-doned state properties held at the Prime Minister Office on Wednesday. The meeting was presided over by Prime Minister Imran Khan.

"These unutilised state properties will be marketed at the Dubai Expo to attract foreign and Pakistani investors to buy these assets," Privatisation Secretary Rizwan Malik informed the

prime minister during the meeting.

The prime minister directed the authorities concerned to sell all pretious abandoned properties of the state and to spend the money to be

fetched from their sale on welfare of

The prime minister said that despite having properties worth billions of rupees, state institutions were bearing

losses of billions of rupees every year.

"Utilisation of properties worth billions of rupees will help generate funds which will be spent by the government on public welfare schemes such as schools, colleges, hospitals. It is an important component of the govern-ment's policy," the prime minister said.

"Unfortunately, criminal negligence was done by the previous governments as they did not utilising these valuable properties. Despite billions of rupees' assets, various federal government institutions are bearing losses of billions of rupees every year," he added.

The prime minister warned that strict action would be taken against government officials who did not identify unused properties or tried to hin-

der the government move Mr Khan directed the Asset Management Committee and federal ministries as well as provincial governments to resolve all issues related to identified properties next week and implement the government decision immediately.
