



A BRIEF VIEW OF



The Association of Builders & Developers of Pakistan (ABAD) is a national level representative organization of builders and developers, formed in the year 1972 with the aim and objective of unifying and streamlining the construction activities of private sector.

ABAD is registered under the Companies Ordinance, 1984 with Registration No. KAR No. 4967 of 1977-78 and licensed under Trade Organizations Ordinance, 2007 and its affiliated with the Federation of Pakistan Chamber of commerce and Industry (FPCCI).

Today, ABAD has in its fold more than 1,400 leading construction companies of the country. Most of its members' offices are equipped with up-to-date systems of designing, cost control, project management and latest civil engineering techniques to minimize the cost of construction. The association operates on democratic lines with election of One Chairman, Senior Vice Chairman, Vice Chairman and Managing Committees and One Chairman from each of its two regions i.e., Southern Region and Northern Region for a full term of year. The Chairman & Sr. Vice Chairman is elected among Full / Ordinary members and the Vice Chairman from Associate Members and One Chairman each from its two respective.

The Elected Office Bearers for the term 2022-23 are Mr. Altaf Tai, Chairman; Mr. Khawer Munir, Senior Vice Chairman; Mr. Nadeem Yousuf Jeewa, Vice Chairman; Mr. Raheel Rinch, Chairman Southern Region; Mr. Sultan Gohar, Chairman Northern Region (Lahore) and Engr. Faraz Hussain Memon, Vice Chairman Hyderabad Sub-Region.

As a representative organization of the country's builders and developers, ABAD has made a valuable contribution in the formulation of National Housing Policy and Sindh building Control Ordinance. It has also played a leading role in securing and increase in the House building Finance Corporation component of housing loans as well as the allocation to HBFC in Federal Budget.

The principal aims and objectives of ABAD include

Unifying builders and developers for their collective good. Promoting housing industry in the country. Providing assistance to the Government in formulating its housing policies and plans. Co-coordinating between ABAD members, the Government and other agencies. Dealing with problems faced by its members in the execution of their projects. Organized research. Working actively for eradication of unethical business practices from the housing and development field. Exploring the prospects of large-scale projects in the public sector and then acting as a consortium of ABAD members to secure and execute the projects.

In the provincial capital of Sindh, ABAD has played a pivotal role in procurement of land for its members and also for the issuance of no objection to them by Karachi Development Authority.

Other major achievements of ABAD include increasing the covered area of flats, fixation of the selling price of housing units, inclusion of a provision of escalation, simplification of the procedure for the permission to mortgage and registration of leases, increase in the period of completion and streamlining of documentation procedures regularly.

Although there is a pressing requirement for houses in the city yet on account of nonavailability of infrastructure and other amenities, some schemes cannot be developed due to scarcity, efforts to remove these bottlenecks are continuing on all possible levels.

As a socially responsible organization in addition to the above core functions ABAD also extends donations and other kinds of support to deserving institutions and welfare organizations. A safe shelter to live in is recognized the world over as a fundamental human right and that is the vision behind ABAD's efforts and ventures.



We emphasized to the Chief Secretary the importance of including Hyderabad representatives in pivotal organizations like SECP, HDA, and SDA.

Highlighting the need for capable and ethical officials in roles like Regional Director and Additional Director at HDA, we aimed to curtail unauthorized construction and bolster city progress. Our discussion also covered ongoing development projects across various areas of the city.

Responding swiftly, the Chief Secretary directed his Designated Secretary (DS) to address the matters promptly. Instructions were given to correspond with higher authorities at SECP, HDA, and SDA.

Additionally, the DS was tasked with drafting a letter to the Deputy Commissioner of Hyderabad to expedite resolution of builder concerns.

Our dedication to the region remains steadfast, and I anticipate that incoming office-bearers will carry on this commitment with equal fervor.



Headway in land encroachment complaints

Cantonment bye-laws upgradation

They meticulously drafted amendments, facilitated internal discussions, and presented these proposed changes to the cantonment authorities for subsequent approvals.

As a result of these amendments, significant modifications have been made, including an increase in building ratios, among other substantial changes.

Following the implementation of these amendments, the cantonment boards have already issued updated bye-laws, with the exception of Clifton Cantonment, which is anticipated to complete the process in the near future.

Liaision with Sindh high-ups for resolution of issues



The office bearers of ABAD also engaged in talks with the caretakers ministers in Sindh, specifically the Home Minister *Brig retired Haris Nawaz*, and Local Government Minister *Muhammad Muheen Jumani*.

ABAD delegations in both meetings emphasized their desire to foster the growth of the construction sector in Karachi and the province, all while adhering to the legal framework.

"We are poised to present our recommendations within the upcoming 2 to 3 days, with optimism that these suggestions will gradually pave the way for the relaxation of these restrictions," the chairman added.



Meetings with Consul Generals of China and Turkey



In August, ABAD delegations, led by its officebearers, engaged in meetings with the Consul General of China at his office, while the Consul General of Turkey paid a visit to ABAD House.

The core purpose of both meetings was to strengthen diplomatic relations with these two countries, with a special focus on fostering cooperation in the construction sector and harnessing the untapped potential present in Pakistan for foreign investors. During the meeting with the Chinese Consul General, Mr. Altaf Tai led the visiting delegation in discussing various topics, including the participation of private builders and allied industries in CPEC projects, streamlining the visa application process, and expediting the development of Gwadar.

The Chinese dignitary responded positively, expressing a keen interest in addressing these matters. Similarly, during the meeting with the Turkish Consul General, the ABAD delegation aimed to identify collaboration opportunities within Pakistan's private sector, with a specific emphasis on construction projects.



DHA Multan visit



At the invitation extended on several occasions, a delegation from ABAD comprising office bearers and a group of members visited DHA Multan on September 6th to conduct a site tour and assess potential investment opportunities.

During the visit, ABAD members were provided with a comprehensive tour of the DHA Multan project. They examined various aspects of this expansive endeavor, seeking valuable insights into potential investment prospects. Following the tour, both parties mutually agreed to sustain their collaborative efforts in exploring these opportunities further.

Shielding members from harassment



Furthermore, certain members of the association received notices from the Anti-Corruption Establishment (ACE) without any clear justification, creating a sense of uncertainty among other members and impacting project work.

ABAD took immediate action by raising the issue with the ACE department. Subsequently, both parties agreed to establish effective communication channels to address such grievances.

ABAD appointed its former Chairman of the Southern Region, Mr. Ibrahim Habib, as the focal person to pursue the matter, while the ACE named a senior official to lead the discussions.

This collaborative effort resulted in improved communication and prompt information sharing, leading to the resolution of the complaints.

CSR initiatives to help those in need

ABAD has actively engaged in social welfare and Corporate Social Responsibility (CSR) initiatives throughout the country, demonstrating its commitment to giving back to society. This dedication was evident during various occasions, including Ramazan.



As part of their CSR efforts, ABAD hosted Iftar and Sehri events for the public at the ABAD House throughout the holy month. This gesture aimed to provide food to those affected by extreme inflation during Ramazan, enabling them to fulfill their religious obligations.



In addition, ABAD demonstrated its commitment to corporate social responsibility by donating 10 wheelchairs to the Sindh Persons with Disabilities Protection Authority (SPDPA) during a meeting with the Secretary in June.



The Association also pledged its support to the Indus Hospital, particularly in the construction of its new building, to facilitate people in need. This commitment was solidified during a visit to ABAD House by Dr. Abdul Bari Khan, the Founding President of Indus Hospital and Health Network, in May.

Endeavours for Gwadar



ABAD embarked on the Special Economic Zone (SED) project in the fiscal year 2019-2020, aiming to secure approval from the Provincial and Federal Government. In a significant development, ABAD wrote a letter to the Prime Minister in January 2023, urging the declaration of Gwadar as a Special Economic Zone. The Prime Minister took notice of the matter, leading to its discussion in a meeting of the National Development Council (NDC) in Islamabad.

Subsequently, a high-level meeting was held in May 2023, where ABAD had representation, and it was unanimously agreed that there were no objections from the Province and relevant stakeholders to declare Gwadar as a Special Economic Zone. Later on May 30th, 2023, the Chief Minister of Balochistan officially declared Gwadar as a Special Economic Zone.

Voice against cartelization



ABAD on March 1, 2023 held a press conference at the ABAD House to shed light on the monopolistic practices of iron, steel, and cement cartels, resulting in escalated prices of these crucial construction materials. The members emphasized the need for ongoing efforts to dismantle these monopolies and establish fair pricing for raw materials within the construction industry.

They cautioned that the government must take proactive measures to address this issue; otherwise, builders may be compelled to divert their investments to other countries, posing a significant risk to Pakistan's economy. In a positive turn of events, a few days later, the prices of steel witnessed a reduction, indicating the fruitful outcomes of the endeavors undertaken by ABAD members on behalf of the construction fraternity.
